Minnesota Ag & Food Summit Health & Safety Notice:

Your health and safety are important to us, and we have gone through extensive discussions and review for this year's Summit.

The Minneapolis Convention Center (MCC) is owned by the City of Minneapolis and is following CDC guidelines. As such, they currently require face masks inside the public spaces of the building and are recommending use for indoor spaces not open to the public (i.e., inside the Ballroom). Masks and hand sanitizer will be available at the event. Additionally, while there is no social distancing requirement in place, AgriGrowth is planning to space out the tables and exhibits as much as possible to allow for social distancing where able.

COVID Safety Form

COVID-19 has been declared a worldwide pandemic by the World Health Organization and an inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is a contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention (“CDC”), senior citizens and individuals with underlying medical conditions are especially vulnerable. Due to the nature of COVID-19, it is not possible for our organization to prevent against the presence of the disease. Therefore, by choosing to participate in a Minnesota AgriGrowth Council (AgriGrowth) event, I may be exposing myself to and/or increasing my risk of contracting or spreading COVID-19.

COVID-19 Assumption of Risk and Waiver of Liability

I agree to follow all CDC and local public health guidelines to reduce the likelihood of acquiring or spreading COVID-19. I attest that I have been fully vaccinated, or, if I am unvaccinated from COVID-19: (1) I do not believe that I have been exposed to a person with a confirmed or suspected case of COVID-19 within the past 14 days, and (2) I am not currently experiencing or have experienced COVID-19 symptoms within the past 14 days. I further attest that I have not been diagnosed with COVID-19 and not yet cleared as noncontagious by a physician. I attest that the following will remain true for the duration of my participation in the AgriGrowth event.

By attending or participating in an AgriGrowth event, I voluntarily assume all risks associated with exposure to COVID-19 and forever release and hold harmless the Minnesota AgriGrowth Council, its employees, consultants, officers, directors, agents, volunteers, or other representatives and vendors (collectively, “the Released Parties”) from any liability or claims including for personal injury, death, disease, or property losses, or any other loss, including but not limited to claims of negligence, and give up any claims I may have to seek damages, whether known or unknown, foreseen or unforeseen, in connection with exposure, infection, and/or spread of COVID-19 to participation in an AgriGrowth event.

I acknowledge that the venues and the Minnesota AgriGrowth Council have put in place preventative measures to reduce the spread of COVID-19 at the event, and that I must follow all posted instructions and other verbal or written instructions while in attendance. However, the Released Parties cannot guarantee that I will not become infected with COVID-19. By attending the event, I voluntarily assume all risks related to exposure to COVID-19.
