### **RULES AND REGULATIONS OF THE SOCIETY**

1. Name of the Society : **PEOPLES EDUCATIONAL ACADEMY**
2. Location of the office : H.No. 2-12-70, West Marredpally,  
Secunderabad – 500026
3. (i) Membership : (11) persons having Social service as well as  
Educational services Mentality only will be  
admitted for the membership  
(ii) Category Members : (6)  
(iii) Admission fees and annual : Admission fees Rs.0.50 and Annual Monthly  
subscription or monthly subscription Rs.6/4

#### **4. GENERAL BODY**

- I. Annual General Body will meet once in a year i.e., in the month of August.

#### **II. FUNCTIONS:**

- i) To pass the Budget for the ensuring year and approve the  
expenditure statement of previous year.
- ii) To approve the reports of Activities of the Society.
- iii) To elect the Executive Committee etc.

#### **5. EXACT NUMBER OF THE EXECUTIVE BODY INCLUDING OFFICE BEARERS :**

1. **PRESIDENT:** He presides over all the meeting of both the General Body and executive Committee. He can have a casting vote in the position. He can supervise all the branches of the Society.
2. **VICE-PRESIDENT:** He is to assist the President in discharging his functions in the absence of the President. He will perform the duties of the President as entrusted by him.
3. **SECRETARY:** He is the Chief Executive Officer of the society and custodian to all records relating to the Society and Correspondent on behalf of the Society. He has to take on record of all Minutes of the Society and to convince both the bodies of the Society. He has to operate the bank accounts of the society. He has to guide the Treasurer in preparing the budget and expenditure statements to be put before the General Body for its approval.
4. **JOINT SECRETARY:** He has to do the work as entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of Secretary he can perform the duties of the Secretary.
5. **TREASURER:** He is responsible person for all the financial transactions relating to the Society. He has to maintain accounts properly along with purchases. He has to prepare budget and expenditure statement of the Society with guidance of the Secretary.
6. **OFFICE-BEARERS:** They are responsible persons towards doing the activities of the Society, which the Executive Committee entrusted to them.
7. **QUORUM:** Half of the total Members of the General body meetings and 1/4<sup>th</sup> of the Executive Body meeting. No Quorum is necessary for the attainment of the Aims and objects.
8. **FUNDS:** The Funds shall be spent only to the attainment of the objects of the Society, and no portion hereof shall be paid or transferred directly or indirectly to any of its members through any means.
9. **AMENDMENTS:** No amendments or alterations shall be made in purpose of Association unless it is voted by 2/3 of the members present at General Body Meeting concerned for the purpose and confirmed by 2/3 of the members present at a Second Special Meeting.
10. **WINDING OF:** In case, if the society has to be windup the property and the funds of the society remains after full satisfaction of the liabilities of the societies shall be transferred of or paid to some other institutions with similar aims and objects.
