Section 4: First aid measures

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126)

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin contact: For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). For skin burns, cover with a clean, dry dressing until medical help is available. If blistering occurs, do NOT break blisters. If swelling, redness, blistering, or irritation occurs seek medical assistance.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to Doctor or Hospital.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink.

Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

PPE for First Aiders: Wear overalls, safety glasses and impervious gloves. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

Notes to physician: Treat symptomatically.

Section 5: Fire fighting measures

Hazchem Code: •2YE

Suitable extinguishing media: If material is involved in a fire use alcohol resistant foam, water fog (or if unavailable fine water spray), foam or dry agent (carbon dioxide, dry chemical powder).

Specific hazards: Flammable liquid. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. Avoid all ignition sources. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.

Fire fighting further advice: Heating can cause expansion or decomposition leading to violent rupture of containers. If safe to do so, remove containers from path of fire. Keep containers cool with water spray. On burning may emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.



Section 6: Accidental release measures

Emergency Procedure: Shut off all possible sources of ignition. Clear area of all unprotected personnel.

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust or vapours. Work up wind or increase ventilation.

Containment Procedure: If safe to do so, isolate the leak. Small spills are allowed to evaporate provided there is adequate ventilation. Contain - prevent run off into drains and waterways. If contamination of crops or waterways has occurred advise emergency services or State Department of Agriculture. If contamination of sewers or waterways has occurred advise local emergency services.

Clean Up Procedure: Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but

avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

Use a spark-free shovel.

Section 7: Handling and storage

Handling: Avoid eye contact and repeated or prolonged skin contact.

Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from incompatible materials described in Section 10. Store away from sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.

This material is classified as a Dangerous Good Class 3 Flammable Liquid as per the criteria of the Australian

Dangerous Goods Code and must be stored in accordance with the relevant regulations.



Section 8: Exposure controls / Personal protection

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

If risk of inhalation of exists, wear organic vapour/particulate respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716.

Hygiene measures: Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Wash hands prior to eating, drinking or smoking. Avoid contact with clothing. Avoid eye contact and repeated or prolonged skin contact. Ensure that eyewash stations and safety showers are close to the workstation location.
