

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to mikealvaughn.com and Mikeal Vaughn for County Council and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Mikeal Vaughn for County Council include mikealvaughn.com. The Mikeal Vaughn for County Council website is a Political Campaign Site. By using the Mikeal Vaughn for County Council website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Mikeal Vaughn for County Council may collect personally identifiable information, such as your:

- First and Last Name

Use of your Personal Information

Sharing Information with Third Parties
