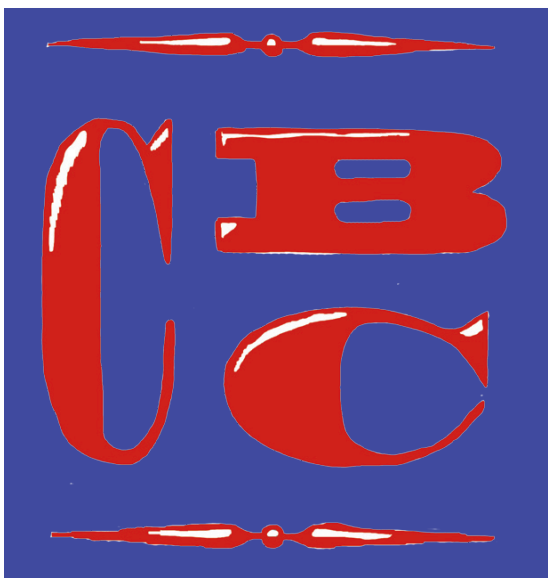

**Applicants, who are already carded with another CBC association, that are attending the Carded Judges Seminar requires a separate reservation form and Carded Seminar Fee in addition to applicant reservation form and fee.**

As an applicant, you may be tested using video judging, rulebook testing and an interview session. Your personal presentation will also be evaluated throughout the seminar. Associations may provide their applicants with their overall score, however, CBC, Inc. will not be responsible for the release of testing scores.
