

## **Terms of Use – EarlyBird Central Inc.**

**Last Updated:** April 26, 2021

Our website and mobile application is provided by EarlyBird Central, Inc. (“EarlyBird,” “we,” or “us”), an SEC-registered investment adviser. These terms of use (“Terms”) constitute a legal contract between you and EarlyBird and govern all aspects of your use of EarlyBird’s website and mobile application (“Site”). Please read these Terms carefully. By downloading or using any of the information, materials, or functions available on the Site (the “Services”), you agree to be bound by these Terms.

### **Your Information and Disclosure to Third Parties**

EarlyBird has made a commitment to protecting the privacy of those who use our Site. Please review the Site’s Privacy Policy. The Site’s Privacy Policy is incorporated by reference in the Terms. By using the Site, you are consenting to the Privacy Policy.

### **Site Services**

When you use the Site, you consent to receive communications from us electronically via the Site. You agree to provide accurate, current, and complete information about yourself when you use the Site and to update such information while you continue to use the Site.

### **Eligibility**

You represent and warrant that you: (a) are above the legal age of majority in your jurisdiction of residence, (b) have not previously been suspended or removed from the Site, (c) do not have more than one (1) account at any given time for the Site; (d) you will only provide us with true, accurate, current and complete information if you register for an account. If we believe or suspect that your information is not true, accurate, current or complete, we may deny or terminate your access to the Site or Services (or any portion thereof), and (e) that you have full power and authority to enter into the Terms and in doing so will not violate any other agreement to which you are a party.

### **Accounts and Registration**

To access the Service, you must register for an account. When you register you will be required to provide us with some information about yourself and your child. There are three types of accounts:

1. **Custodian Accounts:** This account type is for a custodian who is the parent or guardian of a minor to control gifts on behalf of the minor. A custodian account owner may elect to add a Trusted Contact to his or her EarlyBird account. The Trusted Contact has view-only rights to a custodial account, as assigned by the custodian account owner.
2. **Giver Accounts:** This account type is for friends and family who choose to give gifts.
3. **Child Accounts:** This account type is for the beneficiary of the gifts. This account is only available to the child after they have turned 18 years old.

You agree that the information you provide to us is accurate and that you will keep it accurate and up-to-date at all times. We reserve the right to restrict certain areas of information on the Site to such registered users. If you provide any information that is untrue, inaccurate, not current or incomplete, or we have reasonable grounds to suspect such, we reserve the right to terminate your account and refuse any and all current or future use of the Site by you. When you register, you will be asked to create a PIN. You are responsible for maintaining the confidentiality of your account and PIN. EarlyBird is not liable for any harm related to the theft of your access credentials, your disclosure of access credentials, or your decision to allow another person or entity to access and use the Site using your access credentials. You agree to accept responsibility for all activities that occur under your account. If you have reason to believe that your account is no longer secure, then you must immediately notify us by using the contact information below.

### **Investments**

You should carefully read these Terms and consider the investment objectives, risks, charges and expenses of EarlyBird before investing. All of EarlyBird’s clients are advised on a discretionary basis; EarlyBird will select the investment based on information provided by the client. You confirm that you do not need, require or desire in-person or other personal investment advice. Our investment advice will be based on the personal information you provide to us through our website. We do not provide any investment advice through other means.

### **Uniform Gifts to Minors Act**

Ownership of an account established under the Uniform Gifts to Minors Act (UGMA) is governed by the terms of this agreement and UGMA law. The account may be accessed only by the owner of the parent account (“Custodian”) (or the successor Custodian), and the funds must be used for the benefit of the child. We presume the Custodian is carrying

out her or his duties in accordance with the law, and we have no duty or obligation whatsoever to monitor or ensure that the acts of the Custodian (or successor Custodian) are conducted according to law or for the child's benefit. We are not responsible to either the Custodian or the child for monitoring the age or eligibility of a minor for an UGMA account, even though our records may include the minor's date of birth, and will not send any notices regarding the termination of the UGMA account for such reasons to anyone except and unless explicitly required to do so by state law. As clearly set forth by state law, it is the Custodian's responsibility to properly distribute the funds in the account including upon the child's death or attainment of the age of eighteen (18) (or the age of distribution under applicable state law).

### **Fees**

EarlyBird does not charge an account opening fee. EarlyBird does not require a monthly minimum to maintain your account.

### **Payment Providers**

In order to use the payment functionality of our Site, you must open a "Dwolla Platform" account provided by Dwolla, Inc. and you must accept the Dwolla Terms of Service and Privacy Policy . Any funds held in the Dwolla account are held by Dwolla's financial institution partners as set out in the Dwolla Terms of Service. You must be 18 years of age or older to use the service. You authorize EarlyBird to collect and share with Dwolla your personal information including full name, date of birth, social security number, physical address, email address and financial information, and you are responsible for the accuracy and completeness of that data. You understand that you will access and manage your Dwolla account through our Site, and Dwolla account notifications will be sent by EarlyBird, not Dwolla. EarlyBird will provide customer support for your Dwolla account activity, and can be reached at [support@getearlybird.io](mailto:support@getearlybird.io) and/or

### **Custodian Accounts**

Custodian accounts that have an AUM of \$200 or less will not be charged a monthly fee. AUM is calculated across one or multiple custodial accounts owned by the same account owner. If the total AUM exceeds \$200, a custodian account owner will pay a \$1/month wealth management fee for the first custodial account, and \$1/month for each additional custodial account. If the total AUM exceeds \$15,000, a custodian account owner will no longer pay a monthly wealth management fee(s), and instead he or she will pay an annual wealth management fee in an amount of 0.25% of the average AUM over the course of the year and such fee is charged monthly. All fees mentioned in this paragraph will not be deducted from a minor's custodial account, and instead will be deducted from the funding source connected to the user's EarlyBird account.

Transaction processing fee do not apply to custodian accounts.

### **Giver Accounts**

A giver account will not be charged monthly or annual wealth management fee without active custodial accounts. A giver account will pay a \$2 gift transaction processing fee

per transaction. All fees mentioned in this paragraph will not be deducted from the gift to the minor's custodial account, and instead will be deducted from the funding source connected to the user's EarlyBird account.

### **Child Accounts**

When a child assumes control of his or her account, there will be no monthly minimums or account opening fee. [EARLYBIRD TO PROVIDE ADDITIONAL INFORMATION REGARDING WHETHER THE MONTHLY/ANNUAL FEE AND TRANSACTION PROCESSING FEE WILL APPLY TO CHILD ACCOUNTS]

### **Change in Fees**

You acknowledge and agree that the fees described above may be increased or decreased as EarlyBird shall determine to be appropriate.

### **Referral Program**

EarlyBird may, in EarlyBird's sole discretion, offer promotional referral programs ("EarlyBird Referral Programs") that allow you to obtain account credits or other rewards ("reward") as a thank you to our existing customers ("referrers") and to welcome our new customers ("referees"). Rewards may include products, services, or EarlyBird credits, which consist of a specified dollar value that can be applied as a one-time investment in a custodial account that you control/manage, or can be applied when sending a gift to another minor's custodial account.

The following is applicable to all EarlyBird Referral Programs, unless otherwise stated in the specific terms to a particular EarlyBird Referral Program. To the extent any term in the specific terms conflict with these Terms, the specific terms to a particular EarlyBird Referral Program shall control.

#### *1. General Eligibility Requirements*

In addition to any eligibility requirements disclosed under the specific terms of a particular EarlyBird Referral Program, the following requirements must be satisfied to receive any reward through an EarlyBird Referral Program:

- a. Referrers must have EarlyBird accounts that are in good standing and are responsible for sending no more than one invitation each to referees that you know personally, other than yourself, such as friends, family and known acquaintances using any unique referral link provided by EarlyBird per EarlyBird Referral Program; and
- b. Referees must complete and satisfy any account opening requirements using any designated EarlyBird Referral Program or referral codes and must have EarlyBird accounts in good standing to receive any reward. EarlyBird is not

responsible for incorrect entry or other failure on the part of referees when registering for an account. Referees must not have a preexisting EarlyBird account prior to accepting an EarlyBird Referral Program invitation. Referees may redeem no more than one referee reward but may earn future rewards as a referrer by satisfying the general eligibility requirements in this section.

EarlyBird reserves the right to determine, in our sole discretion, whether an account is closed and/or in good standing. If an account is closed or not in good standing for any reason at any time, any EarlyBird Referral Program rewards for which the referrer or the referee would otherwise be eligible will be forfeited and any EarlyBird Referral Program rewards already disbursed may be revoked.

For either party to be eligible to earn a reward, both the referrer and the referee must meet these eligibility requirements. Rewards in the form of account credit may only be used to make a one-time investment to the account of the referrer's child or gifted to another EarlyBird user for use in his or her child's account. Rewards may expire at the discretion of EarlyBird. Rewards cannot be shared or transferred to another account.

## *2. Compliance*

In connection with your participation in an EarlyBird Referral Program, you agree to the following restrictions:

- a. No spam: You agree that you will not "spam" anyone with referrals to join EarlyBird either by mass emailing, use of automated systems, bots, or automatic dialers, and you will not post EarlyBird Referral Program links on websites or event or venue pages without the express consent from the owner or operator of any such websites or pages. You agree not to engage in or provide material support to any device or scheme that results in "spam" to referees.
- b. No misrepresentations: You agree that you will not attempt to mislead anyone in connection with the EarlyBird Referral Programs. This includes, but is not limited to, creating fake accounts, profiles, links, or messages.
- c. No prohibited content: You agree that you will not use any defamatory, offensive, abusive, or obscene content in connection with the EarlyBird Referral Programs. This includes, but is not limited to, content that violates someone else's privacy and harassing content.
- d. No fraudulent activity: You agree not to defraud or abuse, or attempt to defraud or abuse, anyone in connection with the EarlyBird Referral Programs. You agree to not engage in or provide material support to any activity that may be fraudulent, deceptive, or manipulative in connection with the EarlyBird Referral Programs.

- e. No misuse of EarlyBird's content: You agree not to sell EarlyBird Referral Program links or create websites, email addresses, or social media with EarlyBird's name, images, or content without EarlyBird's express consent. EarlyBird's content is not intended for distribution to, or use by, any person or entity in any jurisdiction where such distribution or use would be contrary to law or regulation or which would subject EarlyBird or any of EarlyBird's products or services to any authorization, registration, licensing or notification requirements within any jurisdictions or outside those jurisdictions in which EarlyBird and its affiliates are licensed to operate.

EarlyBird reserves the right to delay delivery of a reward pending verification that a referrer or referee has complied with these terms and/or the terms of a specific EarlyBird Referral Program. Violation of any of these restrictions may result in termination of your eligibility to participate in the EarlyBird Referral Programs and may, in EarlyBird's sole discretion, deny you any EarlyBird Referral Program rewards earned in violation or suspected violation of these restrictions.

### *3. Disclosure of Your Information*

By choosing to participate in an EarlyBird Referral Program, you expressly acknowledge and accept that referrers and/or referees may learn that you (whether as a referrer or referee) have an EarlyBird account. Other information disclosed to referrers and/or referees as part of the EarlyBird Referral Programs may include name, EarlyBird account status, and information about rewards received under the EarlyBird Referral Programs.

### *4. Legal and Regulatory Requirements*

You represent and warrant to EarlyBird that: (1) you are not subject to any statutory disqualification as set forth in sections 203(e) and 203(f) of the Investment Advisers Act of 1940 (the "Act"); (2) you are not currently the subject of any investigation or proceeding which could result in statutory disqualification under the Act; and (3) you do not have a "place of business" at which you regularly provide investment advisory services, solicit, meet with, or otherwise communicate with customers, or any other location that is held out to the general public as a location at which you provide investment advisory services, solicit, meet with, or otherwise communicate with customers in any U.S. state. If you cannot accurately make the preceding representations, you may not participate in any of the EarlyBird Referral Programs. If you are currently participating in an EarlyBird Referral Program and the preceding representations become inaccurate, you may no longer be eligible to participate in the EarlyBird Referral Programs.

The EarlyBird Referral Programs are void where prohibited by law.

You agree to release, discharge, and hold EarlyBird and its respective directors, officers, employees, promotion agencies, and assigns harmless against any and all claims,

damages, and liability caused, or claimed to be caused, by participation in any EarlyBird Referral Program or use or redemption of any rewards.

EarlyBird assumes no responsibility for invitations sent by referrers, and EarlyBird assumes no responsibility for undeliverable email or text messages to referees. For referrers, by sending the invitation via text message, you represent that you have consent to send such text messages to each referee.

Rewards that you receive for participating in an EarlyBird Referral Program may be taxable, so please consult your tax advisor if you have any questions about the tax implications to your personal situation.

EarlyBird may offer compensation to current clients, affiliate marketers, solicitors, and other strategic partners who recommend EarlyBird and refer new clients. The compensation received for referring a new client will depend on the relationship with the aforementioned client, affiliate marketer, solicitor, or other strategic partner and the volume and/or quality of new clients they are referring to EarlyBird. New clients are advised of such compensation prior to opening an account. EarlyBird supervises the referral activities of current customers, affiliate marketers (including “bloggers”), solicitors, and other strategic partners. Clients are not charged a fee nor do they incur any additional costs for being referred to EarlyBird by a current client, affiliate marketer, solicitor, or other strategic partner.

#### *5. Changes to EarlyBird Referral Programs and Program Terms*

EarlyBird reserves the right to suspend, cancel, terminate, limit, cap, or modify any EarlyBird Referral Program and/or reward at any time at its sole discretion and without prior notice. Please check these Terms regularly to confirm whether any changes have been made as indicated by the “Last Updated” date posted at the top of this page. Your continued participation in any EarlyBird Referral Program after we make any changes to these Terms will demonstrate your acceptance of any such changes. If you do not accept any such changes, your sole and exclusive remedy is to cease participation in the EarlyBird Referral Programs.

#### *6. Other EarlyBird Referral Program Information*

Investing involves risk, including loss of principal. The information provided in this section should not be considered a solicitation to buy, an offer to sell, or a recommendation for any security in any jurisdiction where such an offer, solicitation, or recommendation would be unlawful or unauthorized. Any preliminary information provided to prospective customers prior to EarlyBird agreeing to enter into an advisory relationship does not constitute investment advice and should not be relied on as such. The principal contributed to an account and any earnings thereon may lose value and are not FDIC insured, bank guaranteed, insured by any federal government agency, or guaranteed by EarlyBird. EarlyBird reserves the right to limit or cap the amount of EarlyBird Referral Program rewards you are eligible to receive and to refuse to cover any EarlyBird Referral Program rewards if EarlyBird determines that such rewards were obtained under wrongful or fraudulent circumstances, were awarded to you in error, that inaccurate or incomplete information was provided in opening an account, or that any of these Terms have been violated.

By participating in the EarlyBird Referral Programs, you undertake to perform your duties under these Terms in a manner consistent with these Terms, any and all of EarlyBird's instructions to you, the provisions of the Act, and the SEC's rules under the Act.

### **Your License**

Subject to these Terms, EarlyBird grants you a personal, non-exclusive, non-transferable, limited and revocable license to access the Site for your personal use ("Your License"). EarlyBird reserves the right to revoke Your License to use the EarlyBird Site at any time, including if we detect any unauthorized use by you in violation of these Terms.

### **Intellectual Property**

The Site, the content, any materials downloaded, and all intellectual property pertaining to or contained on the Site (including but not limited to copyrights, patents, database rights, graphics, designs, text, logos, trade dress, trademarks, and service marks) are owned by EarlyBird or third parties; all rights, title, and interest will remain the property of EarlyBird and/or such third-party owner, as applicable. All content is protected by trade dress, copyright, patent, and trademark laws, as well as various other intellectual property and unfair competition laws. You are authorized to view and retain a copy of pages of the Site only for your own personal, non-commercial use. You may also view and make copies of relevant documents, pages, images, or other materials on the Site for the purpose of transacting business with EarlyBird.
