**DIRECTIONS FOR USE:** For best results, apply product at time of lowest drain use, typically at the end of the day. Initially, add 8 ounces to each drain. Try to coat side surface areas inside drain pipe. Repeat daily as necessary until desired results are achieved. Then apply 4–8 ounces per week as a maintenance dosage.

**PPE:** Recommend latex or rubber gloves and protective eye wear.

**FIRST AID TREATMENT:** Avoid skin or eye contact. If eye contact occurs, rinse thoroughly with water for 15 minutes. If irritation persists, seek medical attention. Do not ingest. May cause gastrointestinal irritation with nausea and diarrhea.

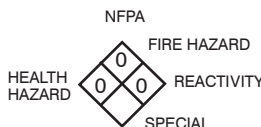
