

JET SKI HIRE AGREEMENT

Personal Safety

1. All hirers must hold a full current drivers licence.
2. Hirers must be over the age of 25.
3. Hirers and family/friends who may operate this watercraft are to complete the safety briefing instruction with Lakeland Wanaka before the hire begins. This is to ensure operators can fully enjoy the craft and ensure the safety of others.
4. Any person under 25 are not allowed to operate this craft without an adult (over 25 years) on board in charge. However, children are allowed as passengers with an authorised operator who has completed the practical safety instruction.
5. Hirers must adhere to and ensure all other riders of this personal watercraft abide by the safety instructions in the manufacturers' instruction manual and provided by Lakeland Wanaka.
6. Maritime New Zealand rules must be followed to minimise risk of injury.
 1. Speed may not exceed 5 knots (idle) if less than 200m offshore or from a divers flag.
 2. Speed may not exceed 5 knots (idle) if less than 50m from another vessel or swimmer.
7. Operating limits are the following lakes: Lake Wanaka and Lake Hawea, Lake Dunstan and Lake Wakatipu (NO USE is allowed on any river or in the ocean).
8. Lifejackets will be provided with this personal watercraft & MUST be worn at all times.
9. When towing, a lookout who is ten years of age or older MUST be onboard the jet ski and watching the tow at all times.
10. No night operation is permitted.

Damage and Insurance

1. Any damage to the craft that requires an insurance claim or repair will result in the insurance excess being billed to the hirer. Non-payment of excess will result in termination of hire or potential debt collection.
2. Repeat damage by a single user may result in the cancelation of that user's hire with no refund given.
3. The hirer is responsible for any damage to the craft while it is in the hirers possession.
4. Negligence by the operator of the craft resulting in harm or loss of life or breach of the Maritime Rules may result in loss of the hire with no refunds given.
5. Wheel clamps or locks are to be fitted to the trailer during overnight storage, or kept in a garage to ensure you are covered by insurance in case of theft.

What's included in the Hire

1. Insurance on the personal watercraft and trailer.
2. Trailer with warrant & registration.
3. All maintenance.
4. Storage.
5. Usage of Lakeland Wanaka's jet skis dependant on your hire length.
6. Watercraft is fitted with all safety equipment required including life jackets.

Bookings

1. Bookings are on a first in first serve basis.
2. Bookings must be made AT LEAST 48 hours before day of use unless arranged otherwise with Lakeland Wanaka.
3. We understand weather and other unforeseen circumstances can change your plans, bookings cancelled more than 48 hours before the day of hire will be refunded.

4. Bookings are made by using the online booking system once available or by contacting Lakeland Wanaka directly.
5. Jet Ski's will be delivered full of fuel, Jet Ski's must be returned full or fuelling costs will be billed plus a \$20 fuelling fee.
6. Jet Ski's will have a full safety check and running fluids check prior to bookings.
7. Jet Ski's can be towed to areas outside of Wanaka but Lakeland Wanaka must be made aware of where the Jet Ski is to be used and stored.
8. Jet Ski's must be used in accordance with local bylaws. It is the membership owner's responsibility to know the local bylaws of the area they wish to operate the Jet Ski in, any fines incurred will be at membership owners own cost.

Medical Disclaimer

1. By completing the user agreement form, you declare that you have no pre-existing medical conditions that could potentially impair your safe operation of the Jet Ski.

Liaility

1. We, our directions and employees will not be liable to you in contract, tort (including negligence), breach of legislative requirements, damage to property, personal injury, disability, illness or death suffered by your or any other person as a result of the use of the equipment or in connection with any tours or other services provided or any act/omission of any person. If for any reason we do become liable to you or any other person for any reason including contract, tort (including negligence), breach of legislative requirements, damage to property, personal injury, our total liability is limited to the fees you have paid to us for the use of equipment and provisions of the tours or services to you.
