



## HOUSE POLICIES

The following rules are the house rules which apply at Chin Chin Club. If you are on our site, you are obliged to comply with these rules. By entering the venue, you tacitly agree to abide by the applicable house rules and General Terms and Conditions of the MD GROUP ([www.m-d-group.nl](http://www.m-d-group.nl)). Violation of any house rule can be reported to the police and future access can be denied. We do not grant access to persons who, in any form, cause inconvenience for our neighbours or have caused in the past. By entering

### AGE

The minimum age of entry during club nights is 23. Be aware that in case of doubt, our host keeps the right to ask for your identification.

### ATTITUDE

In addition to all our daily social standards and values, we expect our visitors to be tolerant and positive towards other guests present at our location, regardless of their origin, culture, sex, sexual orientation, religion and age.

### CAMERAS

There are cameras on various places in the building. Anyone visiting our Chin Chin Club agrees to the camera surveillance. In case of calamities, these recordings may be shown as support material to third parties.

### DRESSCODE

Chin Chin Club's dress code is relaxed chic or glam. An elegant outfit is appreciated. We request you to avoid beachwear or sports shorts, but sports luxe and trainers are welcome. A tie, suit or evening dress are not mandatory but are nonetheless welcome. Furthermore, your clothes should look representable. Chin Chin Club has the right to refuse access when guests are wearing inappropriate clothing. This includes dirty, immoral, damaged clothing and or unhealthy appearance.

### DRUGS

The use, sale or possession of any narcotic drugs is strictly prohibited. Narcotic drugs are taken and placed in a police locker.

### FIRST AID KIT

A first aid kit can be found with the management from Chin Chin Club. The management is trained to provide first aid interventions.

### FIRE SECURITY

The emergency fire safety and evacuation instructions are available for guest to read. In case of fire please do not panic and warn an employee and press the nearest fire alarm.

### INSPECTION

At the entrance of the building, but also inside, there may be the possibility of having to submit to an inspection. This check is set to protect everyone in terms of overall security. Visitors who are visibly affected by alcohol or drugs will be denied access.

### LOITERING

We have the right to deny any access to Chin Chin Club in case of suspicions of unpleasant loiter.

### LOST & FOUND

Found items need to be handed in.

### PARKING/BICYCLE RACKS

You must park your vehicle at the designated places in such a way that no third parties are affected. If this is not done, you are at risk of your vehicle being removed.

### PROPERTIES

It is prohibited to take properties from Chin Chin Club outside of the building. This also includes left over food, beverages and glassware. In case of damage to our property, you are liable for repairs or renewal costs. You are responsible for your own properties. We do not accept liability for theft, loss and/or damage.

### SOUND(LEVEL)

In several rooms of Chin Chin Club more than 85 DB (a) sound is produced. Our company does not take responsibility for any consequences that may occur to your hearing. Staying in these rooms is therefore at your own risk. Ear plugs are available at the entrance.

### UNWANTED INTIMACIES

Unwanted intimacies (sexual harassment) are not tolerated.

### WEAPONS

Using or wearing any weapon is strictly forbidden. Upon detection of a firearm, the police will be called immediately.
