Document Clinic Cases:

We are thrilled that our Document Clinic was not adversely impacted by COVID, because once clients contact us through any of our other services, we can screen them for the Document Clinic. In 2019 we served 149 clients in our Document Clinics. In 2020 we served 193 clients. That is a 23% increase in people we served. About 51% of those clients are victims of abuse. The number of documents increased from 620 in 2019 to 716 in 2020.

We never could have anticipated the challenges we would encounter in 2020.

In many ways, TLC was ahead of the curve because we had been using Zoom for years and we understood how to use online technology to conduct clinics.

Without missing a single week, we took our clinics online when closures began. There were still many challenges and it took grit, determination, and many hours of extra work on the part of everyone, but we successfully brought more services to those in need in Utah than ever before. We are thrilled to report on what we have accomplished in spite of the obstacles created by the worldwide pandemic.

Hotline:

When many services shut down in March of 2020, our Hotline was indispensable in providing advice, referrals, and information to clients who could no longer access services in-person. We eventually expanded our Hotline by adding a second attorney to each Hotline shift. The goal was to answer as many calls as possible without the caller going to voicemail. Our Hotline is staffed by an attorney Monday through Friday between 9:00 a.m. and 2:00 p.m. In 2020 TLC attorneys answered 3,168 calls, which is remarkable when compared with 943 calls in 2018 and 2,231 in 2019. That is a 142% increase in total calls from last year. Of those calls, 2,111 were victims of abuse, which was about 67% of our cases.

This weekly clinic is the service that TLC was first known for and is often still considered the flagship of our services. We conduct a weekly clinic at the Health and Justice Building in Provo. On average our volunteers and staff met with 25 clients per night. Because of our experience in running rural clinics remotely, when closures were announced in mid-March, we immediately went online. Though our services were online immediately, it was difficult to communicate this to the community, so our numbers decreased. We worked hard at advertising the clinic and the numbers began picking up. We now average 20-25 online meetings with clients per week. The great news is that we provide service to clients from all around the state. We feel strongly that although it was difficult seeing our numbers decrease for a period of time, starting the online clinic was an incredible benefit for people across the state, not just within Utah county. When the pandemic is controlled, we will continue to offer the Tuesday clinic online because it benefits so many people.

At the beginning of June, we reopened the live clinic using plexiglass partitions, masks, tables doubled in width and spaced far apart, limited the number of people in a room, and introduced computer portals to connect clients with service providers working from home. Though we encourage the use of online services because of the reduced risk of COVID exposure, some clients desperately want to talk in person. We are now averaging about 10 clients per week at the walk-in clinic, in addition to the 20+ who receive advice online. We believe that next year our numbers will grow dramatically because we will continue to offer both clinics, and it is likely that both will expand as people learn about the options and feel more comfortable going to public buildings.

Despite the setbacks caused by the COVID closures, we served 1,024 people at the FJC; 643 of our clients were victims of abuse, which means 63% of the clients we see are victims. Though our FJC numbers were down from the 1,294 people we saw at the FJC in 2019, we believe that even if the COVID restrictions are in place for most of 2020, our numbers will surpass those of 2019 because people are learning about our online clinic.

Domestic Violence Shelters and Rural Clinics:

One of our primary goals for 2019 was to increase the number of clinics available in rural areas and through Domestic Violence shelters. We made remarkable progress and continued those services into 2020. We had to change our strategy when we could no longer travel and host live clinics due to the pandemic. As described above, we were prepared to serve our clients online at the Tuesday evening clinic and through the Hotline. In calendar year 2020, we conducted 158 interview and counseling sessions at clinics hosted at DV shelters or in clinics across the state other than the Family Justice Center in Provo. We helped 118 victims of abuse through these clinics, which is about 75% of the people we assisted.

Our numbers decreased from 538 clients served in 2019 due to the inability to host live clinics for the majority of the year. However, we were able to serve those 158 clients in the first two and half months of the year, with a few more at the end of the year. We believe that, given the roadblocks of this year, being able to serve this many clients in that short of a time was a success.

We look forward to returning to live shelter and rural clinics in 2021 when it is safe to do so. We believe our numbers in both the live clinics and the online clinics will increase as the word continues to spread about our services.

Pro Se Calendar:

The Utah Bar Foundation gave TLC funding to develop more Pro Se Calendars throughout the state. We started a calendar in the Eighth District in Duchesne and Roosevelt with Judge Chiara. We also moved the Provo calendar from quarterly to every other month rotating between the two Commissioners.

We contracted with a paralegal to do the final documents for the cases that were finalized. In 2019 we helped 47 parties through Pro Se Clinics as compared to 22 in 2018. In 2020 we helped 29 parties. Many calendars were canceled when the courts shut down and then opened for limited proceedings. We made some important adjustments that will benefit the program long term.

In some case, we sent the client to the attorney a week in advance of the hearing so the attorneys could work together to get a detailed agreement in place prior to the court date. We found that attorneys had time to verify assets and debts and do more thorough job in negotiating the settlement. We expect our numbers will increase next year as we plan in expand services, beginning with Cedar City.

Volunteers and CLE events:

We are especially proud of the fact that our volunteer hours increased during this turbulent time. Many of our volunteers reached out to us asking how they could help. In 2019, attorneys provided over 856 hours of

service and time in training and law students volunteered over 527 hours of time. In 2020, attorneys donated 928 hours and law students contributed over 865 hours. In 2020 we conducted one full-day CLE event. 42 attorneys attended the training for a total of 316.5 CLE credits.

Combined Services:

In 2020 we provided 4,572 services to people across the state. This is up from 4,259 services in 2019. That is an overall increase of 6.8% in services in a very challenging year. Approximately 64% of our combined clients are victims of abuse. Despite a chaotic year in so many ways, TLC was able to utilize new services and virtual technology (via increased reliance on Zoom meetings and phone calls) to increase our services.
