The most important feature of Bitcoin, and what makes it different from conventional money is the decentralization. No institution, such as central banks, has control over the Bitcoin network.

#### Fastest growing payment technology.

Digital currencies are being globally adopted for financial transactions since it has no geographic borders. According to Statista, in 2016 less than 9M people had wallets for crypto assets, and in 2021 crypto wallet owners are over 68M, an adoption that has largely grown in the last few years.

# TRANSACTING CRYPTOCURRENCY WAS HARD - NOT ANYMORE.

The main barriers for a business to accept, buy or sell Bitcoin:

- Bad user experience.
- Long confirmation time.
- Price volatility.

### **ACCEPT PAYMENTS**

Merchants can accept Bitcoin, Ethereum, and other cryptocurrencies without worrying about volatility. The cryptocurrency is automatically converted to USDT or DAI and distributors are responsible for providing the exchange to fiat currency whenever the merchant requests the withdrawal.

Distributors are able to profit from crypto transactions when they provide the withdrawal services in fiat currency by charging a fee, similar to what payment acquirers does by charging the MDR.

# SELL CRYPTOCURRENCY


Registered merchants can sell cryptocurrencies very easily. Deposit will be required to made to the distributor in fiat currency and the distributor will provide a deposit to the merchant's account in USDT or DAI. Having the USDT or DAI allows the business to sell any cryptocurrency listed on the XPOS platform and they can earn service fees from the transaction that is automatically shared with the distributor.

# **BUY CRYPTOCURRENCY**

Businesses can act as intermediaries by providing conversion from crypto to fiat currency. The XPOS owners can use the "Cashier" module as they would use to accept a payment, but instead of delivering a service or a good, they will deliver cash. Fees are splitted with the Merchant and the Distributor.

# **TRANSACTION FLOW**

XPOS network can run both in its closed-loop (off-chain) for reducing costs and processing time, and on-chain to democratize access.

# **REVENUE STREAMS**

The distributor is able to generate revenue from different sources as explained below.

#### **XPOS SALES**

As a distributor you are able to resell it with your own markup margin ou even implement a different distribution model such as device rental.

#### **XPASS SALES**

It can be supplied to your clients through the merchants and that becomes another source of revenue.

#### **CRYPTO SALES TRANSACTION FEE**

Every time a merchant sells cryptocurrency through a device that the distributor have activated, the fee is splitted between distributor and the shop owner. The fee can be set by the distributor through the dashboard and received by the distributor at his account.


#### LIQUIDITY AND EXCHANGE TO FIAT CURRENCY

After a crypto payment is received by the merchant, it will be automatically converted to stablecoin. Distributors should be able to provide conversion between USDT/DAI and the fiat currency used in its region. When that happens, the distributor can charge the MDR (Merchant Discount Rate) fee for facilitating the transaction.

# **DISTRIBUTOR PORTAL**

Distributors can manage all their clients in one place.

#### **BUSINESS MODEL**

Distributors should create their own market entry strategy. Whether selling, renting, or providing the device for free to their clients under consignment, the distributors decide.

#### MARKETING AND SALES

It is also a responsibility from the distributor to market it accordingly, producing their own brochures and sales material.

#### LIQUIDITY AND EXCHANGE TO/FROM FIAT CURRENCY

Distributors should be able to provide conversion between USDT or DAI and the fiat currency used in its region.

#### **COMPLIANCE**

Applicants should demonstrate they are able to suffice demands from regulators in their markets initially by providing a Legal Opinion by a lawyer and later by putting in place the compliance process that will meet the demands from the local regulatory bodies and obtain the relevant license if required.
