Education: Our founding degree partner is Southern New Hampshire University and a program called College for America CfA. Through CfA, enrollees earn their Bachelors in Management. This program focuses on building a wide range of management skills from operations, to business writing, to financial management, team leadership, strategy, and more. In 2020, we supported 98 new students towards earning their bachelor's degree. 67% of students are expected to graduate within 150% of the expected time. In 2020, the organization launched Pay It Forward, enabling students to pay no upfront tuition, but repay it only when they earn over \$40k. As a result of the COVID-19 pandemic, the organization also launched Rivet School Bridge, focusing on students directly out of high school. They also gave out numerous emergency grants providing relief and support to students with unexpected life challenges and other barriers to academic success.
