TRACTION

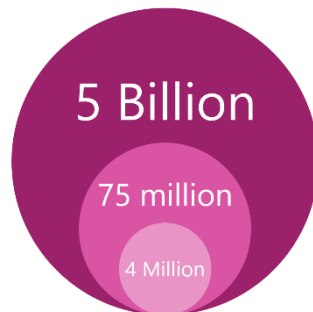
- We've generated a profit of **200.000 Euro** in the first 2 years of operation.
