Additional Fee Information

- Fees include all freshly prepared meals and snacks. Fees also include premium nappies & wipes.
- Registration fee is non-refundable, payable upon enrollment. This includes our Welcome Pack & settling in sessions.
- Additional ad-hoc sessions and extra hours are subject to availability. Any ad-hoc sessions or extra hours booked but not taken are not refundable unless agreed otherwise in exceptional circumstances.
- If your child is offered a place, 50% of one month's advance fees will be due upon enrollment. This will be offset against the final month's fees and is non-refundable if the place is not taken. Reimbursement is subject to T&Cs.
- Your child will access the Over 3's rate the term after their birthday, and when in receipt of EYE funding.
- Sibling discount: 5% for the second and third child attending the same number of sessions as the first child.
- Monthly fees are collected in advance, payable by the 25th on each calendar month after receipt of invoice. Please state your invoice number for reference.
- Payment is made by bank transfer (BACS). Direct Debit or Credit Card Payment may be available in the future. For security reasons, we do not accept cash payments.
- All late payments will be charged 1.5% of outstanding amount on a daily basis for up to 2 weeks; this will be invoiced the following month. After an overdue period of 2 weeks your child may be denied entry to the setting.
- The setting will be closed for 2 inset days per year: this is to continuously improve the quality of teaching and provide professional development for all our educators. These sessions will not be reimbursed nor will days be given in lieu.
- Fees are payable for all Bank holidays and personal holidays taken. Refunds or replacement sessions cannot be given for unattended sessions and booked sessions cannot be swapped for alternative sessions.
- 12% reduction in fees if full year in total is paid in advance. 5% reduction in fees if 6 months is paid in advance.
- Advance payments are non-refundable.

- Please assess your eligibility for Child Tax Credit by contacting www.hmrc.gov.uk/tax-credits
- The initial payment of fees will be determined by the child's official starting date and will include all sessions booked from that date, up to, and including the remainder of that particular month. Settling in Sessions are not charged.
- If your child is attending less than the month's full amount of sessions before or after they join us, we are required to charge on ad-hoc basis for that particular month. You may choose to pay standard fees for the whole month.
- Returned payments from the bank may incur an administration charge equal to any charges that Yüme may be charged by the bank.
- You must give 2 month notice in writing if you choose to end your contract with us. Your deposit credit will be deducted on the last month's payment. In case you decide to re-enroll after dropout, you must pay registration fee again and your child's spot may be subject to availability or be placed on our waiting list until the space is available.
- After a breach of contract, you will be required to pay two months notice period and/or all late payments.
- Extended Hours: If the extended hour(s) is (are) shorter due to an early pick up, the pre-booked fee will still apply. Late pick-ups will be changed in respect to additional multiples of 30 mins (e.g.: 10 or 20 min late = 30 min).
