Subject to conditions prescribed by the Beverly Hills Unified School District and ProWest Constructors, sealed proposals, for the Subcontractor Proposal Package listed below, are invited for the following described work:

PROJECT DESCRIPTION:

ProWest Constructors ("ProWest") is acting on behalf of the Beverly Hills Unified School District as the Lease/Lease Back Contractor on the South Campus Modernization Shoring & Retaining Wall #2 project at the Beverly Hills High School.

This project consists of the construction of Retaining Wall #2 with a temporary shotcrete wall, soil nails, and a permanent shotcrete wall over the temporary wall. There is a short section of wall with drilled concrete piles, wood lagging, and shotcrete. All walls include reinforcing. Also included in this proposal release is site demolition, mass excavation, grading, and earthwork to accommodate benches for soil nail drilling, Site Lighting along Heath Road, Survey, SWPPP Implementation and Monitoring, and Site Utilities for the storm drain at the base of the wall.

Proposals must be received on or before 2:00 PM on the designated Proposal Due Date. All proposals time stamped after 2:00 PM on the designated Proposal Due Date will be considered nonresponsive.

Prequalification of MEP Subcontractors. In accordance with California Public Contract Code section 20111.6, all mechanical, electrical or plumbing ("MEP") Subcontractors of any tier (contractors that hold C-4, C-7, C-10, C-16, C-20, C-34, C-36, C-38, C-42, C-43 or C-46 licenses), must be prequalified. All MEP Subcontractors **holding** any of the licenses listed must be prequalified. This prequalification requirement for MEP Subcontractors applies even if the subcontractor will perform, or is designated to perform, work that does not require one of the licenses listed above, but the subcontractor **holds** one of the licenses listed above.

Prequalification of Mechanical, Electrical, Plumbing and any other subcontractors who hold any of the licenses listed above, is mandatory at this time to be eligible to propose on the Project for Proposal Release #2.

Prequalification packets may be submitted up to twelve (12) days before the proposal due date.

PROPOSAL DELIVERY INSTRUCTIONS:

Proposals shall be delivered to ProWest at the location listed below. Proposals may be hand delivered, emailed or faxed. If they are emailed or faxed, original proposals with wet signatures must be submitted within two (2) working days after proposal due date.

PROPOSAL BONDS:

For Proposals in the amount of \$150,000 and over, a Proposal Bond in the amount of 10% of the Lump Sum Base Price shall accompany the Proposal. For Lump Sum Base Price amounts of less than \$150,000, a Proposal Bond shall not be required.

The Surety issuing the Proposal Bond shall be, on the Proposal Deadline, (i) listed in the latest published State of California, Department of Insurance, list of Insurers Admitted to Transact Surety Insurance in this State; and (ii) have an A.M. Best Rating of at least A-/VII.

PREVAILING WAGE REQUIRED:

The successful Proposer and its subcontractors will be required to pay prevailing wage rates at the location of the Work pursuant to California Labor Code section 1720 et seq. The Department of Industrial Relations has determined the general prevailing rate of per diem wages in the locality in which this work is to be performed for each craft or type of worker needed to execute the Contract which will be awarded to the successful proposer. The successful Proposer and all its subcontractors shall comply with all applicable Labor Code provisions, which include, but are not limited to, the payment of not less than the required prevailing rates to all workers employed by them in the execution of the Subcontract, the employment of apprentices, the hours of labor and the debarment of Subcontractors and their subcontractors.

The District has determined that the Prevailing Wage Determination for this project is 2021-2. Prevailing wage rates are available at <http://www.dir.ca.gov/dlsr>.

SKILLED AND TRAINED WORKFORCE:

This project is subject to SB693 Skilled and Trained Workforce Requirements.

CSLB:

At the time of submission of the Proposal, Proposer and all subcontractors, regardless of tier, shall have the appropriate current licenses issued by the State of California Contractor's State License Board for the Work to be performed.

DVBE:

Compliance with Disabled Veteran Business Enterprise (DVBE) contracting goals is required under this contract. The District has a DVBE participation goal of 3% per year of the overall dollar amount of state funds allocated to the District pursuant to the Leroy F. Greene School Facilities Act of 1998, and is expended each year by the District. Proposers must make a good faith effort to contact and utilize DVBE contractors and suppliers in securing bids for performance of the Project.
