Audit Findings

Audit Narrative

The audit process formally began with several phone calls with Layanda Dowell, Director of Compliance, Delaware, Christina Dertouzos, Quality Assurance Manager, and Ken Donovan, Director of Operations, Delaware, in August. The auditor had worked with VisionQuest to audit four facilities in Pennsylvania, and had worked with Ms. Dertouzos closely to ensure that VisionQuest policies matched the PREA standards. Ms. Dertouzos worked closely with MS. Dowell to ensure the policies were both PREA compliant and fit the law and work of VisionQuest Delaware facilities.

All the PREA pre audit material was sent September 16 and reviewed by the auditor over the next three weeks. Prior to the in-person audit, the auditor sent an email detailing what VisionQuest would need to do for the audit. The auditor arrived at the VisionQuest Delaware office on the morning of Tuesday, October 16th. Ms. Dertouzos, Ms. Dowell, Mr. Donovan, and Carlton Adams, Program Director for both Kent and Sussex County RAD, met with the auditor. The auditor reviewed the process for the in-person audit and answered questions. The group then provided the auditor a staff and resident roster for each facility to select from for random staff and resident interviews, as well as determined who would be best to interview for various roles within the organization.

The auditor decided to interview all residents (six from Sussex and four from Kent) as well as 10 staff. Out of 30 total staff, the auditor selected 10 by crossing off every third name on the list until 10 names remained. The auditor then did interviews with staff in specific roles, reviewed staff records (randomly selecting 12 files of current staff to review and verify compliance) and then left for the day at 4 p.m.

On the morning of October 17th, the auditor went to Sussex County RAD and began staff and resident interviews, reviewed all resident files, took a tour, and reviewed video footage. Around 4 p.m., the auditor went to Kent County RAD to interview residents, tour the facility, and review video footage. All residents go off-site for school, so evening was the best time for interviews to be done. The next day, the auditor returned to Kent County RAD to finish with additional staff interviews and reviewing files. The auditor left around 2 p.m. A total of three days were spent on site.

Facility Characteristics

VisionQuest are two staff secure residential facilities (that generally operate as a single facility with two separate locations) in Delaware. Sussex County RAD is a house with an additional modular unit with offices an office and area for school and recreation (movies and video games). Kent County RAD is a house. Both facilities have staff offices, a kitchen and dining spaces, recreational/living space, and bedrooms and bathrooms for residents.

Residents from both facilities attend public school, although there is a separate modular unit that serves as a school at the Sussex County RAD. Both facilities have multiple bedrooms the house 2-3 residents, and one room for a single resident. There are multiple bathrooms that residents use privately.

PREA posters, brochures, and auditor contact information was found in all spaces residents use. Also noticeable throughout the facility was information about the Sanctuary® Model of Trauma Informed Care, which the facility uses as a best practice.

There is a video monitoring system at each facility. At Sussex County RAD, the monitor is in the staff office on the first floor of the house. At Kent County RAD, the monitor is in the basement, where other materials are stored (toiletries, food, etc.) Cameras are used in South Penn to monitor the shared living spaces in the housing units and in other common areas including staff offices.

Both programs are very small—both in the number of residents and the facilities themselves. There always seem to be many staff present, and even though the necessary ratio during awake hours is 1 to 5, it seem like the ratio is usually much higher.

VisionQuest has a comprehensive PREA policy that includes zero tolerance of sexual misconduct, which is defined to include sexual abuse and sexual harassment. Both facilities fall under Director of Compliance, Layanda Dowell, since they both operate under one administrative staff. Phyllis Yester, Executive Vice President of VisionQuest, is the agency-wide PREA Coordinator. Ms. Yester has an additional employee, Christina Dertouzos, which assists her with all PREA-related duties. With this team approach, Ms. Yester feels she has ample time to fulfill her role as PREA Coordinator and other job responsibilities.

Both agencies maintain a staff ratio of at least 1:8 during resident waking hours and 1:16 during resident sleep hours. This is a requirement of the Department of Services for Children, Youth, and Their Families (DSCYF) and VisionQuest Delaware Residential Programs Operating Procedure Supervision of Youth (that calls for a ratio of 1:5 during awake hours, and 1:10 during the night). The auditor reviewed staffing plans, policy, annual inspection report from DSCYF the annual PREA report, and conducted staff and resident interviews. The auditor also viewed documentation and video footage of random unannounced rounds done by intermediate or higher level staff.

VisonQuest Delaware Residential Programs Operating Procedure addresses searches and cross-gender viewing compliant with PREA, but the agency does not conduct searches. They have not conducted searches in the last twelve months. The housing unit bathrooms and other facilities residents use are single occupancy. Staff does not accompany residents inside the bathroom. Staff of the opposite gender announces their presence before entering housing units as mandated by policy. All information was confirmed in interviews with staff and residents.

If the act is not criminal, Children and Youth and VisionQuest will conduct an administrative investigation.
