

FUNDS AND SERVICES FOR TENANTS EXPERIENCING NEED (FASTEN)

FASTEN is a program offered, through the <u>Project Parachute initiative</u>, to help vulnerable tenants stay in their homes in the wake of the Covid crisis. FASTEN connects individuals to services and financial resources, including rental arrears assistance.

WHO WILL PROVIDE SERVICES TO TENANTS?

FASTEN services will be delivered by seven service providers that work within the City's eviction prevention program <u>Homebase</u>. Providers include – BronxWorks, CAMBA, Catholic Charities Brooklyn and Queens, Catholic Charities Community Services, HELP USA, RiseBoro Community Partnership (RiseBoro), and Services for the UnderServed (S:US).

WHO IS ELIGIBLE FOR SUPPORT AND ASSISTANCE THROUGH FASTEN?

Individuals and families served by FASTEN must:

• Have income that is not more than 50% area median income (AMI), as captured in the table below:

- Be experiencing housing instability, such as inability to pay rent fully; and
- have experienced negative Covid-related financial impacts, such as loss of income or an increase in expenses.

Anyone who meets these requirements can receive assistance regardless of immigration status or employment status (e.g. temporary, intermittent, part-time, day labor, and contract workers) through non-profit Homebase providers.

WHAT SERVICES WILL BE PROVIDED TO TENANTS THROUGH FASTEN?

Through FASTEN, tenants are eligible to access:

- Services and service referrals, both virtual and/or in person, such as education on tenants' rights under housing law, housing court navigation supports; informal landlord mediation counseling; referral to benefits programs the individual may be eligible for including unemployment, SCRIE (Senior Citizen Rent Increase Exemption) / DRIE (Disability Rent Increase Exemption), SNAP (Supplemental Nutrition Assistance Program), etc.; information about and assistance with applications for Covid relief-related resources; financial counseling; and career support including job search assistance and referrals to workforce providers;
- One-time or short-term financial assistance, such as costs associated with securing and transitioning into new housing (security deposit, first month rent, moving expenses), career developments and job search related costs (licensure, initial weeks of daycare), transportation costs, and immediate need grants (utilities, food, prescriptions, etc.); and/or
- Rental arrears assistance for NYC residents ineligible for existing rental arrears grants due to immigration status or nonstandard employment.

WHERE CAN TENANTS ACCESS SERVICES AND SUPPORTS THROUGH FASTEN?

Collectively, the seven participating service providers serve the whole city. Each service provider partner will offer services to clients based on their zip code, as outlined below.

HOW CAN TENANTS LEARN MORE AND GET SUPPORT?

Tenants can be referred by landlords, referral partners, and agencies or reach out directly to their respective Homebase provider, as outlined below. Clients are also able to identify their local Homebase provider by calling 311 or visiting the Homebase Locator webpage (https://www1.nyc.gov/site/hra/help/homebase-locations.page).
