Overview

Gyanm Institute respects your right to privacy. We do not currently trade, sell or rent personal information collected about you to third parties. Please read the Privacy Policy outlined below that explains how Gyanm Institute will and will not use the information you provide. Information we collect

In general, you can browse the Site without telling us who you are or revealing any personal information about yourself. Once you give us your personal information, you are not anonymous to us. To fully use our Site, you will need to register using our online registration form, where you may be required to provide us with your personal information for registering you for different courses. This will include Student's name, Father's name, Mother's Name, Address, e-mail address, telephone number, Mobile Number, Marks obtained in last attended classes, school in which you are/were studying and newspapers you read. By accepting the Privacy Policy and the User Agreement in registration, you expressly consent to our use and disclosure of your personal information in accordance with this Privacy Policy.

You agree that we may use your personal information to contact you via e-mail or phone number or address and deliver information to you related to your online registration account, online testing platform or that, in some cases, are targeted to your interests, such as administrative notices and communications relevant to your use of the Site. By accepting the User Agreement and Privacy Policy, you expressly agree to receive this information.

We may automatically track certain information about you based upon your behaviour on our site. We use this information to do internal research on our users' demographics, interests, and behaviour to better understand, protect and serve our users. This information is compiled and analysed on an aggregated basis. This information may include the URL that you just came from (whether this URL is on our site or not), which URL you next go to (whether this URL is on our site or not), your computer browser information, and your IP address. We maintain data files for our records. We do not use personal information of student beyond our domain and are not sharing personal information with third parties. Our web site may automatically monitor the number of visitors, the average time spent on the site, the popularity of our web-sites, and any programming errors or failures on any of our web-sites in order to determine the effectiveness of the Gyanm Institute web-site and to make improvements to the website.

About cookies

"Cookies" are small files placed on the hard drive of your computer. Gyanm Institute website uses cookies to provide services to you and help ensure account security. Most cookies are "session cookies," meaning that they are automatically deleted from your hard drive once you end your session (log out or close your browser). Gyanm Institute's website uses cookies on certain pages of the website to:

- Allow you to enter your information less frequently during a session.
- Offer certain features that are only available through the use of cookies.
- Measure promotional effectiveness.
- Analyse our web page flow.

Your choices about cookies – We offer online testing platform or registration process for new student or existing student that may only available through the use of a cookie. You are always free to decline cookies if your browser permits. However, if you decline cookies, you may not be able to use certain features on the website, and you may be required to re-enter some information more frequently during a session.
