Personal data that we process

CrossFit Eudokia processes your personal data because you use our services and/ or because you provide this data to us yourself. Below is an overview of the personal data that we process:

- Name and surname
- Date of birth
- Place of birth
- Address details
- Telephone number
- E-mail address
- Other personal data that is actively provided
- Location data
- Information about activities on our website
- List of contact details of members/ clients via an app
- Bank account number

Special and / or sensitive personal data that we process

CrossFit Eudokia processes sensitive personal data about your health and biometric data.

For what purpose and on what basis do we process personal data

CrossFit Eudokia processes your personal data for the following purposes:

- Handling payments
- Sending newsletters
- Contact by phone email to be able to carry out our services
- Legally required activities such as at benefit of the tax authorities

CrossFit Eudokia analyzes your behavior on the website in order to improve the website and to tailor the range of products and services to your preferences. CrossFit Eudokia follows your surfing behavior on various websites with which we tailor our products and services to your needs.

Automated decision-making

CrossFit Eudokia makes decisions based on automated processing on matters that can have consequences for people. These are decisions taken by computer programs or systems, without involving a person.

How long we keep personal data

CrossFit Eudokia does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected, but with a maximum of seven years in connection with the tax authorities.

Sharing personal data with third parties

CrossFit Eudokia will not sell your data to third parties and will only provide it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. CrossFit Eudokia remains responsible for these processing operations.

Cookies, or comparable techniques, that we use

CrossFit Eudokia can use functional, analytical and tracking cookies. You can opt out of cookies by setting your internet browser in such a way that it no longer stores cookies. In addition, you can also delete all information previously saved via your browser settings. These are, for example, advertisers and / or the social media companies.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization mentioned by you. If you want to use your right to object and / or right to data portability or if you have other questions / comments about data processing, please send a specified request to info@crossfiteudokia.com. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. CrossFit Eudokia will respond to your request as soon as possible, but in any case within four weeks.

Complaint
