Injury or Death of Combatants

IMPORTANT - Promoters must understand, acknowledge and agree with the following legal indemnity regarding public liability relating to combatants contesting WBF sanctioned Amateur Masters Championships.

- Promoters when signing the legally binding Indemnity agreement acknowledge and accept that the WBF is in no way liable or responsible for any injury or death of a combatant that contests a WBF sanctioned Amateur Masters Championship.
- The Promoter acknowledges and understands that the WBF is in no way responsible for any public liability insurances pertaining to combatant injury or death whilst competing and challenging for WBF Amateur Masters Championship Titles.
- The Promoter is legally responsible for and must ensure that public liability insurance covering injury or death of combatants that are contesting WBF sanctioned Amateur Masters Championships is legal and current.
- The Promoter understands that they must submit a legal and current public liability Certificate of Insurance to the WBF covering injury or death to all combatants contesting WBF sanctioned Amateur Masters Championships prior to WBF Championship Titles being sanctioned.
