

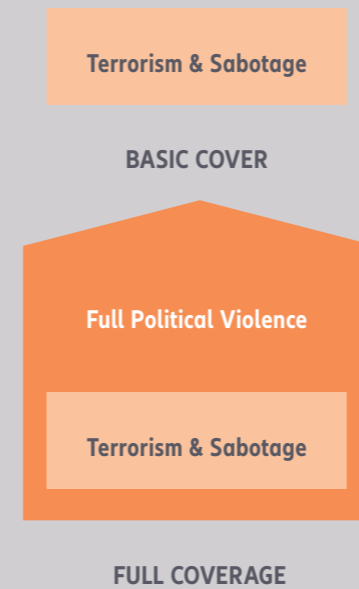

# COVERAGE OPTIONS FOR RISKS OF TERRORISM AND POLITICAL VIOLENCE

In our globalised world, companies are increasingly facing challenges from terrorism and political violence. Insurance cover is available from state pools as well as private sector policies – some limited to the home country, some transnational, with diverse coverages and different jurisdictions. Our services aim to close the gaps in coverage and ensure transparent, globally consistent insurance cover.



## TERRORISM & SABOTAGE

Actions by persons or groups of persons to achieve political, religious, ethnic or ideological goals.

## FULL POLITICAL VIOLENCE

In addition to terrorism & sabotage, this covers:

- ✓ **Malicious damage:** disturbance of the public peace committed by one or more persons
- ✓ **Organised riot, revolution or rebellion:** open, violent resistance to a lawful civil or military authority or government
- ✓ **Coup d'état / putsch:** violent overthrow of a government by unconstitutional means or the attempt at such an overthrow
- ✓ **Mutiny:** illegal resistance of the armed forces
- ✓ **War:** hostile conflict between states or nations, whether war has been declared or not
- ✓ **Civil war:** violent armed conflict between opposing civil groups from the same state or nation or two neighbouring states or nations.

## ALLIANZ GLOBAL CORPORATE & SPECIALTY (AGCS)

offers various coverage options to insure against terrorism and political violence, which can be combined as required. The cover can be added where state pool solutions or traditional types of business insurance reach their limits, e.g. in the area of offshore wind, infrastructure projects and incidents with cross-border effects.

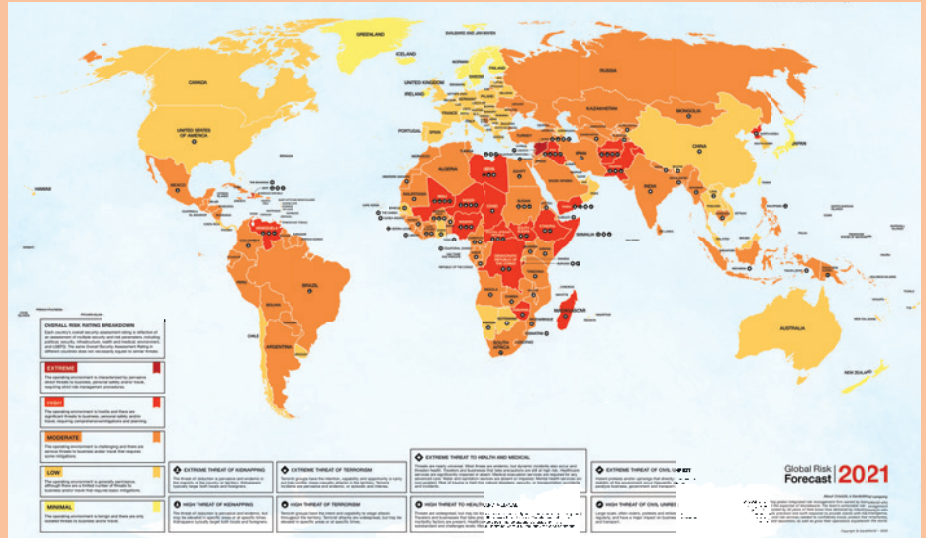
## ADDITIONAL COVERAGE OPTIONS:

<b>NCBR</b>	(Nuclear, Chemical, Biological, & Radiological Terrorism) Damage resulting from nuclear, chemical, biological and radiological attacks. Sum insured: max EUR 50 million
<b>Threats</b>	Business interruption losses due to official terrorist warnings (without previous property damage). Sum insured: max EUR 50million
<b>Mass shootings</b>	Property-related damage and damage due to business interruption caused by property damage or ordered closure of the business. Sum insured: max EUR 50million
<b>Event cancellation</b>	Loss of profit and costs due to the cancellation of an event. Sum insured: max EUR 100 million
<b>Consequential losses / dependent losses</b>	Business interruption losses due to property damage at a supplier or customer company caused by an act of terrorism.
<b>"Loss of Attraction"</b>	Reduced demand / loss of attraction
<b>Terrorism liability</b>	Insurance cover for companies that can be held liable for personal injury and damage to property resulting from terrorism and political violence. Sum insured: max EUR 100 million

*Cover for terrorism and political violence can be taken out as a supplement to property, engineering, energy or entertainment insurance or as a separate contract. It should be possible to implement this in local policies accordingly.*

*We also create International Insurance Programmes (IIP) to cover the risks of terrorism and political violence, with the aim of meeting current regulatory requirements.*
