Achievement or Growth on Benchmark Assessment

October Update: All students were given the iReady Diagnostic at the beginning of the school year. Students who enroll will be given the Diagnostic to evaluate current levels in reading and math. Students will participate in iReady lessons in addition to classroom instruction in order to increase their scores towards the grade level benchmark. Progress of lessons will be provided monthly as well as a summary of the Diagnostic results mid and end year.

November Update: All students should be working on the iReady lessons determined by the diagnostic score from the beginning of the school year. iReady recommends 60-90 minutes per week/per subject when students are participating in remote learning. We are transitioning from approximately 30 minutes per week/per subject as previously recommended. The following table shows the averages for kindergarten through eighth grade. The week of 11.23 is lower due to the Thanksgiving holiday. Students were only in school for 2.5 days.

December Update: Students completed the iReady diagnostic the weeks of December 7th and 14th. The data will be updated and available during the January board meeting. Students continued working on iReady lessons. The data for time on task, lessons passed, lessons completed and the average are below for ELA and Math.

January Update: The demographic information is being updated and will be included in February's board meeting. Initial results show an increase in proficiency levels and a decrease of students at risk for Tier 3 intervention across all grades! As we were on winter break, there are no updates for iReady lessons at this point in the month.

Goal Progress: As stated in our mid-year goal we have decreased the students "At Risk for Tier 3" according to the iReady diagnostic. At the beginning of the year, 55.76% of students were at risk in reading. At the mid-year point this number has decreased to 39.79%. At the beginning of the year, 47.94% of students were at risk in math. At the mid-year point this number decreased to 34.85%.
