

THE IMPORTANT STUFF.

- Trading hours: Friday 5pm – 10pm, Saturday 12pm – 10pm, Sunday 12pm – 9pm, 52 weeks of the year. We may open on select public Holiday weekends – keep an eye on Grazeland socials for further details.
 - There are two entrances to Grazeland, the main entrance is on the street, and the rear entrance is through the carpark. Both are located on Booker Street, Spotswood. Enter 20 Booker Street in your maps for directions.
 - There are over 700 car parks (on & off street) (including disabled car parks) and bike racks for 100 bikes.
 - We recommend that you use public transport. Via train, take the Werribee/Williamstown line to Spotswood train station, just a short walk from the Grazeland entrance. Or via boat, the Williamstown ferry service stops at the Spotswood jetty, right in front of Grazeland. It's approximately 35 minutes from Southbank to Grazeland.
 - We have ATMs onsite, all vendors have EFT terminals and accept cash. ATMs are conveniently located at both entrances.
 - There are toilet amenities located near both entrances, including disabled access. The disabled toilets have baby change tables inside.
 - Our huge line-up of amazing food vendors cater for all dietary requirements. To find specific information about our vendors, please visit our website.
 - Grazeland is fully licensed. There are 3 bars onsite, conveniently located in the Meadow, Boulevard & Metro zones. All bars practice the Responsible Service of Alcohol (RSA). You are not permitted to bring any alcohol onsite or take away off site.
 - You can set up a bar tab for your function. We provide wristbands for easy identification of your guests (self-service) or we can organise a tailored drinks service.
 - Unaccompanied Minors will not be served at any bar, and accompanied minors must have orders for beverages placed by a responsible parent/guardian.
 - Unduly intoxicated or disorderly persons, in accordance with the Responsible Service of Alcohol (RSA), will be refused service and may be asked to leave the premises.
 - We have the right to refuse entry to any person.
 - All employees are trained and supported by management to request valid identification from persons whom they believe appear under 25 years of age.
 - All food is served on compostable packaging, including cutlery and food containers supplied by vendors. Cups for drinks are in compostable PLA.
 - Plastic bottles are not allowed within the park.
 - Grazeland Melbourne will be open even if it's raining. 75% of the park is under cover, and we'll even heat parts of the park during the colder times of the year.
 - In the event of extreme weather, we may close the park. If this occurs Management will notify the public via our website & digital platforms.
 - COVID POLICY- As per the State Government Mandatory Vaccination Regulations, you will be required to provide vaccination status or lawful exemption and check in with the provided QR code.

SUSTAINABILITY & WASTE MANAGEMENT

90% of Grazeland's waste
will be either commercially
composted or recycled!

All traders must adhere to our strict waste management and sustainability policy which includes:

Grazeland has appointed a waste management contractor, Waste Ninja. All waste generated at Grazeland will be removed from the park by private contractors.

All packaging used by vendors is approved by Grazeland Management as 100% commercially compostable.

Vendors must adhere to the following:

- Packaging must be plant-based and commercially compostable.
- All beverages served in PLA cups.
- All cooking oils used for fryers will be supplied & recycled by Oil2U.
- All organic waste (generated from food preparation) is composted.

All waste generated within the public areas at Grazeland will be compostable via commercial composting processes. Visitors will be made aware of the waste management protocols at Grazeland via informative signage, clearly marked bins, onsite management at entry points and information on the Grazeland website and social channels.

On site recycling:

- All glass bottles will be crushed & recycled on site via Bottle Cycler – all packaged beverages are in glass only.
- Cardboard waste generated by our traders will be collected and sorted within the WPA to ensure it's sent to the appropriate recycling service provider, reducing if not eliminating any waste going to landfill.
- Any plastic or other materials brought into Grazeland must be placed in specific bins so it doesn't contaminate the compostable waste stream.

What happens to your food waste

1. Your food waste is transported to one of our organics recycling facilities.
2. Microorganisms digest the valuable nutrients contained within the organic matter.
3. Renewable energy and organic fertiliser is produced!

TERMS & CONDITIONS.

- We record your credit card at the time of booking in our secure online portal. This acts as your deposit and security guarantee.
- Full payment of the venue hire fee is due on the day of your function.
- Any bar tabs must be either prepaid or paid in full on the night, or we withhold the right to charge your credit card.
- Decorations can only be used if free standing and must be approved by your Function Manager prior to your event. We do not allow anything to be attached to the walls either inside or outside - no glue, sticky tape or blue tack please.
- Confetti/Confetti balloons, streamers, glitter and party poppers are strictly NOT ALLOWED inside the venue and are subject to cleaning charges if brought in.
- Grazeland is a sustainable site and therefore no single use plastic a sustainable venue and as such we do not allow single use plastics on site. (Straws, balloons, plastic plates or glasses etc)
- Cleaning charges of \$100 will apply to your credit card if you do not clean up after your function. We allow a 30-minute grace period prior to your function to set up and 30 minutes post to pack down and clean up.
- NO BYO food or alcohol of any sort, including cakes. Desserts and beverages can be organized through our vendors via your Function Manager.
- The entire venue is licensed. There are 3 bars and Grazeland prides itself on the Responsible Service of Alcohol (RSA).
- Unduly intoxicated or disorderly persons, in accordance with the Responsible Service of Alcohol (RSA), will be refused service and may be asked to leave the premises.
- As the Hirer or Organizer of the Event/Function, you are responsible for any damage caused by you or your guests to the Venue. Any such damage will be charged to the Hirer/Organizer.

Conditions of entry

Entry to Grazeland, 20 Booker Street, Spotswood VIC 3015 is subject to the following conditions:

Management reserves the right to refuse entry to any person, and to remove from the premises, without refund, any person who violates any of the conditions listed below. We also reserve the right to inspect any bag and/or articles of clothing via screening equipment and/or bag search checks.

These conditions of entry are subject to change without notice.

1.0 Acceptance of Risk and Limitations of Liability

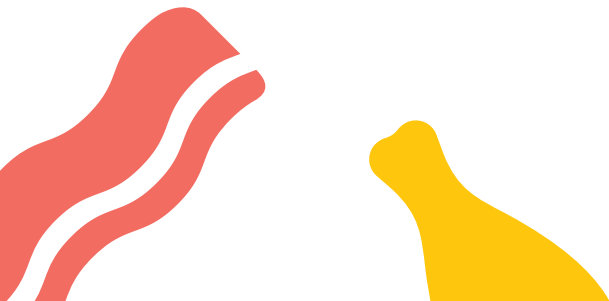
Patrons entering Grazeland do so at their own risk. Patrons assume all risks associated with and incidental to Grazeland, whether before, during or after Grazeland. This includes property damage or loss, and personal injury. Patrons waive any claims for personal injury or death against the Venue Owners on behalf of the patron and any accompanying minor(s); except those claims excluded by law.

2.0 Admission & Entry Fee

Venue owners or their management and/or security reserve the right to refuse admission to, or remove any person for reasonable cause, without notice. Persons under the age of 12 must be under direct supervision of an adult at all time. Persons under the age of 18 must be accompanied by a parent or legal guardian.

Management and/or security reserve the right to inspect a patron's bag(s) prior to entry. Footwear must be worn at all times.

Entry fee is non-refundable, and a non-refund policy applies. This includes any refunds due to change in weather on the day of attendance or if you are ejected for any reason in accordance with our conditions of entry. Entry fee applies to all patrons 12 years and older. Carers accompanying a person with a disability will not be charged an entry fee.



3.0 Refusal of Entry and Ejection

Venue Owners, appointed management or security reserve the right to refuse entry or eject patrons for the following reasons:

- a. If a patron is unwell at the venue and displaying flu-like symptoms
- b. Anyone who intentionally coughs, sneezes or spits.
- c. Patrons who act in a manner that is inappropriate, offensive to others or illegal
- d. Patrons that behave in a manner which causes or may cause property damage or that threatens or may threaten the safety of customers, performers or other persons
- e. Patrons who wear clothing that includes inappropriate symbols or wording that causes offence
- f. Any person who are unduly intoxicated may be refused entry or ejected
- g. Any person demonstrating disorderly behavior or displays harmful or offensive behavior may be refused entry or ejected
- h. Any person who is rude or aggressive to any other person including staff

4.0 Items not permitted at Grazeland

Patrons to Grazeland CANNOT bring the following items into the park:

- Plastic Bottles are not allowed within Grazeland
- Weapons of any kind or any other items deemed dangerous by management
- Water pistols, whistles
- Fireworks, flares or laser lights
- Drones of other flying craft
- Motorised toys or equipment
- Skateboards, inline skates or roller skates, or any similar devices
- Any device or object in the opinion of management has the potential to cause injury or public nuisance
- Bicycles are not permitted inside Grazeland. There are 100 bicycle racks conveniently located at the front gate.
- Food that you have brought elsewhere, exception to baby food or formula
- Promotional or marketing materials not approved by Management
- Balloons, Confetti, Streamers, Glitter, Party Poppers and single use plastic items

5.0 Smoking

Smoking is strictly prohibited anywhere within Grazeland and the surrounding perimeter including both entrances. This includes electronic cigarettes.

6.0 Alcohol and drugs

- a. Patrons must not bring drugs or alcohol into Grazeland
- b. Alcohol must be consumed within the area of Grazeland ('the permitted area') and is not permitted to be taken outside the venue.
- c. Any person wishing to drink alcohol at Grazeland may be required to produce a valid driver's license, current passport or proof of age card.
- d. Any minor found drinking alcohol will be refused entry or ejected from Grazeland.
- e. Any person supplying alcohol to a minor or deemed to be assisting or contributing to the supply of alcohol to a minor will be refused entry or ejected from Grazeland.
- f. Any person demonstrating disorderly behavior may be refused entry or ejected from Grazeland.

7.0 COVID Safety and Compliance

Grazeland is a COVID Safe venue. Failure to comply with any government guidelines, State directives or legislation with regards to COVID-19 or any other relevant health directives may result in the patron being refused entry or ejected from Grazeland.

Failure to follow any direction from the venue staff related to COVID protocols may result in your ejection from the venue.

8.0 Animals/Pets

All pets are welcome at Grazeland but they must be people friendly. All pets must be on a short leash and you must be able to carry them should you choose to go into a congested area. Accidents must be cleaned up immediately and there will be some designated pet free areas. All artificial turf areas are no-go zones for pets. You must accept full responsibility for your pet. pets are not permitted from 7pm.

9.0 Use of Your Image

Patrons agree not to record or transmit, or aid in recording or transmitting, any description, account, picture or reproduction other than for private non-commercial purpose, without the permission from the venue owners.

Patrons, by their actual attendance grant permission to Grazeland and the venue owners to use their name, image, likeness, or statements in any live or audio, video or photographic display or other transmission, exhibition, publication or reproduction made of, or at Grazeland without further authorization form, or compensation or attribution to the patron. All recordings and photographic displays are our sole property and you release us from liability arising on account of such usage.

10.0 Change of activities

Grazeland reserves the right to add, withdraw or substitute performing artists and amenities at any time.

Cancellation policy.

7 days prior - 50% of the full cost of the function will apply, including any pre-ordered food and beverage.

14 days prior - 30% of the full cost of the function will apply, including any pre-ordered food and beverage.

14 days and over - full refund except for major private events - see your customised contract for details.

All invoices must be paid in full at least 14 days prior to the function date. Grazeland Management reserve the right to cancel any function that has not been paid for in full and to retain any applicable cancellation fee.

In the unfortunate event that Grazeland cannot open due to extreme weather, damage to the venue or authorities will not allow the venue to open by the start time and day of your confirmed event, Grazeland will refund in full all venue hire fees and any prepaid pre-set bar tabs that have been previously paid by you. Other fees for hire of equipment, entertainment and professional services will be refunded less any cancellation fees that are charged by third party suppliers.

Force Majeure contract clause.

All of the covered buildings within the venue are still somewhat open to the elements and as such are not fully sealed from the weather especially during windy or storm related events. Please ensure you and your guests are prepared for such weather if forecast.

The safety of our patrons and staff is paramount. In the event of extreme weather, we may close the venue.

If this occurs, we will advise you and your guests as soon as practical. You and your guests may be directed to other sheltered areas within the venue. You and your guests may be asked to leave the venue if directed by emergency services and or event team management.

We will operate the Venue during inclement weather unless the Venue Manager in his sole discretion, or an appropriate regulatory authority, determines it is unsafe to do so and declares a Function or Events cancelled.

If the whole or any part of the infrastructure of the Venue is damaged due to a Force Majeure Event, we reserve the right to cancel a Function or Events until such time that the infrastructure is repaired and/or deemed safe.

If a Force Majeure Event occurs, we reserve the right to cancel a Function or Events until we in our sole and absolute discretion determine it is safe and appropriate to recommence conducting Functions and Events.

A Force Majeure Event could include but is not limited to an Act of God, Physical Damage to the Premises, a Pandemic or Public Health Outbreak or Federal, State, Local Authorities closing the Venue or cancelling Operational License's.

We reserve the right to cancel a Function or Event at our sole and absolute discretion if for any reason the Venue cannot open.
