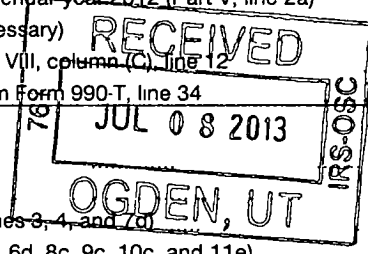

Program services for 2012 addressed the needs of the people in the Archdiocese of Gulu, Northern Uganda. Two main areas of emphasis were the Secondary Schools we have been supporting for years: Sacred Heart Seminary in Gulu and Archbishop Flynn Secondary School in Pader.

A Secondary School in Uganda has 6 grade levels (Senior 1 through 6). It can be compared to a Junior High and High School combined in the United States. The government of Uganda has made a commitment to its people to provide primary education (grades 1-8) to all children but does nothing about Secondary education. The government encourages NGOs

The young men who choose not to pursue a priestly vocation will move on to become architects, engineers, teachers, political leaders or a myriad of other occupations to serve their community.
