The mission of Hope For Uganda is to bring hope to the people of Northern Uganda through faith formation, quality education, improved health and food sustainability programs.

Hope For Uganda (HFU) provided financial assistance to 67% of the 142 young men attending Sacred Heart Minor Seminary (SHS) in Gulu, Northern Uganda to pay for tuition, room and board fees. HFU also provided financial assistance to 46% of the 467 students attending Archbishop Flynn Secondary School (AFSS) in Pader, Northern Uganda to pay for tuition, room and board fees. In 2017, the HFU board raised the money needed to purchase 261 acres of fertile farm land near AFSS with the goal of developing a Rural Development Education Center to grow enough food to feed the children, sell the excess crops to generate income, and to teach the students and local farmers modern agriculture methods to improve the productivity of their land. Finally, the David Fagerlee Medical Center was opened in July 2017 and offers Level 3 care to the poverty-stricken community in Adilang, Northern Uganda - with a focus on providing quality care for delivering babies and newborn training, as well as treating malaria, dysentery, snake bites, HIV/Aids and numerous other out-patient services.
