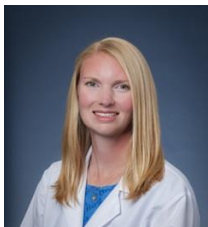

Dr. Frost is a Pediatrician and the Senior Director of the Center for Health Systems Research and Office of Research at Denver Health. She is an Associate Professor of Pediatrics at the University of Colorado. Her work focuses on using learning health systems to rapidly improve care for patients, antimicrobial stewardship, and best practices for management of common outpatient infections. She serves as a scientific advisor for CDC and the American Academy of Pediatrics for outpatient antibiotic stewardship and acute otitis media.



Jonathan L. Temte, MD, PhD, is Associate Dean for Public Health and Community Engagement at the University of Wisconsin School of Medicine and Public Health where he also serves as Professor of Family Medicine and Community Health. Dr. Temte served on the U.S. Advisory Committee on Immunization Practices from 2008-2015, becoming the first family physician to serve as chair from 2012 to 2015. He currently chairs the Wisconsin Council on Immunization Practices and is the AAFP representative on the ACIP Work Groups for COVID-19 vaccines and RSV vaccines. Dr. Temte has a long history of building bridges between public health and clinical medicine. Since the start of the pandemic, he has been involved with COVID-19 response at campus, community, state and national levels.



Abbey Harburn, MPH, Director of Practice Transformation and Analytics. Abbey has been with WCHQ for 5 years, serving in a variety of roles. She oversees the Practice Transformation department which has been expanded to have an enhanced focus on providing additional information and actionable data, which is now feasible via our Data Voyager platform. Harburn holds a Master of Public Health Degree from the University of Wisconsin School of Medicine and Public Health and a bachelor's degree in political science from Wellesley College.
