



**TURKEY:** In October 2021, Turkey ratified The Paris Agreement and in December 2021 the Education Minister announced the Government will start implementing Climate Education at the start of 2022. These outcomes came from the pressure placed by delegates who received over **33,000 signatures** for their climate education petition, campaigned for the ratification of the Paris Agreement, and shared the Treaty with the President, Minister of Environment, Minister of Foreign Affairs, Mayor of Istanbul and other key officials.

**CANADA:** Delegates engaged with the Minister of Climate Change, and have been focusing on **policy 2.4 on ecocide law**. They have collaborated with Stop Ecocide Canada along with their own outreach.

**ECUADOR:** been reaching out to Minsiters and Government officials, and **engaging youth in universities** to support the implementation of the treaty.

**NIGERIA:** In November 2021, President Muhammed Buhari signed the **Nigeria Climate Change Bill** into law after over six months of campaigning and lobbying from youths and civil societies. As part of this, delegates met with, and presented the Mock COP26 treaty to Hon. Samuel Ifeanyi Onuigbo, the previous chairman of the Climate Change Committee and the Minister of State for Environment Hon. Sharon Ikeazor. Delegates who agreed to new opportunities for young people to engage in action for the climate crisis. They are also lobbying the Federal Ministry of Education around on climate education.

**BANGLADESH:** Signed the Glasgow Leaders' Declaration on Forests and Land Use at COP26, pledging to end and reverse deforestation by 2030; cancelled 10 coal-based power plants with a hope to have 40% of energy from renewable sources by 2041; is implementing the 'Mujib Climate Prosperity Plan' - with an aim of accelerating adaptation and resilience actions. These actions came after **months of campaigning from Mock COP delegates**, who had previously had a meeting with Mr. Shamim Al Raji, Additional Secretary, Ministry of Environment, Forest and Climate Change of Bangladesh. He showed support for implementing Mock COP the treaty, taking the implementable policies to the highest government level, and offered tp help youths engaged in climate related works.

**CHILE:** developed a project with other Chilean organizations to work towards the **real Chilean youth participation** in international climate conversations.

**INDONESIA:** Trying to **file a petition** for Climate Education.

**KENYA:** During an NDC Consultation, **the Mock COP Treaty was shared** with an official from the Kenyan Ministry of Environment and was presented during "The Last 20 forum", a forum that discussed the concept of G20.

**PAPUA NEW GUINEA:** **Regular engagement and meetings** with Minsiter for Education, Hon. Jimmy Uguro, MP and his team, to drive climate education. Delegates also had a meeting with Climate Change and Development Authority and presented the Treaty to the Minister for climate change where support was gained for implementation.

**NEPAL:** Submitted the Mock COP26 Treaty to the Climate Change Management Division in person, and are **engaging with experts and local organizations** for support in lobbying and implementing the treaty.

**LESOTHO:** Letters and copy of the **treaty sent to Ministers** and meetings organised.

**UK:** The **Climate Education Bill** has passed its first reading in Parliament. This has come from months of lobbying from delegates with letters sent to the Prime Minister and government ministers and a meeting with the Secetary of Education. Delegates also had a meeting with Alok Sharma, have regular meetings with cabinet office COP26 team.

**BRAZIL:** Reunited at COP26, the delegation decided to **write a letter to the Brazilian Senate Environmental Committee** with a specific focus on climate policy and climate education.

**ICELAND:** Delegates **handed the Treaty to the Prime Minister** when meeting to talk about climate change, and have been specifically advocating for nature in certain cases.

**GUINEA:** Delegates have been reaching out to Government Ministers to **arrange a meeting**.

**LIBERIA:** Launched the **African Climate Education Toolkit** aiming to promote climate education in Liberia and Africa. They also hosted Post COP26 event title; Youth Post COP26 & Nationally Determined Contributions: the perspectives of the young people.

**SINGAPORE:** **Sharing session** on SG's strategies for climate action and sustainable development.

**JAPAN:** **Met with the Ministry of Environment** to introduce the Treaty, with an aim to formalise a meeting with the Minister of Environment. Future Earth Japan Hub are supporting Mock COP's implementation of the Treaty through providing academic support.

**FINLAND:** Finland committed to protecting 30% of the land and 30% of the water sector by 2030; the Ministry has talked about incorporating justice into the law; and the Adaptation Strategy is being reformed with adaptation also being taken into account in other legislation. These agreements came after **Mock COP delegates contacted and had meetings with the Minister of Climate and Environment and the President's advisors**. Delegates had spent months implementing their campaign plan to go te every constituency ahead of elections, developing a website and social media, securing funding and running a Youth Conference on Climate and Biodiversity which featured on the evening news in Finland where delegates explained the Mock COP26 Treaty.
