Over the past fiscal year which ended in March of 2021, Kathryn Bliss, Lisa Joly, along with Nikki McCarthy and Sandie Lessard, have worked diligently to support CoSA sites across the country while working to meet the reporting requirements of our Public Safety funding and being responsive to the needs of their local communities and core members in the midst of a national pandemic. There has been an immense amount of courage, resiliency and creativity on the part of everyone to ensure that we are continuing to live out our vision of "no more victims" and "no one is disposable". Technology, outdoor meetings, phone calls, virtual coffee times and the list could go on have all been used as a way to build and maintain connections and have both supportive and challenging conversations even in the midst of limitations and restrictions.

In December of 2020, we acknowledged and celebrated the work of Pat Love as our recipient of the CoSA Canada award of distinction. The zoom recognition event was truly a celebration of an incredible woman and her contribution to the CoSA community across the country. And second, in late March of 2021 our application to the CRA for charitable status for CoSA Canada was accepted, enabling us to receive donations and offer tax receipts. 

## COSA CANADA AWARD OF DISTINCTION

This CoSA Canada Award of Distinction was created in honour of long time CoSA volunteers, Les Horne and Malcom Savage, to celebrate those who have made significant contributions to the work of CoSA in Canada and a way of acknowledging those who grew the vision for this work into the national and international network that it is today. CoSA Canada was honoured to present the first award to Harry Nigh in 2019, who was central in establishing the first circle in 1994 and continues today to represent the strong values, passion and commitment that underlie the work of CoSA in Canada.

The 2020 Award recipient, Patricia Love, is being recognized for her work in the founding CoSA Ottawa, which operates Circles of Support and Accountability in the Ottawa area. Patricia had a career as a Probation officer in Peterborough before returning to Ottawa in the late 1980s. Through her association with St. John the Evangelist Church in downtown Ottawa, she learned of the CoSA model and the work of Harry Nigh, as the church looked to support an individual within their congregation. Drawing on her experience and through collaboration with other CoSA sites emerging around the country, the Ottawa project swiftly developed.




### COSA CANADA AWARD OF DISTINCTION

In 2001 funding was received to hire the first part-time coordinator, and in 2013 CoSA Ottawa became a registered charity. Since its inception, of the 70+ clients who have been involved in CoSA in Ottawa, only one has been convicted of a subsequent sexual offence. It was through the strong, compassionate early leadership of Patricia that the organization has continued to persevere during many challenging times. Throughout the past twenty years, CoSA Ottawa has developed a strong reputation not only locally but internationally and has been recognized for the significant contribution it provides in keeping its community safe.
