The Company is committed to protecting the privacy of its users and Members and we respect the rights of our users worldwide. - 1. Types of Personal Information that Company Collects from Site Users and Members
 - 1.1. Who is collecting and receives your Personal Information: For information on who receives Personal Information, please see the Company's current Privacy Policy below.

Right of access and right to rectification: Users and Members have the right, via postal mail, email, or telephone, to request that Company provide you with a summary of any Personal Information retained by Company that has been voluntarily provided by you through online forms, registration forms, surveys, email, or another online avenue. You may modify, correct, change or update your Personal Information by contacting the Company via postal mail, email, or telephone at the addresses or number listed below.
 - 4.1.2. Right of portability: Users and Members have the right to request their Personal Information be ported to another controller (a controller being someone who determines the purposes and means of processing Personal Information).
 - 4.1.3. Right to be forgotten: Users and Members have the right to erasure of their Personal Information upon request.
 - 4.1.4. Extra safeguards: Users and Members have the right to extra safeguards if sensitive information is being processed (e.g., health, race, sexual orientation, religion, and political beliefs).
 - **4.2.** How to exercise one of these rights: Contact the Company's Data Protection Officer listed below. If you reside in the European Union, the Company is the controller of your Personal Information for the purposes of the GDPR.
- 5. Your Consent: Controls and Choices
 - 5.1. When a visitor performs a search within the Site, Company may record information identifying the visitor or linking the visitor to the search performed and recording information related to the search request. Company may place Internet "cookies" on your hard drive. Internet cookies are small amounts of data that contain a unique identifier that many websites frequently send to your web browser to be stored on your computer's hard drive in order to save data about you, such as your name, password, username, screen preferences, and the pages of a website you have viewed. When you revisit the Site, the Company may recognize you by your Internet cookies and customize your experience accordingly. Company may use Google Analytics or a similar service to gather, store, and track certain information related to your visit to and activity on the Site.

 - 1.1. Who is collecting and receiving your Personal Information:
 - 1.1.1. The Company collects and receives your Personal Information. The Company only requests users and Member Personal Information in order to provide the information and services requested by the user and/or Member with their consent. Those services requested by users and/or Members provided by the Company may include information and news on the Company and related matters, event registration, etc. The Company does not sell, market, or provide any user or Member data to third parties for any other purposes.
 - 1.2. Why we collect Personal Information
 - 1.2.1. The Company is a Unified Communications as a Service Platform (UCaaS); therefore, the Company collects Personal Information in order to establish connections between users and/or Members when requested such as in the case of The Gig RoomTM sessions. The data collected is also used to prevent unwanted parties from entering secure The Gig RoomTM sessions.

- 3. How We Collect and Retain Your Personal Information
 - 3.1. How we collect your Personal Information:
 - 3.1.1. The Company collects cookies when you visit the site. Cookies may be turned off by the user. The Company also collects information from you when you enroll as a Member of the Company, and further when you voluntarily complete the optional Member profile information.
 - 3.2. Retention of your Personal Information:
 - 3.2.1. The Company retains Personal information for the purposes of search optimization, tag recognition, and to meet Member and/or user experience expectations and therefore keeps the Personal information. If the Company finds that Personal Information collected is no longer necessary for its purposes, it will delete the Personal Information.

- 1. The Types of Personal Information the Company Collects from Children
 - 1.1. Email Address

- **1.5.** The Site allows a Child to post videos of musical performances, however a Child is only allowed to post these videos privately. The Site does not allow a Child to post public videos of a musical performance.
- 2. How the Company Collects and Uses Personal Information Collected from Children
 - 2.1. Where authorized by the parent under the Company's Children's Online Privacy Policy, the Company collects Personal Information from the Child;
 - 2.2. The Company uses the Personal Information collected from the Child to validate user authenticity, to process Gig Room invitations, to make information publicly available through a chat room, for search engine customization, and tags for video sorting.
 - **2.3.** Below is a list of third party operators who collect Personal Information from the Child as part of the Company's services in order to establish peer-to-peer connections used by the Gig Room feature.
 - 2.3.1. Twilio
- 3. Parental Rights, Controls and Choices
 - **3.1.** The Company will not require a Child to disclose more information than is reasonably necessary to participate in an activity;
 - **3.2.** A parent of a Child can agree to the collection and use of their Child's Personal Information, but still not allow disclosure to third parties unless it is part of the Company's services; and,
 - **3.3.** A parent of a Child has the following controls and choices regarding their Child's Personal Information;
 - 3.3.1. A parent can review their Child's Personal Information;
 - **3.3.2.** A parent can direct the Company to delete their Child's Personal Information; and,
 - **3.3.3.** A parent can refuse to allow any further collection or use of the Child's Personal Information;
 - **3.4.** In order to exercise any of the aforementioned rights, please contact the Company using the information listed below in Section 6.
- 4. Direct Notice to Parents
 - 4.1. COPPA requires that companies give parents of a Child direct notice ("Direct Notice") of the Company's information practices before collecting information from a Child. In addition, if the Company makes a material change to our practices previously agreed to by a parent, the Company will send an updated Direct Notice. The Company's Direct Notice to parents will state the following:
 - 4.1.1. that the Company collected their online contact information for the purpose of getting their consent;
 - 4.1.2. that the Company wants to collect Personal Information from their Child;
 - 4.1.3. that their consent is required for the collection, use, and disclosure of the Personal Information;
 - 4.1.4. the specific Personal Information the Company wants to collect and how it might be disclosed to others;
 - 4.1.5. a link to the Company's online privacy policy;
 - 4.1.6. how the parent can give their consent; and
 - 4.1.7. that if the parent doesn't consent within a reasonable time, the Company will delete the parent's online contact information from its records.

- 5. Verifiable Consent
 - 5.1. Before collecting, using, or disclosing a Child's Personal Information, the Company will obtain "verifiable consent" from the parent through email verification known as the "email plus" method. Parents will have the option of allowing the Company to collect and use the Child's Personal Information without agreeing to disclose that information to third party operators. If the Company makes changes to the collection, use, or disclosure practices that a parent has agreed to, the Company will send the parent a new notice to get their consent.
