
1. Who we are?

We are Monetise Pte. Ltd. ("Fewcents", "Fewcents," "Fç", "we," "us" or "our"). Fewcents enables the sale and distribution of digital goods by online publishers to end users ("users" or "you"). Fewcents also facilitates the management and payment of subscription services. As used in this agreement, the term "Publisher(s)" refers to providers of digital goods available for purchase via Fewcents, as well as recipients of voluntary payments processed by Fewcents.

Fewcents is based at 700 Lor 1 Toa Payoh, #10-14, Singapore 319773. This Privacy Policy addresses use of personal data by Fewcents. This Privacy Policy explains how we and some of the companies we work with collect, use, share and protect information in relation to our services, web site, and any software provided on or in connection with Fewcents, and your choices about the collection and use of your information.

This Privacy Policy applies to all visitors, end users, and others who access Fewcents. By using Fewcents Service, you understand and agree that we are providing a platform for access to digital goods, including, but not limited to, digital information such as, audio, photographs, videos, articles, documents, online games and other materials.

2. Information we collect.

We collect the following types of information.

Information you provide to us directly:

- Your first and last name, password, email address, a reference number that can be associated with your payment details, your purchase history (if any) and login data, which you provide when you register for a Fewcents account. When you sign up for our newsletter, we collect your name, email address, industry and company.
- Communications between you and Fewcents. For example, we may send you Fewcents Service related emails (e.g., account verification, changes/updates to features of Fewcents, technical and security notices). You may send us comments, questions or requests.
- Additional details related to your use of the services, including a record of your agreement to Fewcents legal terms, term of subscription and renewal periods, contents of your shopping basket (if any), preferred billing method, user account details or credit card details or other terms of payment.

Information you provide to us indirectly:

Fewcents collects additional data from you while you interact with Fewcents systems, as explained in more detail immediately below.

- **Analytics information:** Fewcents uses third party services to help us measure traffic and usage trends both on our website and on our Publisher websites. These tools collect information sent by your device or by our service to you, including the web pages you visit through Fewcents,

add-ons, your anonymized IP address, and other information that assists us in gathering feedback to improve Fewcents and our business model. We collect and use this analytics information together with analytics information from other users so that it cannot reasonably be used (and is not used) to identify any particular individual user.

- **Cookies and similar technologies:**

- When you visit Fewcents, we may use cookies and similar technologies like pixels, web beacons, and local storage to collect information about how you use Fewcents and provide features to you. Cookies are small files that make it easier for you to use content from the Publishers that use Fewcents. Your Internet browser automatically receives these files from our servers and then saves the cookies on your computer. Fewcents uses what are known as session cookies and persistent cookies. We send several persistent cookies to your computer. Among other things, cookies allow you to access Internet content across different websites.
- You can change the settings on your browser so that it informs you when it accepts a cookie, or so that it does not accept any cookies at all.
- We recommend that your browser be set to accept cookies from Fewcents, as only then will you be able to use Fewcents Services.

- **Log file information:** Log file information is automatically reported by your browser each time you make a request to access (i.e., visit) a web page or app. It can also be provided when the content of the web page or app is downloaded to your browser or device. When you use Fewcents, our servers automatically record certain log file information, including your web request, IP address, browser type, referring / exit pages and URLs, number of clicks and how you interact with links on Fewcents, domain names, landing pages, pages viewed, and other such information. We may also collect similar information from emails sent to our users, which then help us track which emails are opened and which links are clicked by recipients. The information allows for more accurate reporting and improvement of Fewcents Services.

- **Browser Fingerprint:** Your browser contains information about your browser version, program language, individually installed plug-ins (i.e., small programs or program extensions). The individual fingerprints are all different from one another, like human fingerprints. Browser providers or installed plugins can retrieve (or read out) this information in order to, for example, inform you when a new software is available to you. These “fingerprints” enable us to identify you when you are trying to make a purchase, restore your access to a previous purchase and merge historical activity.

3. How we use your information

In addition to uses of information we describe elsewhere in this Privacy Policy, we use your data to do the following:

Enable Fewcents Service:

-
- For both visitors and registered users, we use browser fingerprint information to determine which device is employed to access Fewcents content. This allows us to know what content you have accessed and whether you have created an account, so that we can restore access to a previous purchase or link historical activity. We process your data, including your name, email address and payment information to carry out the transactions that you initiate when you use Fewcents Service as an account-holding user. We further review a range of user data, including log files, IP addresses and email addresses, and purchase information in order to improve Fewcents product, trouble-shoot and track issues with Fewcents platform, and identify areas for improvement.
 - We use your personal data to communicate with you about the services we provide. For instance, for subscription service users, we use your contact information to notify you that your subscription will automatically be renewed soon or has expired. We also use user and transaction data to handle support requests from users or Publishers, including investigating a transaction or issuing a refund.
 - In order to make sure our Publishers get paid, we engage in a settlement process. During this process, our payment service provider consults user data, including name, amounts owed and currency information and makes net payments to our Publishers.

Analyze user behavior:

- We perform statistical and other analysis of your activities related to Fewcents, including which digital content you access, at what times and frequency. We do this to gain a better understanding of how our services are used so that we can provide you with a better, more intuitive and personalized experience and offer new products and services that may interest you.

Marketing:

- With your consent, Fewcents will use your data for marketing purposes, including to communicate with you about products, services, and other organizations and activities that may interest you. In order to tailor these communications, we evaluate your Fewcents activities, often by using automated processing. The results of these evaluations enable us to offer you discounts, for instance, on services similar to those you have demonstrated an interest in. In the course of using your data for marketing purposes, we will not, under any circumstances, forward it to third parties without your consent. You may opt out of being included in marketing communications by contacting us as explained in Section 9 below.

4. How we share you information

We will not share your information with third parties outside Fewcents or its Affiliates (defined below) except as noted in this Privacy Policy or with your explicit consent.

Parties with whom we may share your information:

- Fewcents shares your data with its Publishers for the purposes of fulfilling the services. This includes anonymized purchase information, subscription terms information and renewal periods.

- Fewcents shares limited information with Publishers, including your name, email address and default currency, as well as transaction details, including item purchased, purchase date, and similar, only after you have conducted a transaction with that specific Publisher. Publishers may use this data to inform you by email or digital advertising of their products and/or services that might be of interest, i.e. for marketing purposes, or for the fulfillment of their services. Publishers are not permitted to share your data with any third parties. Additionally, Fewcents may share the results of analysis of user behavior described above with Publishers and other Affiliates of Fewcents.
 - We may share certain information regarding Fewcents content and/or your information (including but not limited to, information from cookies, log files, device identifiers, location data, and usage data) with businesses that are legally part of the same group of companies that Fewcents is part of, or that become part of that group ("Affiliates"). Affiliates may use this information to help provide, understand, and improve Fewcents (including by providing analytics) and Affiliates' own services (including by providing you with better and more relevant experiences).
 - We also may share your information, including information from tools like cookies, log files, and browser fingerprint information, with payment service providers, hosting providers, Google Analytics and other third-party organizations that help us provide Fewcents to you ("Service Providers"). Our Service Providers will be given access to your information as is reasonably necessary to provide Fewcents with their services, under data processing agreements that require them, among other things, only to act on Fewcents' instruction and to take sufficient technical and organizational measures to safeguard your data.

What happens in the event of a change of control:

- If we sell or otherwise transfer part or all of Fewcents business, or our assets, to another organization (e.g., in the course of a transaction like a merger, acquisition, bankruptcy, dissolution, or liquidation), your information may be among the items sold or transferred. The buyer or transferee would be obligated to honor the commitments we have made in this Privacy Policy.

Responding to legal requests and preventing harm:

- We may access, preserve and share your personal data in response to a legal request (like a search warrant, court order or subpoena) if we have a good faith belief that a law, regulation, or governmental request requires us to do so. This may include responding to legal requests from jurisdictions outside of Singapore where we have a good faith belief that the response is required by law in that jurisdiction, affects users in that jurisdiction, and is consistent with internationally recognized standards. We may also access, preserve and share information when we have a good faith belief it is necessary to: detect, prevent and address fraud and other illegal activity; to protect ourselves, you and others, including as part of investigations; and to prevent death or imminent bodily harm. Information we receive about you may be accessed, processed and retained for an extended period of time when it is the subject of a legal request or obligation, governmental investigation, or investigations concerning possible violations of our terms or policies, or otherwise to prevent harm.

5. How we store your information

Storage and Processing:

- Your information collected through Fewcents may be stored and processed in Singapore or any other country in which Fewcents, its Affiliates or Service Providers maintain facilities.
- Fewcents, its Affiliates, and/or Service Providers may transfer information that we collect about you, including personal information, across borders and from your country or jurisdiction to other countries or jurisdictions around the world. If you are located in the European Union or other regions with laws governing data collection and use that may differ from Singapore law, please note that we may transfer information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction. Regardless of where your information is processed, we apply the same protections as are described in this Privacy Policy. In instances where data is transferred, we ensure a sufficient level of protection for the rights of data subjects based on the adequacy of the receiving country's data protection laws, contractual obligations on the recipient of the data, or privacy shield principles.
- We use commercially reasonable safeguards to help keep the information collected through Fewcents secure and take reasonable steps (such as requesting a unique password) to verify your identity before granting you access to your account. However, Fewcents cannot ensure the security of any information you transmit to Fewcents or guarantee that information on Fewcents may not be accessed, disclosed, altered, or destroyed.
- You are responsible for maintaining the secrecy of your unique password and account information, and for controlling access to emails between you and Fewcents, at all times. We are not responsible for the functionality, privacy, or security measures of any other organization.

6. Your choices about your information

You are entitled to make choices about our handling of your data, from deleting or correcting data you include in your profile to opting out of advertising and other communication controls.

For personal data that we have about you:

- **Delete Data:** You can ask us to delete all or some of your personal data (e.g., if it is no longer necessary to provide Fewcents Services to you).
- **Change or Correct Data:** You can edit some of your personal data through your account. You can ask us to update your data in certain cases, particularly if it's inaccurate.
- **Object to, or Limit or Restrict, Use of Data:** You can ask us to stop using all or some of your personal data (e.g., if we have no legal right to keep using it) or to limit our use of it (e.g., if your personal data is inaccurate or unlawfully held).
- **Right to Access Your Data:** You can request a copy of your personal data.

If you have any questions, you may contact us using the contact information below.

We will only collect and process personal data about you where we have a lawful basis for doing so. Examples of lawful bases include consent (where you have given us consent for the processing, whether

by agreeing to this Privacy Policy, ticking a box in a dialogue window, both, or by another explicit method), contract (where processing is necessary for us to perform our contract with you, for instance, to deliver Fewcents Services) and “legitimate interests.” Where we rely on your consent to process personal data, you have the right to withdraw or decline your consent at any time. In those instances where we rely on legitimate interests, you have the right to object. If you have any questions about the lawful bases on which we collect and use your personal data, please contact us as set forth below.

How long we keep your data:

- **Retention:** We will retain your information as long as your account is active, as necessary to provide you with Fewcents Services or as otherwise set forth in this Privacy Policy. We will also retain and use this information as necessary for the purposes set out in this Policy and to the extent necessary to comply with our legal obligations, resolve disputes, enforce our agreements and protect Fewcents’ legal rights. We also collect and maintain aggregated, anonymized or pseudonymized information which we may retain indefinitely to protect the safety and security of our site, improve our services or comply with legal obligations.
- Your consent to the uses of your data outlined in this Privacy Policy are valid unless revoked.
- If you do not access your digital content or use Fewcents Service for a period of eighteen (18) months, Fewcents may delete your data. Fewcents may inform you three (3) months before the expiration of this deadline, and give you the opportunity to oppose this deletion.

7. Children’s privacy

Fewcents does not knowingly collect or solicit any information from anyone under the age of 18 or knowingly allow minors to register for Fewcents. Fewcents and its content are not directed at anyone under the age of 18. In the event that we learn that we have collected personal information from a child under age 18, we will delete that information as quickly as possible. If you believe that we might have any information from or about a child under age 18, please contact us at privacy@fewcents.co.

8. Other websites and services

Please remember that when you use a link to go from our service to another website or service, our Privacy Policy or other terms do not apply to those third-party websites or services. Your browsing and interaction on any third-party website or service, including those that have a link on our website, are subject to that third party’s own rules and policies.
