PRIVACY POLICY

We take your privacy very seriously. Please read this privacy policy carefully as it contains important information on who we are, how and why we collect, store, use, and share your personal information. It also explains your rights in relation to your personal information and how to contact us or supervisory authorities in the event you have a complaint.

By using our website, you signify your assent to our Privacy Policy. If you do not agree with this Privacy Policy, please do not use our site. Your continued use of this site following the posting of changes to these terms will mean you accept those changes.

We collect, use and are responsible for certain personal information about you. When we do so we are subject to various laws in the United States and the General Data Protection Regulation which applies across the European Union (including in the United Kingdom), and we are responsible as "controller" of that personal information for the purposes of those laws.

1. **Key Terms.** It would be helpful to start by explaining some key terms used in this policy:

2. **Personal Information We Collect About You.** We may collect and use the following personal information that identifies, relates to, describes, is reasonable capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household:

This personal information is required to provide our products and services to you. If you do not provide personal information we ask for, it may delay or prevent us from providing products and services to you.

- 3. **How Your Personal Information is Collected.** We collect most of this personal information directly from you—in person, by telephone, text or email and via our website. When You participate in a Module, behavioral data is collected as a part of the service offering to Subscriber.
- 4. **How and Why We Use Your Personal Information.** Under data protection law, we can only use your personal information if we have a proper reason for doing so, e.g.,:
 - To comply with our legal and regulatory obligations;
 - For the performance of our contract with you or to take steps at your request before entering into a contract;
 - For our legitimate interests or those of a third party; or
 - Where you have given consent.

A legitimate interest is when we have a business or commercial reason to use your information, so long as this is not overridden by your own rights and interests.

The above table does not apply to special category personal information, which we will only process with your explicit consent.

5. **Promotional Communications.** We may use your personal information to send you updates by email, text message, telephone or post about our products and services, including exclusive offers, promotions or new products and services.

We have a legitimate interest in processing your personal information for promotional purposes (see above "How and why we use your personal information"). This means we do not usually need your consent to send you promotional communications. However, where consent is needed, we will ask for this consent separately and clearly.

We will always treat your personal information with the utmost respect and never sell or share it with other organizations outside the eTrain group for marketing purposes.

You have the right to opt out of receiving promotional communications at any time by:

We may ask you to confirm or update your marketing preferences if you instruct us to provide further products and/or services in the future, or if there are changes in the law, regulation, or the structure of our business.

- 6. Who We Share Your Personal Information With. We routinely share personal information with:
 - Our affiliates, including companies within the eTrain group;
 - If You are using a Module, we will share the data we collect with Subscriber per the terms of the Agreement with Subscriber as a part of our service offering.
 - Other third parties we use to help us run our business, such as marketing agencies or website hosts;
 - Third parties approved by you, including social media sites you choose to link your account to or third-party payment providers;

We only allow our service providers to handle your personal information if we are satisfied they take appropriate measures to protect your personal information. We also impose contractual obligations on service providers relating to ensure they can only use your personal information to provide services to us and to you. We may also share personal information with external auditors, e.g. in relation to ISO or Investors in People accreditation and the audit of our accounts.

We may disclose and exchange information with law enforcement agencies and regulatory bodies to comply with our legal and regulatory obligations.

We may also need to share some personal information with other parties, such as potential buyers of some or all of our business or during a re-structuring. We will typically anonymize information, but this may not always be possible. The recipient of the information will be bound by confidentiality obligations.

- 7. **Personal Information We Sold or Disclosed for a Business Purpose.** We do not sell or disclose Personal Information to unidentified third parties for any business purpose. Any information that is collected through the participation and use of our Modules is disclosed to Subscriber as a part of the Agreement between us and the Subscriber.
- 8. Where Your Personal Information is Held. Information may be held at our offices and those of our affiliates, third party agencies, service providers, representatives and agents as described above (see above: "Who We Share Your Personal Information with").
- 9. How Long Your Personal Information Will Be Kept. We will keep your personal information while you have an account with us or while we are providing products and/or services to you. Thereafter, we will keep your personal information for as long as is necessary:
 - To respond to any questions, complaints or claims made by you or on your behalf;
 - To show that we treated you fairly; or
 - To keep records required by law.

We will not retain your personal information for longer than necessary for the purposes set out in this policy. Different retention periods apply for different types of personal information.

When it is no longer necessary to retain your personal information, we will delete or anonymize it.

10. Your Rights Under the GDPR.

You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt-out of the sale or disclosure of your personal information. If you exercise your right to opt-out of the sale or disclosure of your personal information, we will refrain from selling your personal information, unless you subsequently provide express authorization for the sale of your personal information. To opt-out of the sale or disclosure of your personal information, contact us at the email provided in Section 13 How to Exercise Your Rights.

Please be advised that the only way to optout of the disclosure of your personal information to Subscriber is to not use our service offerings and not participate in our Modules.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.
- Please note that we may not delete your personal information if it is necessary to:
- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive,

	fraudulent, or illegal activity; or prosecute those responsible for that activity;
	 Debug to identify and repair errors that impair existing intended functionality;
	 Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
	 Comply with the California Electronic Communications Privacy Act;
	 Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
	 Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
	 Comply with an existing legal obligation; or
	 Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
Protection Against Discrimination	You have the right to not be discriminated against by us because you exercised any of your rights under the CCPA. This means we cannot, among other things:
	 Deny goods or services to you;
	 Charge different prices or rates for goods or services, including through the use of discounts or other benefits or imposing penalties;
	 Provide a different level or quality of goods or services to you; or
	 Suggest that you will receive a

different price or rate for goods or services or a different level or quality of goods or services.

Please note that we may charge a different price or rate or provide a different level or quality of goods and/or services to you, if that difference is reasonably related to the value provided to our business by your personal information.

- 12. **Keeping Your Personal Information Secure.** We have appropriate security measures in place to prevent personal information from being accidentally lost or used or accessed in an unauthorized way. We limit access to your personal information to those who have a genuine business need to access it. Those processing your information will do so only in an authorized manner and are subject to a duty of confidentiality. We continually test our systems and follow ISO 27001 guidelines, which means we follow top industry standards for information security. We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Any personal information we collect from you to verify your identity in connection with you request will be used solely for the purposes of verification.
