What data do we collect?

What are your data protection rights?

Brain Stimulation AB would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Brain Stimulation AB for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Brain Stimulation AB correct any information you believe is inaccurate. You also have the right to request Brain Stimulation AB to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Brain Stimulation AB erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Brain Stimulation AB restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Brain Stimulation AB's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Brain Stimulation AB transfer the data that we have collected to another organization, or directly to you, under certain conditions.

How do we use cookies?
