Neoliberal Fairness, Women's Sports and the Scientific Fundamentalism of Sex and Gender

In our moment of omnipresent media saturation, everyone's a scientist and a policy expert. This book examines the widespread public debates about the "fairness" of allowing trans girls and women and women with Disorders of Sexual Development (DSDs) to compete in amateur and professional sport. Media, individuals, sports governing bodies, and even the athletes themselves all proffer competing visions and definitions of sex and gender, and this project triangulates the rhetoric of sex and gender across multiple media domains to trace the emergence of a new scientific fundamentalism that hews to the ideology of T (testosterone) as determining sex. This fundamentalisms risks erasing the work of second wave feminism to parse gender from sex, and return to a new biologically reductionistic model of a sex binary. Rhetorical claims to prioritize "fairness" over "inclusion" replicate historical patterns of abuse and marginalization under these same words and ignore a historical record which shows how women's sports have never been fair or inclusive for those multiply marginalized; indeed, the scientific "evidence" used to defend women's sports is rooted in the exploitation and abuse of Black female bodies in the name of science.

Dissertation Abstract

Care of the Self: Gurdjieffianism as Modernist Cure

This project argues for the importance of Gurdjieffianism, a mishmash of mystical, occult, and New Age-y though, to literary and cultural modernism. It is also an excursus into the vexatiousness of material and psychological identity, sexed and gendered, interpellated by race and empire and the cataclysms of war (World Wars I and II but also the Russian Revolution and the Spanish Civil War). Through a study of Gurdjieff's influence on the personal praxes and public aesthetics of writers such as Margaret Anderson, Kathryn Hulme, Katherine Mansfield, Jean Toomer, and Leonora

Carrington, this book also examines writers who lived athwart to normativity and convention, in ways that liberal feminism and/or academic leftists might not particularly care for at the present moment, but who, in the context and stranglehold of the time in which they wrote and lived, nevertheless represent a rejection of the coherence of identity in terms of the compulsion to know and embrace of a self that is known by its active unfolding. These people sought an experience of self beyond the "prison-house of thought," that is, beyond the explicit and implicit mandate to norm and conform. This book looks at the lives and works of those who could not or would not norm and conform, and whose journeys away from conformity were routed through the particularity of Gurdjieffianism.
