Under the provisions u/s 80G(5)(i)(a) the institution/fund registered u/s 12A, u/s 12AA(i)(b) or approved u/s 10(23C), 10(23C)(vi)(via), etc., shall have to maintain separate books of accounts in respect of any business activity carried on and shall intimate this office within one month about commencement of such activity.
