Terms of Enrolment

- 1) A deposit of \$1000 is payable on the school's acceptance of the student. The deposit will be credited to the first term's fees when the student starts at Springbank School. No refund will be given if the student is accepted for enrolment but does not attend Springbank School.
- 2) An Activity Fee is set each term and is payable for such things as school camp, trips, visiting performers, academic competitions and subject-specific costs.
- 3) I/We accept responsibility to ensure that the Tuition Fees and Activity Fees are paid in full, prior to, or on the first day of each term. Notice of any tuition fee changes shall be given by the school managers at least one term in advance. (See School Enrolment where the student does not start or complete a full term).
- 4) In the event that your account becomes overdue and is referred to a collection agency and/or law firm, you will be liable for all costs incurred for debt to be collected in full.
- 5) A full term's notice in writing is required by the caregivers before the withdrawal of a student. Where insufficient notice is given, I/we agree to pay the equivalent of the next full term's tuition. For students not returning for the following year, written notice must be given by parents by the end of Term 3 of the current year.
- The student is subject to a high standard of conduct and discipline, and high expectations for learning. We accept the right of the school for any reason judged sufficient by it to require if necessary the withdrawal of the student after admission (See School Handbook for Discipline Policy and Procedure). If a student is withdrawn by the school before the end of a school term, no refund will be given for the remainder of the term.
- 7) My/our son/daughter has not been suspended, is not under suspension and has not been excluded or expelled from another school.
- 8) I/we have disclosed all information regarding any current or previous behavioural issues; and any current or previous academic concerns or limitations.
- 9) I/we give permission for staff to take photos of my child for educational purposes (displays, newsletters) and for promotional purposes (advertisements, brochures, website, social media).
- 10) Privacy Act: I/we accept that all information relating to the student will be used for school purposes and may only be released to outside agencies at the discretion of the school management.
- 11) I/we request that our son/daughter be enrolled at Springbank. I/we have read the following terms of enrolment and I/we will abide by these.
- 12) I/we declare that the information provided in this application is true and correct. I/we accept that any false, misleading, or undisclosed information may lead to cancellation of enrolment at any stage.
