Terms and Conditions

- 1. Member Fitness** - By signing this agreement, the Signer represents to Kim's Black Belt Academy that the student/s enrolled is physically and mentally fit to take classes offered by Kim's Black Belt Academy.
- 2. Fees and Charges** - Tuition cannot be prorated. Tuition must be paid whether student attends or not. There will be a \$10.00 late fee assessed for each day any unpaid balance is made passed the due day of Thursday. For extended camp hours, student/s are encouraged to be picked up by 6:30 pm unless they are participating in a class. There is a \$1.00 late fee per minute/per child

that will be assessed for late pick-ups. The fee is paid immediately to Kim's Black Belt Academy, upon pick-up of student/s. There will be no billing or invoicing for late pick ups. If payment is not received by the last day of the week, Student will not be picked up till payment is made in full. There will be a \$15 fee for a redeposit and/or a \$30.00 fee plus any applicable late fees on returned checks. Any balance will be sent to collections and/or disputed in small claims court. If this action is required the signer will be liable for court cost and an additional \$500 fee for time spent. My initials indicate that I have read and agree to all fees and charges Initial

3. Liability Waiver and Release - The Signer understands and agrees that the strict observation of the rules and regulations relative to training, including the use if protective equipment is required, and that the use of the facilities and the Students presence at the school are at the sole risk of the Signer. It is understood and agreed by the Signer that martial arts involves defensive and offensive skills and training which include violent and sudden movements, and that in connection with the training and instruction sessions, there will be physical contact between instructors and Students, also between and among the Students themselves, and that such contact may result in personal injury despite the best intentions and following adequate precautions. The Signer also understands and agrees that Kim's Black Belt Academy is not a daycare or a medical facility and if at any time required to administer any type of medical care i.e. Insulin shot or Epinephrine shot, shall not be responsible for and are hereby released from any liability. The Signer guarantees that the student/s is adequately covered by Medical Health Insurance in the event of a personal injury. The Signer agrees that Kim's Black Belt Academy and its instructors, agents, employees, operators, and authorized representatives, shall not be responsible for and are hereby released from any liability, claim, loss, including loss of property, damage, personal injury, or expense incurred by Student/s or anyone claiming through a Student, or relative to any activity connected with Kim's Black Belt Academy including but not limited to, any caused by the negligence or gross negligence of Kim's Black Belt Academy or its instructors, Students, agents, employees, operators, or authorized representatives.

4. Classes / Contact - Scheduling and content of classes and programs and furnishing of facilities and instructors are at the sole discretion of Kim's Black Belt Academy and may be changed from time-to-time. Kim's Black Belt Academy agrees to furnish the Student/s with qualified instructors to teach and supervise classes, practice sessions and contests conducted by Kim's Black Belt Academy. Signer understands that during the course of the instruction, Kim's Black Belt Academy instructors, authorized personnel, and/or other Students will be engaged in a course of conduct requiring physical contact with the Student. Signer gives full consent to such contact as is required by the training program and classes.

5. Holidays - The Signer understands that classes may not be held on national or local holidays, scheduled vacations or other times as directed by Kim's Black Belt Academy.

6. Co-signer - The person/s signing this agreement as a co-signer agrees to be jointly, severally and individually liable..

7. Acceptance of Member - Upon acceptance as a Student of Kim's Black Belt Academy, the Student/s agrees to faithfully comply with all provisions, terms and conditions hereof, including all rules and regulations of Kim's Black Belt Academy. Kim's Black Belt Academy reserves the right to immediately suspend or terminate any Student from participation or enjoyment of rights under this agreement for failure to comply with rules and regulations of Kim's Black Belt Academy. Suspension or termination of a Student shall not entitle the Signer to a refund credit for any tuition already paid or cancel any unpaid balance due.

8. Prorated Tuition – Kim's Black Belt Academy does not prorate tuition. Tuition must be paid whether student attends or not.

9. Summer Camp - Signer understands that language entered in this agreement also apply when Student/s attend Kim's Black Belt Academy Winter, Spring, and Summer Camp.

10. Transportation- For field trips and from time to time it may be necessary to transport student/s enrolled in Kim's Black Belt Academy to and from different events and/or activities. It

is expressly made a condition precedent to participation in Kim's Black Belt Academy that the student/s, parents, and/or guardian waives, releases, indemnifies and saves harmless Kim's Black Belt Academy, their employees, instructors, agents and/or partners from all claims of every kind of injury, loss or damage occasioned by Kim's Black Belt Academy instruction, its facilities, and/or equipment, including any and all activities and transportation associated with Kim's Black Belt Academy.
