Signal Person Refresher Syllabus

Time: 8 hours

Maximum Class Size: 12

Prerequisites: None

Course Description: Many different types of construction jobs involve working with cranes to hoist loads. This work is dangerous and can cause serious accidents or even fatalities. Crane operators, riggers and signal persons all need to follow safe work practices, including inspecting cranes regularly and using equipment properly. This 8-hour LIUNA Training and Education course refreshes participants on completing this dangerous work in a safe and efficient manner. In addition, students are updated on any regulatory changes that may have gone into effect since their last training session.

Goals/Objectives/Student Learning Outcomes:

- Describe some of the common errors that cause most crane and rigging accidents
- Describe and demonstrate six safe work practices for working with and around cranes and explain why each is important
- Using scenarios involving cranes working near power lines, give the minimum clearance between the crane and the lines based on OSHA standards
- Describe and demonstrate five safe work practices related to rigging and hoisting
- Identify seven types of rigging hardware and describe the functions of each piece of the hardware
- Describe eight types of sling configurations and identify the situation that each is used in
