IN 2019, WE WORKED WITH OUR MEMBERS TO EDUCATE THE PUBLIC ABOUT 240 ANTI-LGBTQ BILLS INTRODUCED IN THE STATE LEGISLATURES, AS WELL AS 9 TRANS RIGHTS BILLS, 10 BILLS MAKING HEALTH CARE MORE ACCESSIBLE AND 4 CONVERSION THERAPY BANS. IN 2019, WE LAUNCHED PROJECT GAME CHANGER, STARTING WITH 6 STATE-BASED
