TERMS OF SALE

1. **Terms are cash, etransfer, certified cheque, bank draft or wire transfers.** Personal cheques and/or business cheques will be accepted only when accompanied by an irrevocable letter of guaranteed credit from the bank stating buying limit and authorized by an officer of the bank. All other arrangements must be approved by senior management.
2. All bidders must have a bidders pass in order to bid.
3. All bidders must provide The Electric Garage Inc with proof of means to pay for any purchases. The Electric Garage Inc retains the right to request a \$500 CASH deposit.
4. All vehicles, or any other purchases, are sold "AS-IS" and without guarantees by The Electric Garage Inc. In no event shall the auction be responsible for any guarantees.
5. All statements by the Auctioneers and those statements printed in advertisements are believed to be correct; however, bidders are to examine all cars and other items before bidding and do so upon his or her opinion and examination.
6. The Electric Garage Inc is not responsible for correctness or year genuineness or any description of the vehicles.
7. All cars are offered for sale subject to reserve price set by the seller unless otherwise stated.
8. Ownership of an item passes to bidder when Auctioneer says "SOLD". At that time, the new owner assumes full responsibility of the item, including but not limited to insurance, damage, whether self-inflicted or by a third party, fire, theft or any other damage that should occur.
9. Should any dispute in a bid arise, the Auctioneer will use his judgement and his decision is final.
10. All vehicles must be removed from the premises by the purchaser at his own expense, no later than 12:00PM on Monday after the sale. If it is not removed, The Electric Garage Inc may remove and store the vehicle at the owner's risk and expense.
11. A purchaser's failure to comply with all of the conditions of sale entitles The Electric Garage Inc and the consignor to use other available remedies or courses of legal action to hold the purchaser liable. This may include the following:
 - a. Cancel the sale and retain as liquid damages all payments made by the purchaser.
 - b. Re-sell the property to a new purchaser at a private or public sale and in any such event the purchaser shall be liable for deficiency plus any incurred legal fees or court costs.
12. Delayed Payment Agreement:
 - a. I agree to pay in full with cash, etransfer, bank draft, wire transfer or certified cheque, the amount owed on any vehicle for which I sign a contract.
 - b. I understand that the entire amount of any purchase I make must be paid by 12:00PM on the FIRST banking day following the auction.
 - c. I understand that failure to pay for my purchase on time will entitle The Electric Garage Inc and the consignor to hold me liable. This may include all legal fees and/or court costs.
13. I agree to pay the actual costs of storage and towing for my car to The Electric Garage Inc after the first banking day.
14. **BUYER'S FEE OF 8% of the bid amount will be charged to the Purchaser of each vehicle auction lot sold. MINIMUM SALES COMMISSION ON VEHICLES IS \$400.00.**

BUYER'S FEE OF 15% of the bid amount will be charged to the Purchaser of each item of **EG Auctions' Memorabilia**. Separate buyer's fees will be determined and assessed by **independent memorabilia vendors** participating in the auction (ex: A Piece of The Past)

NO BIDS TAKEN FROM UNREGISTERED BIDDERS.
15. **SPECIAL NOTE:** As a buyer of a vehicle at this auction, I "explicitly waive my rights to any implied warranty as set forth by law". As collector vehicles, these automobiles may not be fit for ordinary driving and may not be reasonably safe and free of defects. COMMITMENTS

1. At the time of signing this contract I have entered into an agreement to deliver and offer my vehicle for sale with Electric Garage Inc. for the reserve price stated. The Reserve Price is an expected selling price that is inclusive of the auction commission. The Auction Company reserves the right to lower the commission in order to sell the car with the seller's net figure being unchanged. The seller may verbally agree to lower the reserve price during the auction process. A reserved vehicle whose reserve is lifted on the block is still subject to the 8% commission fee. If the vehicle is checked into the auction and is withdrawn or does not cross the auction block to be offered for sale, I agree to pay the sale commission in full plus the buyer's fee on the stated reserve price unless specific written authorization is obtained from Electric Garage Inc. waiving said fees.
2. Entry fees are non-refundable and do not apply to commission. "With Reserve" means the owner may place a minimum protective price on the vehicle. "No Reserve" means that the vehicle will sell to the highest bidder regardless of price. These must be offered as No Reserve prior to any bids being taken. Owners may not bid on their own vehicles.
3. Electric Garage Inc. completes transactions and releases vehicles based on the buyers / bidder's contract and terms. After funds are verified, vehicles will be released to new owners. Net sale proceeds will then be paid to the seller. Cheques will be *mailed out* approximately **10-15 banking days from the sale date**.
4. **Consignor represents and warrants that they have the right to consign and sell the said vehicle and that its title/registration documents are in order and match the vehicle. Furthermore, states that the said vehicle is free and clear of all liens and encumbrances to all or any financial institution or individual agent.**
5. Consignor warrants the vehicle to be accurately described to the best of their knowledge including items working poorly or no function, its history, description, or mileage is strictly between buyer / seller. Electric Garage Inc. and/or any agents or companies related to the auction are in no way liable for the vehicle description or accuracy therein.
6. **Vehicle check-in** is Thursday, Sept 8th from 8:00 am – 8:00 pm and Friday, Sept 9th from 8:00 am – 3:00 pm. **ALL VEHICLES MUST BE IN THE VENUE BY 3:00 PM ON FRIDAY, Sept 9th!!!**
7. **Vehicle check-out** – vehicles can be checked out once the last vehicle crosses the block for the day. We will NOT check out any vehicles prior to the conclusion of the sale. Your consignment form ***must be completed in full*** including your email address, vehicle mileage, VIN/Serial #, etc. The attached consignment form and bidding contract are fillable PDF files. Save them to your desktop, fill out all the necessary info, re save and attach them in an email to lindsay@egauctions.com. Use one form per vehicle. All information is required for our records as governed by the Alberta Auctioneers Association, so we are no longer able to accept incomplete forms. Please ensure you also send the completed second page. **NOTE: WE CAN NOT ACCEPT PICTURES OF THE CONSIGNMENT FORM**

Items to note:

Your vehicle registration or Form 1 (for a US vehicle) is required as proof of ownership and VIN so a copy of that document MUST accompany your consignment form...if you do not have a registration, please provide a copy of your bill of sale when consigning your vehicle and the ORIGINAL when checking your vehicle in at the event. If you do not produce a vehicle registration upon check in to the auction, your vehicle will be sold ON A BILL OF SALE ONLY.

Please ensure the name and address on the consignment form matches the name(s) and address on the provincial registration, Form 1 or bill of sale.

A picture of the VIN plate is also required with your consignment package.

*****A copy of a car fax is required for all units from model year 1981 or newer. Please bring this to vehicle check in and submit to the show office*****

Also, include a ***full type-written description of the vehicle in WORD FORMAT or in the BODY OF YOUR EMAIL that can be copied and pasted onto our website*** (include specifications, options, and selling features). Please refrain from using "I" statements in your description. We offer live, online internet bidding as well, so it's important we have as much detail on your vehicle as possible. Vehicle Check-In:
