Information Collection

Information You Provide

- Your identification data. Data provided by you such as a name, surname, age, education, a photo showing the image of the person,
- Your contact data. Data provided by you such as an e-mail address, telephone number, place of residence,
 - **Your career data.** Data provided by you such as data on acquired education, professional experience and interests,
- Your Messages. To improve performance, perform content analysis and deliver media
 messages more efficiently, we retain that content on our servers for a longer period of

Information You And We Share

- statute of limitations under applicable law,
- (potential) disputes; and
- Guidelines issued by relevant national data protection regulators.

Otherwise, we securely erase your information once this is no longer needed for the purposes for which the information is collected.

Service Providers

We may employ third party companies and individuals to facilitate our Website, to perform Website-related services or to assist us in analyzing how our Website is used.

These third parties have access to your Personal Information only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Law And Protection

We may collect, use, preserve, and share your information if we have a good-faith belief that it is reasonably necessary to: (a) respond pursuant to applicable law or regulations, to legal process, or to government requests; (b) enforce our Privacy Policy and any other applicable terms and policies, including for investigations of potential violations; (c) detect, investigate, prevent, and address fraud and other illegal activity, security, or technical issues; or (d) protect the rights, property, and safety of our users or others.

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by following the unsubscribe link or instructions provided in any email we send.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. International Transfer

Your information, including Personal Information, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

In the event of a dispute with Tidio Poland arises with regards to the international transfer of data, courts of Szczecin, Poland have exclusive jurisdiction over the matter.

Transfer outside EEA

In some cases, in particular when Tidio uses the services of third parties / partners, who support Tidio in its business activities, the personal data may also be accessed or processed outside the EEA. Rights

What does it mean?

You have the right to be provided with clear, transparent and easily understandable Right to be information about how we use your personal data and your rights. This is why informed we're providing you with the information in this Privacy Policy.

Right do access

You have the right to obtain access to your personal data (if we're processing it) and certain other information (similar to that provided in this Privacy Policy). This is so you're aware and can check that we're using your personal data in accordance with data protection law.

Right to You are entitled to have your personal data corrected if it's inaccurate or rectification incomplete.

Right to erasure

This is also known as 'the right to be forgotten' and, in simple terms, enables you to request the deletion or removal of your personal data where there's no compelling reason for us to keep using it. This is not a general right to erasure; there are exceptions.

Right to restrict

You have rights to 'block' or suppress further use of your personal data. When processing is restricted, we can still store your personal data, but may not use it further. We keep lists of people who have asked for further use of their personal processing data to be 'blocked' to make sure the restriction is respected in future.

Right to data
