This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for providing our services and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

Information Collection And Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. That Personal Data may include but is not limited to:

- Your name, passport or other identification number, telephone number(s), mailing address, email address and any other information relating to you (such as an online identifier or to one or more factors specific to your physical, physiological, genetic, mental, economic, cultural or social identity) which you have provided us in any forms you have submitted to us, or in other forms of interaction with you;
- 2. Information about your use of our website and services, including cookies, IP address, subscription account details and membership details, but only to the extent that we may identify you from such information;
- 3. Your company information, including financial information, corporate data or such other corporation information which you have provided to Bond in any forms submitted to us or in other forms of interaction with you

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data"). This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. In addition, we may use third party services such as Google Analytics to collect, monitor and analyze this.



Communications

Only in case you have given us permission, we may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information that we think would be interesting for you to read. You have the opportunity to opt out at any time via the unsubscribe link in emails and we will remove you from the distribution list immediately.

Cookies

Cookies are files with a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive. Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
