SPECIAL ORDERS – Healthy Congregations

Mr. John Cheek, Grace Church in the Southern Berkshires, presented an overview of *Marks of Congregational Vitality*, a survey questionnaire offered by the Diocese to assist congregations in assessing their own congregational vitality. Mr. Cheek reported that clearly 'business as usual' is not working to maintain the vitality of congregations. This document/survey prompts congregations to question *Are you living out the Baptismal Covenant?* The document, available on the Diocesan website, also covers financial health, offers the 'hard questions' to ask, and offers suggestions for implementing this tool. Ms. Barbara Groves, St. Luke's, Worcester, discussed some of the ways in which the survey could be utilized, such as vestries focusing on one section at a time, or setting aside a particular day to focus on the entire document. This survey/document stemmed from discussion and concerns expressed by Diocesan Council in regard to the struggles that many congregations are facing. Bishop Fisher thanked the Committee that worked on this document, which included Mr. Cheek, Ms. Groves, and Canon Pamela Mott. Convention Chaplain Margaret Bullitt-Jonas prayed for all congregations.

TREASURER'S REPORT

Bishop Fisher called on Steven Abdow, Treasurer and Canon for Mission Resources, for the 2013 Report of Finances of the Administrative Offices of the Diocese. Mr. Abdow informed delegates that the Journal of the 2013 Diocesan Convention is available on the website. Mr. Abdow announced that our Audited Financial Statements are complete and are included in the Journal. Auditors for the Diocese are Viola, Chrabascz, Reynolds & Company, of Enfield, Connecticut. Mr. Abdow reviewed Revenues for 2013, half of which derive from income from Invested Funds; the remaining half comes from parish support for common ministry, which continues a trend of decline. Mr. Abdow noted that our congregations fulfill nearly 100% of their assessments, and thanked all congregations on behalf of the Bishop and Council. Mr. Abdow then reviewed income from our investments as well as the Trustees investment performance, noting that the total fund return over the last five years is 12.1%, allowing the Diocese to receive a distribution and still maintain fund balances. Mr. Abdow reviewed 2013 income and expenses, noting variances. He added that a small surplus at the end of the year will be added to a 'rainy day fund.' Mr. Abdow noted the continuing decline in congregations' Average Sunday Attendance as well as Plate and Pledge Offerings. He also emphasized financial transparency, noting that Diocesan financial statements are available on our website. In conclusion, Mr. Abdow recognized the work of his colleagues at Diocesan house.

SPECIAL ORDERS – Creation Care

Ms. Barbara Groves called on the Rev. Margaret Bullitt-Jonas, Missioner for Creation Care for her report. The Rev. Bullitt-Jonas, who has served in this position since January, thanked Bishop Fisher for all of his support. She stated that many people remain unaware of their impact on the environment, and that CO2 levels in the atmosphere today are higher than they have been in millions of years—the need to act is imminent. The weather extremes we have been experiencing are just one of the many effects of climate change. This is one great mission of our times, the topic of which can be woven into Sunday School lessons, sermons, prayers, and advocacy. She reported that all issues near to our hearts will be affected over time by climate change. She reported that the Climate Change March to City Hall, that took place recently in Springfield has resulted in City Council passing a resolution to create a Climate Action Plan. The Rev. Bullitt-Jonas thanked the Trustees for the Diocese for their work toward reducing investments in fossil fuels. She also reported that on November 8, 2014 a special event will be offered, Sustainable House of Worship workshop, to help parishes become more energy efficient, save money, and reduce their impact on climate. She asked that there be a representative from each parish in attendance.

SPECIAL ORDERS - Legacy Giving

Ms. Barbara Groves invited Mr. E. John White to report on Legacy Giving. Mr. White reported that there are now 250 members of the Bishops' Legacy Fellowship, representing 42 parishes. This is an increase of 17% over one year ago. Mr. White thanked all who have given gifts over the years. He presented a citation to the Rev. Heather Blais and Mr. Dennis O'Rourke, of St. James' Church, Greenfield, for St. James' planned giving campaign, which has attracted 20 members. Bishop Fisher acknowledged those who work with the people in the ordination process for the diaconate and for priesthood, and thanked them for their service.

SPECIAL ORDERS - Change the Babies

Ms. Barbara Groves called on the Rev. Elizabeth Fisher, St. Thomas' Church, Amenia, New York for a report on the ministries in Ghana. The Rev. Fisher thanked everyone for their support in raising \$30K to help build the kitchen for the Women's Education Center in Ghana. The Rev. Fisher announced that this year's project is to raise funds for the Mampong Babies Home, a facility that houses 35 children whose mothers have died in childbirth. The Home cares for these children until family members are able to provide care for them in their homes. The Rev. Fisher recognized the Rev. Anne Ryder for her commitment to working with the Babies Home, as well as Maggie, the Home's director, who visited the Diocese recently. This year the Rev. Fisher is asking congregations to place a jug or jar marked 'Change the Babies' on their altars to collect loose coins that will help to provide food and medicine to the children of the Babies Home. The Rev. Fisher's goal is to raise \$30K this year to aid the Mampong Babies Home. She thanked all delegates for their continued support.

REPORTS OF COMMISSIONS, COMMITTEES, TASK FORCES AND MISSIONERS

Bishop Fisher announced that all written reports of commissions, committees, task forces and missioners that were received prior to Convention are available on the Diocesan website

<u>SPECIAL ORDER – New Interim Formation Missioner</u>

Ms. Barbara Groves called on the Rev. Hilary Bogert-Winkler, who began serving as the Interim Formation Missioner on June 1, 2014. The Rev. Bogert-Winkler reported that her goal is to build a Diocesan-wide youth

network. She reported taking a group of adults and youths to the Episcopal Youth Event (EYE), a week-long conference in Philadelphia. This conference included dance, song and shared prayer, as well as three days of urban mission projects performed around the City of Philadelphia. Nine youths from the diocese participated. The conference addressed the question *What does it mean to be Christian?* The Rev. Bogert-Winkler said attending the conference was a transforming experience for all. She stated that she would like to build on the experience of EYE with the following events: 1) the formation of a Diocesan Youth Council that will plan youth events; 2) attending *Winterlight 39*, an event for high school youth to be held at Kanuga Conference Center in North Carolina during the winter holidays; and 3) attending *Lift Every Voice Pilgrimage* in 2015, an event that explores the history of slavery and racial injustice and reveals the historical truth of race relations. The first meeting for Youth Council will be November 15th at Christ Church Cathedral from 10:00 a.m. to 3:00 p.m. Following the Rev. Bogert-Winkler's report, Chaplain Margaret Bullitt-Jonas prayed for our youth.

SPECIAL ORDER - The Rt. Rev. Alan Gates, Bishop of the Diocese of Massachusetts

Ms. Barbara Groves welcomed the Rt. Rev. Alan Gates, the newly elected Bishop of the Diocese of Massachusetts, who spoke to Convention of his connectedness with Western Massachusetts, and issues that our two dioceses share in common. Bishop Gates, former rector at Trinity Episcopal Church, Ware credited his time there as welcoming and a great time of learning. He was mentored and guided by Bishop Wissemann, and gave thanks for Trinity Church, and the late Bishop Andrew Wissemann. Bishop Gates shared greetings from the Diocese of Massachusetts and expressed his hope to find new ways to coordinate, cooperate and serve together, to unite in sharing our resources, and to combine our efforts as we share common concerns in our state. He noted that common bonds are our work together toward Casino repeal, and on the diaconal ministry. We also have shared losses in the recent deaths of both Bishop Thomas Shaw and Bishop Andrew Wissemann. Bishop Gates stressed that he is looking forward to building a relationship between the eastern and western parts of the state.

SPECIAL ORDER - Church Without Walls

Ms. Barbara Groves welcomed the Rev. Derrick Fetz to report on the Church Without Walls (CWW). The Rev. Fetz emphasized that this is a lay-led ministry in downtown Springfield that truly represents the love of God in the world. Some of the lay leaders of this ministry include: Karen Gladwin, Linda Taupier, Larry Morrow, and Randy Gallinat. The CWW team showed a video of a Sunday Eucharist held in downtown Springfield. They also reported this ministry was begun by The Rev. John Jeffrey Purchal. It first met at the Chapel of Christ Church Cathedral, and later became a regional ministry. The Reverends Derrick Fetz, Peter Swarr and Bill Dwyer serve this ministry, as well as the late Rev. John DeBonville, who was recognized for his dedication, and for beginning a ministry in West Springfield. Bread is provided by a local bakery, and congregations take turns preparing sandwiches. Convention Chaplain Margaret Bullitt-Jonas prayed for this ministry.

SPECIAL ORDER – Massachusetts Council of Churches

Ms. Barbara Groves welcomed the Rt. Rev. Gayle E. Harris, President of the Massachusetts Council of Churches (MCC) and Bishop Suffragan of the Episcopal Diocese of Massachusetts, and the Rev. Laura E. Everett, Executive Director of the MCC. Bishop Harris and the Rev. Everett offered a message of welcome from all denominations and congregations throughout the Commonwealth. Bishop Harris praised the diocese for its joy, its commitment, and its ecumenical work in so many events. The Rev. Everett reviewed some of the ecumenical events that MCC held this past year, and how their resources were used. She stressed that the most important act this year is to run the church as if the Gospel is true. She reported that the MCC is decreasing their programming this year in order to listen more. She asked that we all act as scouts on the lookout for acts of Christian Unity that are already happening. She had praise for the six new heads of churches who want to work together, and she thanked the Diocese of Western Massachusetts for its witness and its boldness.

SPECIAL ORDER – Lawrence House Service Corps

Chair of the Committee on Dispatch of Business Ms. Barbara Groves welcomed The Rev. Tanya Wallace for her report on the Lawrence House Service Corps. The Rev. Wallace reminded Convention of her congregation's vision, presented last year—the development of a local service corps. She reported that this hope has turned into a ministry. The Rev. Wallace reviewed the history of the Lawrence House, which had been leased for many years to Mount Holyoke College. As the lease was expiring, the congregation brainstormed and prayed, and a vision of a Service Corps project emerged. The congregation received a bequest as well as matching grants to aid this project. The Rev. Wallace reported that many faithful parishioners worked on the project to bring it to fruition as the Lawrence House Service Corps. Five interns have been hired, and each will devote a full year to live intentionally in Christian community, and perform service work throughout the region. All recent college graduates, the interns began their service on Labor Day. The Rev. Wallace reported that the Lawrence House Service Corps has recently been accepted as part of the larger Episcopal Service Corps. Four of the interns were present at Convention—Kevin Smallwood, Quanita Hailey, Alison Brauner and Edward Stroud, and each addressed the delegates on their individual ministries. Intern Andy Leigh-Bullard was not able to attend Convention. The projects include Kate's Kitchen; FoodWorks; working with the youth at Christ Church Cathedral; Cathedral in the Night; and the Veterans Ministry. Following their reports the Rev. Wallace thanked everyone for their support of Lawrence House, and asked for continued prayers.

REPORT FROM THE COMMITTEE ON RESOLUTIONS

Bishop Fisher called on Committee on Resolutions Chair, the Very Rev. James Munroe, for his report. The following resolution was submitted:

Resolution #1 was presented and summarized by the Reverends Lisa Green and Harvey Hill, co-chairs of the Social Justice Committee.

Resolution # 1: Eliminating Fossil Fuel Holdings and Investing in Clean Energy

Resolved, that as a matter of moral and theological urgency, in obedience to God's command to "tend and keep the earth" and consistent with Jesus' injunction that we care for those who are most vulnerable, this 113th Convention of the Episcopal Diocese of Western Massachusetts calls on the Church Pension Fund, the Investment Committee of the Executive Council, and the Episcopal Church Foundation to adopt a policy to refrain from this time forward from

purchasing any new holdings of public equities and corporate bonds of the world's leading 200 fossil fuel companies as identified by the Carbon Underground, and be it further

Resolved, that in obedience to God's call to be stewards of earth's diverse community of life, this 113th Convention of the Episcopal Diocese of Western Massachusetts calls on the Church Pension Fund, the Investment Committee of the Executive Council, and the Episcopal Church Foundation to develop and implement a plan to eliminate exposure within five years to direct ownership of public equities and corporate bonds of the world's leading 200 fossil fuel companies as identified by the Carbon Underground, and be it further

Resolved, that as an investment in the healthy future of humanity and the planet, this 113th Convention of the Episcopal Diocese of Western Massachusetts calls on the Church Pension Fund, the Investment Committee of the Executive Council, and the Episcopal Church Foundation to develop and implement a strategy to invest 5% within two years, and 10% within four years of their overall holdings in "impact investments" in the clean energy sector, and be it further

Resolved, that this 113th Convention of the Episcopal Diocese of Western Massachusetts memorialize the 78th General Convention of the Episcopal Church to encourage all dioceses and the Consortium of Endowed Episcopal Parishes to engage within the coming year the topic of eliminating exposure to investment in fossil fuels and of reinvesting in clean energy.

Motion was made and Seconded to adopt the Resolution on Eliminating Fossil Fuel Holdings and Investing in Clean Energy, and the topic was opened for discussion.

Proposed Amendment: A proposed Amendment would strike the words "leading 200" and "as identified by the Carbon Underground" in both Paragraph 1 and Paragraph 2 of the Resolution as it stands.

The Amendment to the Resolution was Moved, Seconded, and opened for discussion. Following discussion, the Amendment Failed to pass.

Convention returned to discussion on the Resolution.

Motion was made to end the debate (Call the Question). Motion was Seconded and Carried.

Convention VOTED on the Resolution and the Resolution carried.

Resolution # 2 was presented by Linda Taupier.

Resolution # 2: Authorizing Diocesan Council to Revise Policies Regarding Diocesan-wide Health Insurance Benefits

Resolved, that the Diocesan Council have and exercise the authority to study and revise, from time to time, the Diocesan-wide policies regarding medical and dental insurance benefits for the Clerical and Lay staff of the Diocese and its Congregations.

Motion was made and Seconded to adopt the Resolution Authorizing Diocesan Council to Revise Policies Regarding Diocesan-wide Health Insurance Benefits, and the topic was opened for discussion.

Proposed Amendment: A proposed Amendment to the Resolution was presented as follows: to strike the words "revise, from time to time" and to substitute the words "recommend to Diocesan Convention".

The Amendment was Moved, Seconded, and opened for discussion. During the following discussion, VOICE was granted by Convention to the following non-delegates:

Ms. Susan Olbon Ms. Sarah Dunn Motion was made to end the debate (Call the Question). Motion was Seconded and Carried.

Convention voted on the Amendment. The Amendment Failed to Pass.

Convention returned to discussion on the Resolution.

A request to vote by Orders was Moved and Seconded. It failed to Pass.

Motion was made to end the debate (Call the Question). Motion was Seconded and Carried.

Motion was made and Seconded, and it was **VOTED** to adopt the Resolution Authorizing Diocesan Council to Revise Policies Regarding Diocesan-wide Health Insurance Benefits.

[After the Convention, on November 6, 2014, Bishop Fisher notified the Secretary that he had been advised that the Call for a Vote by Orders was not handled consistently with provisions of Article IX.1 of the Diocesan Constitution, and that he had determined that the subsequent vote on the Resolution #2 was of no force or effect. Convention Delegates and Clergy were notified on November 17, 2014.]

SPECIAL ORDER – Global Mission

Chair of the Committee on Dispatch of Business Ms. Barbara Groves welcomed the Reverends Peter Swarr and Anne Ryder of the Global Mission Team, who thanked the diocese for its financial and prayer support, noting that this support provides for both educational and missional opportunities. Bob Harris, St. John's Church in Ashfield, spoke to Convention about the Global Episcopal Mission Network, which sponsors an annual conference that brings together persons interested in missionary work. The Network also offers training and immersion experiences. Members of the Dominican Republic Mission Team reported on their July 2014 mission trip, when they visited the DR for the fourth time. Other global mission work that took place this year included a group from Grace Church, Amherst that visited Haiti; and a group of six members from across the diocese who visited Uganda through the Connect Africa program. The latter helped to organize a library. The Rev. Anne Ryder reported that the goal this year is to raise sufficient funds to provide all the babies at the Mampong Babies Home with pajamas, and the workers with uniforms. She also reported that Tom and Dianne Wilson, missioners in El Salvador, received a grant to dig a new well there.

PRESENTATION OF THE 2015 MINISTRY PLAN AND DIOCESAN OPERATING BUDGET FOR 2015

Bishop Fisher invited Mr. Steve Abdow, Canon for Mission Resources, to present the 2015 Ministry Plan and Operating Budget to Convention delegates. Canon Abdow began his report by showing a video, demonstrating many of the ways that Diocesan resources have been used for mission in 2014. Some of the resources were utilized through Congregational Development Investment grants; Cathedral in the Night; and a variety of food ministries. Canon Abdow thanked Diocesan Communications Director Vicki Ix for creating the video. Following the reading of the Plan, Canon Abdow reviewed the 2015 Proposed Budget, which includes funding for a new Veterans ministry; Interim Formation Minister; Lawrence House Service Corps; Berkshire Ministries; Parish Administrators Day; Building for a New Tomorrow Symposium; Wardens Dinner; Parish Leadership Day; Hispanic Ministries; and Congregational Development Investment grants. Canon Abdow reported that 27% of the Diocesan Operating

budget goes to outreach. Following review of all areas of the budget, Mr. Abdow Moved the Diocesan Operating Budget be accepted as presented. Motion was Seconded and it was **VOTED** to approve the budget as presented. Please see Section 2 of this Journal for the 2015 Ministry Plan and Operating Budget.

REPORT OF COMMITTEE ON PLANNING OF NEXT CONVENTION

Bishop Fisher called upon the Rev. Scott Seabury, Chair of the Committee on Planning of Next Convention, for a report on the place and time of the 2015 Convention. The Rev. Seabury reported that the committee will be meeting soon to evaluate the present venue and other sites, and will recommend a place and time for the 2015 Convention.

Bishop Fisher recognized and thanked the Rev. Deacon Eric Elley and his assistant, Mr. Lee Anderson, both of St. John's Church in Northampton, for all their technical work and hours of dedication to this Convention. He also thanked the Rev. Deacon Jane Griesbach for videotaping the Bishop's Address to Convention.

Report of the Standing Committee to Diocesan Convention Sept. 2014

The Standing Committee, following the canon law of the Episcopal Church, is composed of lay persons and clergy of the Diocese, working in partnership with the bishop of the Diocese. The Standing Committee also serves as a council of advice to the bishop.

The primary canonical responsibilities of the Standing Committee are: review and approval of any sale or encumbrance of property by the parishes or the Diocese; giving consent to all elections and consecrations as bishop in the Episcopal Church; giving consent to candidacy for ordination, and consenting to ordination to diaconate and priesthood.

The Standing Committee takes on additional responsibilities in the event of a vacancy in the office of bishop in our diocese. The President of the Standing Committee serves as vice-president of Diocesan Council.

Normally there are eight members of the Standing Committee, four priests, and four lay persons. The present members with their area of responsibility and term office are as follows: the Rev. Janice Ford – Commission on Ministry (2016) resigned Nov. 2013, replaced by The Rev. Derrick Fetz (2016), The Rev. Bennett Jones II – property (2015), Nancy Lowry – Commission on Ministry (2014), The Rev. Catherine A Munz – President (2014), Judith Phillips – secretary (2015), Ted Zern – Property (2016) resigned Sept. 2016, Lee Cheek – Commission on Ministry (2017), The Rev. Nancy Webb-Stroud – Commission on Ministry (2017).

Between September 2013 and September 2014 The Standing Committee took the following actions:

- Approved the elections and consecrations of the following to the Episcopate:
 Allen Shin, Matthew Alan Gunter, Alan M. Gates, and Elizabeth Cook.
 Consented to the election of a Bishop Coadjutor of West Texas, and the Dominican Republic.
- Approved the following Postulants to be Candidates for Ordination:Sarah Dunn, Jose Reyes, David Woessner, in May, and for ordination the transitional Diaconate in the September meeting.
- Approved Jane Tillman for ordination to the Priesthood.
- Approved the sale of the property at 166 Holden St. Worcester formerly known as St. Johns.
- Approved the request of Grace Church, Amherst to borrow up to \$400,000.
- Ratified the electronic vote for Camp Starfish
- Approved the sale the Chapel of All Saints in Whalom, MA
- Approved sale of the vacant lot adjacent to St. Thomas Auburn
- At Bp. Fisher's request the Standing Committee will meet simultaneous with the Diocesan Council beginning January 2015.



Goals for the Ministry of Communications

I hope to refresh every page of the website – a process I am already engaged in but one that requires time, patience and creativity. There is much to learn in this area for me and I hope to

do some professional development in the area of web design and maintenance. I would like to see the creation of webpages for the Commission on Ministry, Hispanic/Latino Ministry and Communications. The communications page will serve as a portal for uploading news and photos.

I hope to offer a targeted workshop at Leadership Day and host an open "best practices" forum for parish website administrators. There are wonderful things happening in parishes and we can learn much from each other.

I hope to increase the scope of contributors to "Abundant Times" magazine and move more definitively into theme-based issues. Our print medium can be a powerful tool for advocacy and promoting holy conversation.

Most importantly, and in every aspect of this ministry, I hope to follow where the Spirit is leading our congregations and our bishop. There is only one story to be told – the good news of God's love for us in Christ. It continues to be my privilege to be the one "putting pen to paper" in support of that mission.

REPORT OF THE ECUMENICAL AND INTERRELIGIOUS OFFICER

"Is Christ divided?" (I Co 1:13) This verse formed the theme for the Week of Prayer for Christian Unity observed in January 2014. St. Paul asks the question rhetorically in the effort to make the Corinthian community think about the effect their many divisions has on the Church. In 2014, the Apostle's words asked us to reflect and pray about that same reality. In one sense, we know that Jesus the Christ, the incarnate son of the living God, the Lord of all creation is indivisible. At the same time we know how deeply fractured His Body the Church remains two thousand years after his life, death, resurrection, and ascension. Ecumenical and interreligious work exists in recognition of how offensive these divisions are and to fulfill Jesus' prayer the night before he gave his life for this world that all might be one in Him. There is extensive ecumenical work in our diocese, throughout the Commonwealth, and across our nation and globe. And in recent years, as our society becomes more diverse, interreligious work has become a higher priority. While there often has been a dichotomy between "faith and order", which seeks to explore and resolve differences of belief and practice among Christians, and "life and work", which focuses upon our common humanity, the shared issues we face, and answering our challenges through collaborative effort, ecumenists increasingly agree that the efforts toward unity are not an "either/or" but "both/and".

Almost every parish in our diocese has some form of ecumenical and/or interreligious relationship. Such relationships may involve shared worship (especially on special occasions such as Thanksgiving, Good Friday, and Easter), educational offerings, and addressing community issues such as hunger and homelessness. In virtually every community in our diocese, there is a food pantry, clothing closet, and housing/energy assistance program and most communities agree that such groups would not exist without the leadership and support of churches and other religious communities. In this past year in the Commonwealth, several issues have provided new and expanded opportunities for ecumenical and interreligious efforts. The "Repeal the Casino" movement has become an important rallying point for people of countless different religious perspectives. The efforts of churches, synagogues, mosques and temples to get out the word on the issues and to mobilize efforts to get the issue on the ballot for November's election and to publicize the reasons why legalized gambling is not a solution to the economic issues faced by municipalities and the state has been essential to the cause. So too, the continuing efforts by people of many different faiths to address the issues of guns and gun violence remains a significant force in keeping these concerns before the public and political leaders. Perhaps the current focus drawing increasing ecumenical and interreligious cooperation and work is the environment and the concern for our creation. More and more, people of faith are getting involved in the efforts to address the many issues affecting our environment and to encourage individuals and communities to become wiser stewards for preserving the world we share.

One of the most important forums for ecumenical and interreligious work in Massachusetts is the Massachusetts Council of Churches. Under the very able and dynamic leadership of the Rev. Laura Everett, the Council continues to encourage the growth and development of ecumenical and interreligious work and relationships. Steve Abdow is providing excellent leadership as the Council's treasurer and I am honored to serve as the Diocesan representative to the Council. It is a privilege and pleasure to serve as the Ecumenical and Interreligious Officer for the diocese and to serve as the Coordinator for the EDEIO's of Province I. Currently, I am trying to work with Province I's dioceses to make sure that every

diocese has an ecumenical officer. Earlier this fall, Bp. Ian Douglas appointed the Rev. Barbara Briggs, formerly of this diocese, to serve as Connecticut's EDEIO and our former diocesan colleague, Bp. Rob Hirschfeld of New Hampshire and I have begun talking about how our dioceses can work together in our ecumenical and interreligious efforts. Bishop Fisher has been a wonderful support and a powerful presence for the ecumenical and interreligious work in the diocese and in the larger Church. While any answer to St. Paul's question to the Corinthians must acknowledge the continued divisions within Christ's body and the continuing mistrust between peoples of different faith traditions, the work continues to fulfill Jesus' prayer that all humanity might be one as He and the Father are one. May we all be faithful to that task.

Report to Diocesan Convention 2014

Episcopal Church Women

The ECW in the Diocese Western Massachusetts continues to support women's ministries wherever they may need assistance, information, or answers to questions.

- Our major focus is the United Thank Offering, supporting parish coordinators around the diocese and organizing the spring and fall ingatherings.
- ECW has a display table at the diocesan convention where both ECW and UTO information and materials are available. Being present at convention provides visibility and an opportunity to share information. UTO boxes are on all delegate tables and about fifteen ECW start-up packets were taken at the 2013 convention.
- We renewed our collaboration with the Diocese of Massachusetts ECW for another 3-year commitment to adopt Martha, at Our Little Roses Orphanage in Honduras.
- On behalf of ECW I am now in communication with the Global Missions Committee for possible collaboration.
- With our outreach funds, we contributed \$500 to help build a kitchen at the Women's Training Center in Kumasi, Ghana, our companion diocese.

This year most of my time and energy was spent serving on the National ECW ad hoc committee and as Province I Representative to the United Thank Offering Board, two positions that as diocesan president I had not foreseen last year. The silver lining is we will have one and possibly two new delegates to the Triennial Meeting for 2015, as I cannot be a delegate.

Electronic communication becomes more and more of a reality primarily due to distance, but there is a renewed interest in meeting around the diocese in small groups. The new communications missioner is very supportive of maintaining our webpage on the diocesan website and I maintain the Province I ECW website, always looking for interesting information to post and posting all information sent to me from the dioceses in Province I.

As I travel around the diocese, it is evident that there are women gathered together, often informally without much structure, but they love God and their neighbor and look for opportunities to serve wherever there is need. Not too long ago I attended a meeting of an informal praying hands ministry. About 40 women gathered to share how they pray while working with their hands: sewing, knitting, crocheting. In the end, they create items from prayer shawls that bring comfort, to fetal demise pouches for stillbirths and miscarriages, to leprosy bandages that are sent to Viet Nam, where leprosy has not been eradicated, and disposable bandages are not available, to dresses for children in Africa. I listened to some powerful stories about the spiritual benefit to the giver as well as touching stories about the receivers, as women pray with their hands.

LEGACY STEWARDSHIP

2014 Report to Convention October 25, 2014

One of our primary objectives in this Diocese is to tell the story of the value of making Legacy Gifts for the individual, for the family and for parishes and for the Diocese. What is highly unusual in our Diocese compared to others is that even though I am the Bishop's missioner, my focus has been on supporting legacy giving to parishes and not focused on giving to the Diocese. To date we know we have 250 members(a 35 increase over a year ago) in our Diocese who have made legacy gifts of which some 95% of the gifts are designated to parishes. We also know there are many more legacy givers with whom we are not aware or we are aware of but choose not to be part of the Bishops' Legacy Fellowship.

Our approach continues to be one of general education and sharing stories of legacy giving, not one of personal one-on-one solicitation. We send out one diocesan mailing from the Bishop yearly asking people to consider making gifts. We are present at most all-Diocesan wide events either providing resources and or giving talks.

We are committed in supporting parishes in creating their own Legacy Fellowships modeled after the Diocesan Bishops' Legacy Fellowship. To date we have 10 parishes with Legacy Fellowships-and these parishes, not surprisingly, are the ones with the most active legacy giving today.

We tell the story of legacy giving in many ways; continue to contact Rectors and stewardship chairs; continue to send out our "new" one page e-Stewardship Newsletter. And we host The Bishops' Legacy Fellowship Annual Appreciation Concert and Dinner each spring averaging 60 in attendance.

Bruce Rockwell's gracious support of Legacy Giving has not only inspired many parishioners to make gifts but has been very important to my own spiritual growth.

Report by the Rev. Margaret Bullitt-Jonas, Missioner for Creation Care Diocesan Convention, October 2014

I began serving as Missioner for Creation Care in January 2014. I am deeply grateful to Bishop Doug for creating this position and for his ongoing guidance and support as my role unfolds within and beyond the diocese. I am also grateful to the anonymous donors who funded the position, and to Vicki Ix, our Communications Director, whose creative and technical skills have been immensely helpful to me.

Some highlights of the past 10 months:

- Created a new Website, RevivingCreation.org, which includes blog posts, sermons, articles, multimedia, and more. Some blog posts focus on spiritual aspects of Creation (e.g. the biblical basis for Earth care, and the power of recovering our intimacy with the natural world). Other posts reflect on current struggles to stabilize the climate (e.g. Keystone XL pipeline, the Lobster Boat Blockade, People's Climate March and Flood Wall Street).
- Preached at St. John's, Ashfield; St. Mark's, East Longmeadow; St. Francis, Holden; St. Paul's, Stockbridge; St. John's, Williamstown; Christ Church, Rochdale; St. James, Greenfield; and Grace-St. Paul's, Tucson, AZ. Also led adult education forums on Christianity and climate change, and presented the slideshow "God So Loved the World" (available free at RevivingCreation.org) in various churches.
- Began forming a diocesan network that so far includes more than 60 individuals from 23 churches. Led two workshops at Vestry Wardens Day (March 15), attended by about 30 people, and started a private Facebook page for interested members of the diocese.
- Initiated (with the bishop's blessing) a Season of Creation from Oct. 4 (St. Francis Day) through the end of November (Christ the King Sunday). Developed events and assembled resources to support parishes as they explore ways to celebrate the season (Pray, Learn, Act, Advocate). Designed a poster, bulletin insert, and "tool box" (thank you, Vicki!)
- Developed with Vicki a diocesan Web page for Creation Care and a page for Season of Creation.
- Designed with Vicki a banner for members of the diocese to carry to public events: "Love God, Love your neighbor: Stop climate change."
- Joined the Social Justice Commission. Drafted a statement: "Not only with our lips, but in our lives': The Church and Social Justice," edited by the Commission and released on June 24 (Feast day of John the Baptist). Drafted for the Commission's Website page, "Within me there is something like a burning fire."
- Encouraged divestment from fossil fuels. Supported members of the diocesan Task Force on Climate Change and Care for God's Creation as they prepared to vote. Submitted on behalf of the Social Justice Commission a resolution regarding divestment and TEC for discussion at our diocesan convention. Participating in conference calls with Episcopalians for Fossil Fuel Divestment & Clean Energy Reinvestment as we prepare a divestment/reinvestment resolution for General Convention, 2015. Represented Diocese of WMA at a public panel in Springfield regarding a bill to divest pension funds in the Commonwealth of MA.
- Led retreats, including "The Dark Night of the Planet" (how to offer spiritual direction in the context of climate change, held in CT); "Mindfulness in Nature" (for clergy of Diocese of MA); "Pilgrimage for the Earth" (held in VT); and "The Heart of Creation: Cultivating Hope in a Wounded World" (held at Adelynrood). Gave talks at Yale Divinity

School and Boston College.

- Helped to plan interfaith engagement in the People's Climate March. With Stephanie Johnson, Province One's Environmental Stewardship Minister, organized a bus from Springfield to New York City, with Holy Communion celebrated aboard the bus. About 50-60 members of the Diocese of WMA joined this historic climate march, which drew a record 400,000 people.
- Serving on the Board of Better Future Project, which is developing a grassroots climate movement in Mass. and beyond. Participating in New England Regional Environmental Ministries (NEREM), a group seeking to develop a strategic plan for climate action among Christians in New England.

The news from climate scientists is grim. Emissions of greenhouse gases from the burning of coal, gas, and oil continue to increase, as do average global temperatures worldwide. Extreme weather events are becoming more intense and more frequent; oceans are acidifying; sea levels are rising. Last May, scientists reported that the West Antarctica ice sheet has begun a process of melting that appears to be "unstoppable."

Yet God's love for us, and for all Creation, is equally unstoppable, inspiring more and more of us to join the religious environmental movement. I give thanks for all of you who engage in the great work of loving God and neighbor by participating in the movement to protect life as it has evolved on this planet.

Report to Convention Missioner for Servant Leadership & Ecumenical Relations/Collaboration (?) The Rev. Jennifer Gregg

Approximately a year ago, I preached a sermon in which I asked this question: "how do we as a parish get "out" and on the move, shifting the age-old question from how the larger community (of Pittsfield) can help us grow and survive, to how can we help Pittsfield and God's people therein to thrive?"

Like so many of us, I have never been so aware of the need for God's love to be showered on this word in tangible ways than I have in recent years. Our world needs it, people are longing for it and we live in a culture that does not value the church in the same way it did 60 years ago. The richness and gifts we (the church) have to offer has not changed. Jesus Christ is the same yesterday, today and forever. However, how we offer and extend those gifts is being challenged. And as always, it is Jesus that offers the example. Jesus was always on the move, meeting people on the road out and about. It was out in the field, that he met the leper, the hemorrhaging woman, the rich and the blind. It was out in the field that he broke bread and fed 5,000; showered blessing and restored those who had been outcast to community. And when Jesus met God's people, he met them in a community of disciples who was (on the best of days) helping to share the load, while being formed along the way.

It is the re-shaping of this question and Jesus example that has set the foundation for my work over the last year. Getting out and meeting our God who is always on the move by building relationships between congregations, the community at large and the needs of God's people therein.

This has taken three forms: The launch of Cathedral in the Night, Pittsfield, Servant Leadership and Community Organizing.

Cathedral in the Night:

Earlier this fall, Cathedral in the Night – Pittsfield, a shared endeavor currently between 8 congregations (including Roman Catholic, Episcopal, Baptist, Methodist, Lutheran and UCC) and growing began with 90 people present. This simple service features a simplified liturgy of the word and an Agape Meal is held on the front lawn of St. Joseph's Catholic Church on North Street. It has provided a venue for Roman Catholics and Protestants to come together to share in ministry together, a precedent not seen within recent history.

- Preliminary work to this launch was to find ways for congregations within downtown Pittsfield to worship together.
 To this end, it was decided to share the season of Lent together. Beginning with Ash Wednesday, we held an evening service together, followed by a shared Holy Week.
- Relationships have been fostered between the mental health community and congregations leading to a Spiritual Support Group that has met weekly for the last year.
- Working with St. Joseph's high school to set-up internships and/or service projects through Cathedral for HS graduation requirements.

Servant Leadership:

In order to launch Cathedral, some of the work for Servant Leadership was tabled for the earlier part of the year.

- This fall we have hosted a class on Richard Rohr's book, *Falling Upward* with 14 participants representing six different parishes within the Berkshires.
- A joint meditation class with the Pittsfield Meditation Sangha is currently being coordinated to start in coming weeks.
- Working with The Rev. Tom Callard on incorporating components of servant leadership into mission development for congregations.
- Launched an ecumenical youth group composed of six congregations with a growing reach to the larger community.
- In an effort to stream line this work, my hope is to use outdoor worship services throughout the diocese to serve as centers for formation in servant leadership. Providing safe spaces to break down the barriers and deepen the relationships that often arise between those being "served" and those "serving". These conversations will unfold in the coming year.

Berkshire Organizing Project:

This past year, the Berkshire Organizing Project is currently working to research on two issues deeply affecting the region: Food Insecurity and Transportation. Focus has been working on collecting stories from those who are impacted on these issues. Research and stories will be presented to the gathered body as we work toward action with state and local representatives on January 25th, 2015.

REPORT OF THE STEWARDSHIP MISSIONER

While my lay ministry continues to involve assisting parishes in formulating stewardship financial commitment programs that will encourage generous and faithful responses, the major focus of my work consists of assisting congregations in forming stewards. More generous financial offerings are a by-product of faithful stewardship; they are not the end product. The goal of stewardship formation is to form faithful, loving and generous stewards in every facet of their lives. This is a ministry that requires the discerning work of parish stewardship ministry teams that meet regularly throughout the year to pray and engage scripture together while they seek ways in which they can form stewards in the congregation. My prayer continues to be that each and every congregation will have a year-round stewardship ministry team. I believe this is the most effective way to form loving, thankful, generous stewards throughout the church.

As I wrote last year, stewardship is everything we do after we say, "I believe." In other words, stewardship is all we do after we profess our belief in God as the creator and giver of all good things. So, while the financial offerings we make are part of our stewardship response, they are only a part. Stewardship stems from our awareness that everything that we have is a gift from God, and everything that we are is also a gift from God. We are called to be good stewards not only of the financial resources God entrusts to us but also of the gifts of time and talent God entrusts to us. We are called to be stewards of our entire lives, of every aspect of our lives.

While I had been mentoring the stewardship ministry team at Grace Church in the Southern Berkshires, we have expanded the group to include the stewardship teams of Christ Episcopal/Trinity Lutheran Church in Sheffield and St. Paul's Church in Stockbridge. And I have also continued to mentor the stewardship ministry team at the Church of the Nativity in Northborough as well as serving on the stewardship ministry team of St. Mark's in East Longmeadow.

Given my experience in the southern Berkshires, I hope to explore other regional opportunities to work with stewardship teams. If you would like to explore such a relationship, please contact me.

Another element of my time and effort is to represent the diocese as a member of the Northeast Ecumenical Stewardship Council where I serve as convener. On April 17 and 18, 2015, we will offer an ecumenical stewardship event in Boxborough, MA that will feature Michael Curry, Bishop of the Diocese of North Carolina, as a keynoter. Bishop Curry is well known as an especially dynamic teacher and preacher. I hope you will set aside the date and send a team of people to this event. Since Province I no longer has its own stewardship conference, this ecumenical event offers stewardship leaders in our diocese a wonderful way to hear inspirational speakers and to learn how others are working to develop generous stewards in congregations not only in Episcopal churches but also in UCC, Lutheran, and United Methodist congregations throughout New England.

Our diocesan membership in The Episcopal Network for Stewardship [TENS] continues to provide parishes with excellent stewardship resources such as the *Walking the Way* materials many parishes are using this fall as part of their stewardship financial commitment program.

One of the great joys of my ministry is to continue to work with John White, our Missioner for Legacy Stewardship, to support his important ministry in our diocese. We continue to be heartened by the number of people who have remembered the ministry of the church in their estate plans. John has described his lay ministry in his own report to you.

On behalf of Bishop Fisher and Diocesan Council I am honored to present the Ministry Plan for 2015 and the budget that supports it. I will be in each of the three corridors in the Diocese (Berkshires, Pioneer Valley and Worcester) before convention at scheduled meetings to present the budget to you in person. At that time we will review the ministry plan and the financial resources that support it in more detail than is possible on the floor of Convention when the budget will be moved for acceptance.

2015 MINISTRY PLAN

We are committed to fulfilling Jesus' mission of mercy, compassion and hope in Western Massachusetts as we work to transform lives both inside our organization and at our doorsteps. To accomplish this we will:

Listen to the congregations and members of the Diocese so we may discover together how to best leverage the gifts and resources of the Diocese to increase our ministry.

Support and Challenge our congregations in their willingness to grow spiritually and create vital places of worship and ministry in their communities.

Encourage collaboration between congregations in our diocese and with other partners in all aspects of our common life.

Enhance the ministry of all people, lay and ordained, by developing strong teams of leaders that know how to discern their call and then act on it.

The stated plan captures the priorities and strategies of the Bishop, Council, and staff at this time.

2015 BUDGET IN SUPPORT OF THE MINISTRY PLAN

In 2015 we will have more financial resources available than we have had since 2008. They will be used to create a number of new programs and ministries in the diocese while

maintaining the same staffing levels as in the recent past years. I am excited to share the Good News about what we hope to achieve in 2015.

Highlights:

- Congregational Development Investment grant funding to remain at \$90,000
- Christian Formation grants to congregations
- Ecumenical, outdoor ministry in the Berkshires
- Additional funding for Hispanic Ministry
- Veterans Ministry across the diocese
- Funding for consulting for congregations on Recasting Assets through Episcopal Church Building Fund

Revenues supporting our Common Ministry:

- Total Revenues for 2015 are budgeted at \$2,464,267. This represents a 3.41% increase over the previous year.
- Income from Assessments is down by 0.11% to \$1,106,688. The average assessment in our diocese is 10.3%. This is the lowest assessment rate in New England. The range is from 6.75% to 12.30%. The formula is progressive, with those who have the most revenues (and resources) paying a larger share.
- Income from our investments is up by 6.65% or \$81,737 from 2014. In 2015 53% of the total revenues that fund the budget come from investment income.

Expenses directly supporting our Common Ministry and the Ministry Plan:

Our Mission in the World:

- The apportionment to The Episcopal Church is calculated at 15% of income. This is the biggest single line item on the budget and is set at \$304,845.
- Our support for the work of the Global Mission Commission of the Diocese and our support of the Millennium Development Goals continue to be funded at the prescribed rates of 1% and .7% of Diocesan income, respectively.
- We maintain funding for the Anglican Communion Partners, specifically to support mission and ministry in the Diocese of Kumasi in Ghana, at the rate of \$2,500.
- We continue our support of different denominational and ecumenical agencies at the same levels as last year including a contribution to the Mass Council of Churches of \$12,500 towards our partnership with them and the outstanding work they perform.
- We are committing \$21,000 to a new project of Veteran's Ministry in 2014 and 2015. Plans are for weekly gatherings in locations in each corridor led by clergy providing hospitality and a forum to encourage relationship building with veterans. Our hope is that in planting some seeds, signs of God's Reign will grow from this important work with those who have served our nation.
- The total budget for our Mission with the Larger Church is \$401,532.

Our Mission with Congregations:

- Congregational Development Investments will once again be funded at \$90,000. Grants are available for new ministry initiatives, communications, and investments in our buildings that will create income opportunities and new energy efficiency programs.
- The Christian Formation Ministry budget for 2015 has increased by \$18,481 to \$103,481 with the appointment of the Rev. Hillary Bogart Winkler as part-time Missioner. There is \$85,000 available for a combination of programs and grants to congregations. Details are emerging and will be announced.
- The Rev. Jenny Gregg will be working regionally and ecumenically to spread the teaching of the Servant Leadership School and will help lead a new outdoor ministry in Pittsfield. Expenses in this area have increased in order to provide additional available benefits to Jenny.
- There is \$35,000 in college scholarship funds again available through a generous bequest from the estate of William and Helen Waterfield of Worcester.
- We have increased the budget for Hispanic Ministry on the Diocesan level by \$15,000. Canon Tom Callard has been serving as part time Diocesan Missioner and has made great progress. This budget will allow for training and education for lay and ordained ministers throughout the Diocese to develop ministry with Latin@s in our communities.
- There is \$19,000 for consulting by the Episcopal Church Building Fund for congregations looking to recast their assets so to leverage them for increased ministry. The consulting had been scheduled for 2014 but will take place in 2015 instead.
- There is \$36,000 budgeted for Special Assistance for Congregations available to help the Bishop's Office to be "nimble" in assisting congregations with clergy compensation as they face crisis situations that may not only signal danger but opportunity. They are not intended to plug the dam or delay closure, but rather for purposes of exploring new possibilities as they emerge in a changing world. This money will be held as a reserve for this purpose in 2015.
- The total budget for our Mission with Congregations in 2015 is up \$80,686 to \$559,839. This reflects a higher percentage of the overall budget than any other area, and is in keeping with our commitment to support the congregations in the Diocese.

Leadership Development and Clergy Support:

- We are expecting few changes in this area of the budget. Funding is level for most lines.
- The budget for Transition Ministry (finding new clergy for congregations) is reduced by \$11,000 in 2015. In 2014 we were using the services of a consultant. In 2015 our two Canons to the Ordinary are picking up that work.
- There is money budgeted in 2015 to provide anti-racism training for clergy in the Diocese. The training is a part of a directive from General Convention and was last undertaken in 2002.
- Seminarian Assistance which is funded out of the distribution of the Waterfield Memorial Scholarship Fund is budgeted at \$12,500.

- The budget for Lay and Ordained Retiree Support is down \$6,500 from the previous year. This reflects the change in policy that took place in 2011 to no longer extend this benefit to ordained retirees. The Church Pension Fund's new benefit program made the benefit redundant and allowed us to eliminate it going forward. Our total obligation in 2014 for retired clergy and Diocesan lay staff is \$112,803.
- Overall this portion of the budget is down 3.43% from 2014 to \$371,682.

Mission and Ministry of the Bishop:

- The biggest change from 2014 in this area of the budget is on the Communications line. Our missioner, Deborah Harris, retired early this year and our search brought Vicki Ix to the Diocesan staff. Vicki is full time while the previous position was ³/₄ time. The budget for salary and benefits was increased by 20%. The total budget for communications is \$102,549 which includes all costs such as printing, mailing, website hosting and design and so on.
- We continue to fund the work of our part time Missioners for Stewardship and Legacy giving at a cost of ~\$27,000.
- \$25,000 has been budgeted for work on special ministry projects initiated by Bishop Fisher.
- The work of organizing the Diocesan Archives is budgeted at under \$8000.
- The budget in this area is up 6.05% to \$509,203.

Administration and Finance and Agency Functions Provided to Congregations:

- The combined impact of these two areas in the budget is an increase of \$17,596 (2.92%). This represents 25.2% of the Diocesan budget. The increase basically reflects the increased cost of doing business.
- The Agency Function provided full payroll services, complete benefits administration, and oversight of the property and casualty insurance program for the congregations and programs of the diocese.

Wages and Benefits expenses that appears throughout the budget:

- In 2015 we are proposing a budget that includes up to 2.5% in wage increases. Any raises will be based on merit, as determined by a standard performance review process, and approved by the bishop with input from the executive staff.
- Health insurance premiums are forecasted to be minimally higher in 2015.
- Personnel expenses are distributed through the different areas of the budget based on an evaluation of how staff time is spent.


