Why our course

There is an increasing demand for impact evaluation. But for most practitioners, clearly defining impact, as well as adequately assessing, and evaluating it, remains a challenge.

This course will guide you through a step-by-step process for an impact evaluation, providing you with viable options to measure impact, especially for complex interventions. You will learn different methods and how to choose the most suitable for your case.



What can you expect?

Online start Start at a similar level as the other participants by learning online prior to the face-to-face course

Week 1: Getting to know each other and sharing the challenges that you experience in conducting or commissioning impact evaluations. Familiarise with the online learning system, and explore evaluation criteria and the definition of impact. Introduction to qualitative methods.

Week 2: Deepen your knowledge of selected qualitative methods: theory-based methods and how to use the Theory of Change for Impact Evaluation; Outcome Mapping, Contribution Analysis, and Most Significant Change.

Week 3: Discover and familiarise with some basic concepts of quantitative methods.

Face-to-face During the face-to-face training, you will be taken through the entire evaluation process from initial ToR to the final report, and you will practice what you learnt in the online modules

Day 1: Understand the different types of evaluation. Review and work on the ToR of an evaluation assignment. Recap and deepen your understanding of the three qualitative methods studied online.

Day 2: Understand complexity and what methods are most appropriate in complex environments. Quantitative methods, and how to combine quantitative and qualitative methods.

Day 3: Inception process: reconstruction of intervention logic/theory of change, evaluation matrix and content of an inception report, Data collection during impact evaluation.

Day 4: Data analysis and contribution analysis. Validation of findings and participatory sensemaking. From findings to conclusions and recommendations.

Day 5: How to write an evaluation report: structure, writing tips. Presenting evaluation results and use.
