What data do we collect?

Dewar Cyber Consulting Ltd. collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide Dewar Cyber Consulting with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on via email.
- Use or view our website via your browser's cookies.
- Customer surveys and questionnaires

How will we use your data?

Dewar Cyber Consulting Ltd. collects your data so that we can:

- Work with you on any projects where we are providing services to you
- Process your order, payment details and manage your account.
- Email you with details of other projects ongoing which we think you might like.

When Dewar Cyber Consulting Ltd. processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Dewar Cyber Consulting Ltd. will keep your data for five years. Once this time period has expired, we will review your data and, if it is no longer required for project work or has expired, your data will be manually deleted.
