# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.austincanineacademy.com, and Austin Canine Academy and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Austin Canine Academy include www.austincanineacademy.com and ACA. The ACA website is a dog training site. By using the ACA website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, ACA may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Zip Code

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## **Use of your Personal Information**

## **Sharing Information with Third Parties**

ACA does not sell, rent or lease its customer lists to third parties.

## **Tracking User Behavior**

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by ACA. ### **Use of Cookies**

The ACA website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
