## APPLICATIONS OPEN FOR THE CANADA DENTAL BENEFIT



The Canada Dental Benefit is intended to help lower dental costs for eligible families earning less than \$90,000 per year. Parents and guardians can apply if the child receiving dental care is under 12 years old and does not have access to a private dental insurance plan.

Depending on your adjusted family net income, a tax-free payment of \$260, \$390, or \$650 is available for each eligible child. This interim dental benefit is only available for 2 periods. You can get a maximum of 2 payments for each eligible child. Benefit payments are administered by the Canada Revenue Agency (CRA).

The first benefit period is for children under 12 years old as of December 1, 2022 who receive dental care between October 1, 2022 and June 30, 2023.

# ONE-TIME \$500 PAYMENT FOR RENTAL SUPPORT NOW AVAILABLE

Every Canadian deserves a safe and affordable place to call home – but for many it is getting harder to afford increased rent or to even find housing they can afford.

That’s why our government took action to help nearly 2 million low-income renters who are struggling with the cost of rent.

Eligible Canadian renters will be able to access a \$500

top-up to the Canada Housing Benefit.
