Fund Description

SPFFX is designed to replicate the The Sphere 500 Fossil Free Index. The Index is a rules-based U.S. Large Cap Core equity index. It is comprised of the 500 largest listed equities on U.S. exchanges by market capitalization, excluding fossil fuel, utility, and other companies on an exclusionary list created by independent shareholder advocacy non-profit As You Sow. The remaining securities are re-weighted based on the adjusted market capitalization of surviving constituents and rebalanced quarterly.

Jason Britton is the President and Chief Investment Officer of Reflection Asset Management and lead portfolio manager for SPFFX. He is a Chartered Sustainable Financial Analyst (CSFA), holds a Masters of Business Administration from Yale University and previously served as Managing Director and Head of Impact Investing at Bank of America. 

Hypothetical growth of \$10,000


• SPFFX • SPDR S&P 500 ETF (SPY ETF)

Market Recap

Q1 of 2023 ushered in the first bank failures since the Great Recession of 2008. Silicon Valley Bank and Signature Bank of New York were both placed into receivership late in the quarter, causing significant volatility in the banking sector with slight spillage into the broader market. Inflation continued to be high though slowing its rate of increase, and the jobs market continued its healthy expansion. The Sphere 500 Climate Fund (SPFFX) finished the quarter up 8.14% for the period 12/31/22 - 03/31/23, versus SPY performance of 7.50%. This outperformance (0.64%) is attributable to the zero allocation to Energy Sector (-0.24% contribution to return for SPY) and to the over allocation to the Information Technology Sector (over allocation of 3.97% compared to SPY).

Why our screens

Our investment thesis is rooted in the philosophy that by avoiding or reducing exposure to certain historically volatile sectors and those sectors that are potentially exposed to regulatory over-hang, we believe that we can deliver market-like returns in the near-term, while potentially improving long-term risk and return characteristics.
