We endeavor to keep your information secure. We have internal systems dedicated to keeping your data safe and secure. We regularly review and invest in our security efforts to enhance the safety of your information.

Privacy Policy

Welcome to Gather Social Technologies Corp's Privacy Policy. Thank you for taking the time to read it.

We appreciate that you trust us with your information and we intend to maintain that trust. We start by describing to you the information we collect, why we collect it, how it is used and your choices regarding such information. This Policy describes our privacy practices in plain language and endeavors to keep the legal and technical jargon to a minimum.

17. How to contact us

Our Privacy Policy explains how Gather Social Technologies Corp collects, uses, and discloses information about you. The terms “Gather,” “we,” “us,” and “our” include Gather Social Technologies Corp and our affiliates. We use the terms “member” “you,” and “your” to mean any person using our services or attending events we organize. This Privacy Policy applies to the processing of information about members and other individuals that we collect when you use our “services,” which means any website, application, or services we offer, or when you communicate with us. For information about choices you may have under this policy, please see “Your Choices” below. This Privacy Policy does not apply to the information that you may provide to third parties, such as members, and others with whom you may share information about yourself.

For California Consumers please see our California Privacy Statement to learn about California privacy rights.

1. Who we are

Gather Social Technologies Corp is a United States based C Corporation, Registered in the State of Delaware.

2. Where this privacy policy applies

This Privacy Policy applies to Gather Social Technologies Corp apps, events and other services. For simplicity, we refer to all of these as our “services” in this Privacy Policy.

3. Information we collect upon sign up

Registration Information

To make our services available to you when you first sign up for a Gather Social Technologies Corp account, you first give us some basic information: Your name, email address, phone number, date of birth, gender and photos for your profile. If you decide to sign up for our services using your Facebook account, we will also get basic information from your Facebook profile like your name, gender, profile photo, and Facebook friends. We collect additional information when you use our services, for example access logs, as well as information from third parties, like when you access our services through a social media account.

When you add a credit card or payment method to your Gather Social Technologies Corp account, a third party will handle the payments for us and will receive your card information. To keep your financial data secure, we do not store full credit card information on our servers

Additional Information

We may ask you to provide your full name, address and email address. Such details may be shared with third parties for purposes relating to, for example, sending gifts related to our loyalty programs, delivery of merchandise and other bonus product offerings.

When you make a profile on our services or communicate with other members on our messaging system, please be cautious about including sensitive details. We do not recommend that you put email addresses, URLs, instant messaging details, phone numbers, full names or addresses, credit card details, national identity numbers, drivers' license details, health details and other sensitive information on your profile.

Please remember that the photographs you post on our services may reveal sensitive information about yourself. When you do choose to upload and to tell us sensitive information about yourself, you are explicitly consenting to our processing of your information and to our making your information public to other members.

When you post information about yourself or use our messaging system, the amount of personal information you share is at your own risk. If you post anything inconsistent with our Terms of Service, we reserve the right to terminate your Account.

For security and to avoid fake Gather Social Technologies Corp accounts being created, which could possibly be used for malicious activities and/or take away from the quality of the experience for all members' of our services, we may require you to verify your account and might ask for your phone number in doing so.

Geolocation Information

If you turn the location features of your mobile device on when you use your mobile device, we will collect information about your longitude and latitude, WiFi access points and may save your device's coordinates to offer certain features to you. This information helps us identify your physical location and we may use it to personalize the App and to make it easier for you to be matched into, and invited to participate in, upcoming events.

Push Notifications

Though you can opt out of receiving push notifications via your device settings, please note that opting out of receiving these notifications will significantly impact your ability to use the service.

4. Information you give us

We collect information that you choose to provide directly to us when you create an account and use our services. For example, we collect information that you provide when you create your account, fill out a form, or communicate with us. The information includes at least your login credentials, and some basic details necessary for our services to work, such as your gender, date of birth and profile photos. When you add information to your profile, you can share with us optional information such as details on your personality, lifestyle, interests and other details about yourself. When you add certain content, like pictures or videos, you may allow us to access your camera or photo album. Some of the information that you may choose to provide us might be considered “special” or “sensitive” in certain jurisdictions, for example your racial or ethnic origins, sexual orientation and religious beliefs. By choosing to provide this information, you consent to our processing of that information.

If you contact us directly, we may receive additional information about you. For example, when you contact our Customer Support, we will receive your name, phone number, email address, the contents of a message or attachments that you may send to us, along with any other information you choose to provide during the interactions. Sometimes, we monitor or record these interactions for training purposes and to ensure a high quality of service. We will keep records of our communications with you, including any complaints we receive from you about other members or from other members about you.

When you choose to participate in surveys or focus groups we will record and keep both your responses to our questions and the insights that you give us into our products and services. Similarly, if you choose to participate in our promotions, events or contests, we collect the information that you use to register or enter. Of course, we also process the chats you have with other members along with the content you publish, as part of the operation of our services. If you have at any time given us your email address and phone number to send you information on special offers, you can always withdraw your consent at any time via Settings in the app.

5. Information we receive from others

In addition to information that you directly provide to us, we receive information from others about you, including:

Our other members

Other members may provide information to us about you when using our services. For instance, we may collect information about you from other members if they use our reporting function to message us about a concern they have.

Social Media

You may be able to use your social media login (such as Facebook Login) to create and log into your Gather Social Technologies Corp account. This can save you from having to remember yet another set of login details and can enable you to easily share some information from your social media account with us.

We may receive information about you from our current or future corporate partners, parents, subsidiaries, or affiliates.

6. Information we automatically collect when you use our services

When you use our services, we collect information about which features you've used, how you interact with the features and on which devices you access our services.

Device and usage information

We may collect information about the computer or mobile device that you use to access our Services including the hardware model, operating system and version, unique device identifiers, and mobile network information, web browser type; services pages viewed; your IP address; and the page you visited before visiting our services, the time, duration, and frequency of your access, version and language, application installations, app crashes, app settings and characteristics, service provider and signal strength, time zones, phone carrier and manufacturer, mobile advertising identifiers, push notification tokens, and, if you register with your Facebook account, your Facebook identifier, how you interact with other members (e.g., the time and date of your exchange and the number of messages you send and receive).

Geolocation Information

When you access our services, depending on your device settings, we may collect information about your location, which we may use to notify you of upcoming special events in your area, and to improve our services. While you can prevent your device from sharing location information at any time, through your device's operating system settings, doing so may mean we are not able to provide all our services to you.

Other information

Based on your consent, we may collect other information from your device, such as photos and videos from your camera or calendar information that you want to manage within our services.

7. How we use information

We primarily use your information to deliver you enjoyable and useful services and we use it to continuously improve our offerings to you. Additionally, we use collected information to satisfy various business and compliance requirements and to help keep you safe. See details and examples provided below:

To administer your account and provide our services to you

We use your information to create and manage your account, complete your transactions, respond to your customer service requests, conduct order management and billing and to communicate with you about our services.

To facilitate you in connecting with other members

We show profiles of members' to one another and to display information about you, for instance, your self description and your answers to matching questions. We analyze both your and other member's profile and activity in the service of matching you and inviting you to both participate in social events and subsequently, to use our messaging system to help make connections with other members who use our services.

To enable a consistent experience across devices

We may link the various devices you use in order that you may enjoy a consistent experience on all of them. In so doing we may make inferences based on network and device identifiers including but not limited to IP addresses and browser metadata and associate that information with your account.

To provide new services to you and develop new features

We may monitor and analyze trends, usage, and activities in connection with our services, administer focus groups and surveys, conduct research and analysis about how members' interact with our App in order to improve our services and content (for example, change the look and feel or even substantially modify a given feature.) We may register your profile on new Gather Social Technologies Corp apps and features and when they are released we administer your account on these new apps and features.

To serve you relevant ads and promotions

From time to time we may contact you by email, text message, phone or social media with information about our services, new updates and offerings and with marketing information about new products or services we think you may be interested in and to administer, contests, sweepstakes, discounts or other offers or promotions .

To detect illegal or unauthorized activities

We may use data we have to detect, investigate and prevent fraud, abuse, and other illegal activities and we may retain data related to fraudulent activities in order to help prevent recurrences.

To ensure legal compliance

We may use data that includes information from or about you to comply with legal requirements, to perform accounting and administrative tasks, to assist law enforcement, to protect, enforce or exercise the rights, property, or safety of Gather Social Technologies Corp and others, to enforce, for example, our Terms of Service and enforce or manage legal claims.

8. Legal basis for processing

Our legal basis for collecting and using the information described above will depend on the type of information and the specific context in which we collect it.

Providing our services to you

We process information about you in order to provide our services in accordance with our Terms of Service, for example, to allow you to be matched into groups and then invited to attend events in your defined area; to display your profile to other members; to allow us to send you important service updates; and to perform a contract.

Legitimate interests

We also process information about you where it is in our legitimate interests to do so and not overridden by your rights (for example, in some cases for direct marketing, fraud detection and prevention, network and information systems security, responding to your communications, the operation of our event creation and invitation system, by the network administrators, and in improving our services). In some instances we may have a legal obligation to process your information, or may otherwise need your information to protect your vital interests or those of another person. For example, we may process information, if we believe doing so is required by, or in accordance with, applicable law, legal process, regulation, or audits.

Consent

From time to time, we may ask for your consent to use your information for one or more specific reasons. You may withdraw your consent at any time by contacting us info@getgather.app.

9. How we share information

Since our goal is to help you connect with others in your chosen area, the main sharing of members' information is, of course, with other members. During a limited period of time before, during and after any event that you participate in, your profile information will be available to our event hosts. We also share some members' information with service providers and with partners who assist us in operating the services and, in some cases, with legal authorities. See details below:

With other members

When using the Service you voluntarily submit and disclose content. You should assume that content you post or submit on the App may be publicly-viewable and accessible, both by members and non-members of the App. We want you to be careful about posting information that will eventually be made public. If you choose to limit the audience for all or part of your profile, or for certain content or information about you, then it will be visible according to your settings.

With our partners and service providers

We use third party providers in connection with operating and improving our Services to assist with certain business purposes, such as payment processing, data hosting, maintenance, marketing, advertising, security operations, email

transmission, conducting surveys or contests and some aspects of our technical and customer support. These third party service providers, which include data analytics providers, may access, process, and store information about you on our behalf for the purposes we authorize, subject to confidentiality obligations. We may also share limited information about you in hashed, non-human readable form to advertising partners. Prior to engaging any service provider or working with any partner, we follow a comprehensive vetting process. Our service providers and partners must agree to strict confidentiality obligations.

In corporate transactions

Gather Social Technologies Corp may transfer your information if we are involved, whether in whole or in part, in a merger, sale, acquisition, restructuring, divestiture, reorganization, dissolution, bankruptcy or other change of ownership or control. We may also share your information with current or future corporate parents, subsidiaries, or affiliates.

When required by law

We may preserve, access or disclose information about you to government entities and/or other third parties, including the content of messages, if we believe disclosure is in accordance with, or required by, applicable law, court order, subpoena, search warrant, regulation, legal process, or audits. We may also disclose information about you if we believe that your actions are inconsistent with our Terms of Service or related guidelines and policies, or if necessary to protect the rights, property, or safety of, or to assist in the prevention or detection of crime, fraud or abuse of, Gather Social Technologies Corp or others.

To enforce legal rights

We may share information if such disclosure may mitigate our liability in an actual or threatened lawsuit or is deemed necessary to protect our legal rights and/or the legal rights of our members, business partners or other interested parties or if required to enforce our agreements with you; and/or to investigate, prevent, or take other action regarding, suspected fraud, illegal activity or other wrongdoing.

With your consent or at your request

We may also want to share information in a manner that does not personally identify you, such as aggregated or de-identified information. Such information is not subject to this Privacy Policy. We may also share information about you with your consent or at your direction or where we are legally entitled to do so. Your information also is made available to other group members and event hosts when you agree to attend or participate in an event.

10. Cross-border data transfers

By using the App, you acknowledge that Gather Social Technologies Corp is a global service, operating through servers that may be located in countries around the world, including the United States. These countries may not have data protection laws that are as protective as the laws in your country of residence. We have taken appropriate safeguards, such as standard contractual clauses, to require that your information will remain protected in accordance with this Privacy Policy.

11. Your rights

These are some options available to you to control your information:

You can access your account settings from the main menu of the app to directly rectify or remove from public view most information that you provided to us and that's associated with your account. Some information submitted by you cannot be changed or removed directly by you but may be removed by us at your request. If you would like to request that information about you or submitted to us by you be deleted please contact us at info@getgather.app with your account details. Mobile devices and service providers have permission systems for specific types of device data and notifications, such as location services, phone book, and push notifications. You can make changes to your settings on your device to either refuse or agree to the collection of particular types of information or to display notifications that relate to such information. If you deny certain device permissions the services we provide will lose partial or all functionality. You also have the option to have your account deleted by sending an email requesting that we do so to info@getgather.app

Warning:

Even after removing information from your profile or deleting your Account, copies of that information may still be viewable or accessible to the extent that the information has been previously shared with others, or copied or stored by others, or to the extent such information has been shared with search engines. We cannot control this, nor do we accept any liability for this.

Some key points to be aware of concerning your privacy rights:

Applicable privacy laws, sometimes called right of portability or right of access, may give you the right to review the personal information we keep about you. If you believe that the information we hold about you is inaccurate or that we are no longer entitled to use it and want to request its rectification, deletion or object to its processing, or you wish to request a copy of your personal information please contact us at info@getgather.app.

Please note that for your own protection and for the protection of all our members, we may ask you to provide proof of identity before we answer any of the above requests. Also, please note we may reject requests to provide information on certain basis, including if the request is unlawful or if it may infringe on trade secrets, intellectual property or the privacy rights of another member.

If the information you wish to request relates to another member, such as the content of a message you received from them through our service, the other member will have to contact our Privacy Officer to provide written consent before such information is released.

Should you want to stop all information collection by the app by uninstalling it you can do so using the standard uninstall process for your device. If you uninstall the app from your mobile device, the unique identifier associated with your device will continue to be stored. Should you decide to reinstall the app on the same mobile device, we will then re-associate this identifier with your previous transactions and activities. When we have no ongoing legitimate business need to process your information, we will either delete it or take steps to de-identify or anonymize it in accordance with applicable law.

In certain countries and in the European Union, you have a right to register a complaint with the appropriate data protection authority if you have concerns about how we process your personal information. The data protection

authority you can register a complaint with may be where your habitual residence is, where you work, or where we are based.

12. California privacy rights

If you are a resident of California, you can request a notice disclosing the categories of personal information about you that we have shared about you with third parties, during the preceding calendar year, for their direct marketing purposes. For purposes of California law, we do not consider the ways we share your information as a “sale.” California residents do have certain rights to access and delete their personal information and to request transparency about our privacy practices. To request this notice, please contact info@getgather.app with your account details. Once we receive your request, we may verify it by requesting information sufficient to confirm your identity, including by asking you for additional information before we can answer such a request. Please allow 30 days for a response. For your protection and the protection of all of our members, we may ask you to provide proof of identity.

13. Security of your information

We regularly monitor our systems for attacks and vulnerabilities and we regularly review our information collection, storage and processing practices to update our security measures. We work diligently to guard against unauthorized access to or alteration, disclosure or destruction of your personal information. Yet, as with other technology companies, although we work to secure your information, you should not expect and we do not promise that your personal information will always remain secure. We may suspend your use of our services without notice if we detect or even suspect any breach of security. Where you have a password or other access credential, which enables you to use our services, you are responsible for keeping this complex, secure, and confidential.

14. Retention of data

We retain your personal information only as long as it is needed for legitimate business purposes and as permitted by applicable law. In practice, we delete or anonymise your information upon the deletion of your account (following the safety retention window), unless: We have an obligation to keep information to comply with applicable law (for example, some “traffic data” is kept for 12 months to comply with statutory data retention obligations); we must keep it to evidence our being in compliance with applicable law (for instance, records of consents to our Terms of Service, Privacy Policy and other similar consents are kept for five years); because there is an outstanding dispute, issue or claim or dispute requiring us to keep relevant information until it is resolved; or the information need be kept for our legitimate business interests, such as fraud prevention and enhancing members' safety and security. For example, information may be kept to prevent any members banned for security reasons, breaching our Terms of Service or unsafe behavior from opening a new account. Please be aware that even though our systems are designed to carry out data deletion processes in accordance with the above guidelines we cannot promise, due to technical limitations, that all data will be deleted within a specific time frame.

15. Children's privacy

Our services are restricted to members aged 18 years or older and we don't knowingly collect personal information from anyone under the age of 18 or permit them to use our Services. If you believe that someone under the age of 18 has given us personal information, please report them by using the reporting function on the profile or by contacting us at info@getgather.app

Children's Online Privacy Protection Act Compliance

We are in compliance with the requirements of COPPA (Children's Online Privacy Protection Act) as we do not collect any information from anyone under 13 years of age. Our website, products and services are all directed to people who are at least 18 years old or older.

16. Revisions to our privacy policy

As Gather Social Technologies Corp evolves, we may publish revisions to this Privacy Policy from time to time. The most recent version of the policy will govern our use of your information and can be accessed at www.getgather.app. If we make a change to this policy that, in our sole discretion, is material, we will notify you, for example, by giving notice on the Gather Social Technologies Corp App, or via the email address associated with your Account. As long as you use the Gather Social Technologies Corp App, you are agreeing to this Privacy Policy and any updates we make to it.
