Our government has FINALLY recognized how detrimental isolation is for you. The Centers for Medicare and Medicaid Services, in addition to the Indiana State Department of Health, are <u>instructing your home to now offer indoor visits as well as outdoor visits.</u> Of course, there are certain rules to be followed.

Visitation Guidelines for Nursing Homes and Licensed Assisted Living Homes in Indiana

Core principles should be followed in ALL visitations

- 1. Screening for signs and symptoms of COVID-19
- 2. Hand hygiene (use of alcohol-based hand rub is preferred)
- 3. Face covering or mask (covering mouth and nose)
- 4. Social distancing of at least six (6) feet as much as possible

Outdoor Visitation

- 1. Facilities should create accessible and safe spaces for outdoor visitation.
- 2. Outdoor visits are preferred over indoor visits.
- 3. Outdoor visits should continue **EXCEPT** when:
 - a. There is bad weather,
 - b. Resident is COVID positive, or
 - c. Resident is in quarantine.
- 4. Facility COVID-19 outbreak is NOT a reason to postpone outdoor visitation.
- 5. When possible, visits should be for one or two hours with up to two visitors per resident.

Indoor Visitation

- 1. A facility must allow indoor visits.
- 2. A facility must create a policy for:
 - a. Normal visitation hours,
 - b. Length of visits,
 - c. The number of visitors per resident, and
 - d. The number of visitors at any one time.
- 3. If any visitors are not available during normal visitation hours, facilities should work with residents so visitations are available based on resident preference.
- 4. When possible, visits should be for one or two hours with up to two visitors per resident.
- 5. Facilities should allow indoor visitation at all times and for all residents (regardless of vaccination status), EXCEPT when:
 - a. COVID-19 county positivity rate is more than 10% and
 - b. Less than 70% of residents in the facility are fully vaccinated and
 - c. The resident is unvaccinated or
 - d. Residents have a confirmed COVID-19 infection, until they have met the criteria for release from quarantine **or**
 - e. Residents are in quarantine, whether vaccinated or unvaccinated, until they have met criteria for release from quarantine.

Privacy

- 1. Long-term care facilities should allow visits to be conducted with sufficient privacy.
- 2. Facilities are not required to continuously watch each visitor and visitation. However, if a facility has reason to believe that a visitor may not follow the core principles of infection control (see "core principles on page 2), then the facility may choose to frequently or continuously, supervise the visitor and visitation.

Visitors

- 1. Visitors that do not follow the core principles should be asked to leave the facility.
- 2. Visitors should go <u>directly</u> to the designated visitation area.
- While visits in designated visitation areas are still encouraged, in-room visits may occur in facilities for any reason while following the core principles of COVID-19 infection prevention.
- 4. Visits for residents who share a room should not be conducted in the resident's room, unless the roommate remains out of the room during the visit.

Physical Touch:

If the resident is fully vaccinated, they can choose to have close contact (including touch) with their visitor while wearing a well-fitting face mask and performing hand-hygiene before and after. Visitors should physically distance from other residents and staff in the facility.

When there is a new case of COVID-19 among residents or staff, a facility should immediately suspend all indoor visitation, except in a few special circumstances such as Compassionate Care visits.

Compassionate Care Visitation

Visitation should be allowed in compassionate care circumstances regardless of the resident's vaccination status. Such circumstances include but are not limited to:

- End-of-life situations
- 2. A resident's relative or other loved one is an essential caregiver for the resident
- 3. A resident who is grieving
- 4. A resident, who is experiencing emotional distress

What You Need to Know About Your Stimulus Check!

- 1. The Internal Revenue Service (IRS) has already, or will be sending a third stimulus payment for you.
- 2. You should receive your stimulus payments (up to \$1,400) in the same way you receive your social security benefits—such as by direct deposit, check or pre-paid debit card.
- 3. However, if you have more than \$75,000 in adjusted gross income as an individual, or more than \$150,000 in adjusted gross income as a married couple, your stimulus check will be reduced.
- 4. If you do receive stimulus money, it belongs to YOU! The facility CANNOT take it. YOU have the right to spend it how YOU choose.
- 5. If you are on Medicaid, this money is not to be counted as a resource for 12 months from the day you received it. Any of your stimulus money remaining after 12 months will count as an asset. If you have more than \$2,000 in assets, you exceed the allowable limit and will get kicked off Medicaid.
