#### **Introduction of Guests/Public Comment**

- o PJ Foehr discussed his role as School Lead, a new role created by the Charter Commission. He will be acting as an authorizer, supporter, and advocate. He will attend GSB meetings and provide feedback, as well as assist in finding resources if needed.
- o Rae Villanueva shared that one of Wai'alae's robotics teams qualified for the world championships held in Kentucky. The robotics team will be competing with four teams.

#### Review and Acceptance of Minutes of July 2019 meeting

o The Board will vote to approve the July 2019 Meeting Minutes electronically by Friday 8/30/2019 to allow more time for review.

#### **ANNOUNCEMENTS**

- o The New Family Picnic scheduled for Friday, 9/6 from 5-7pm. Friends of Wai'alae School and the Wai'alae School Foundation have agreed to donate ice cream for the event.
- o Representatives from Wai'alae school board will be there to welcome new families and communicate the mission and vision. Representatives from Wai'alae School Foundation and Friends of Wai'alae School will also be present at the event.

#### **OPENING ACTIVITY**

- o Lianna shared a video of the Friday assembly and asked everyone to stand together to sing Oli Aloha.
- o Wai'alae's new counselor opened the Friday assembly.

#### SCHOOL REPORT

#### o **CEO REPORT**

#### o Aligning Wai'alae's budget and goals with the SIP (School Implementation Plan)

- o John discussed what he added to the SIP regarding ITU (Integrated Thematic Units). There is now a 3-year plan on how to make ITUs more inclusive of standards and teachers working in their cardres to identify PD (Professional Develop needs).
- o John added more information regarding the Value Added Measure, which is under Student Led Conferences. Included now are the five vision elements in student-friendly language rubric continuum. Students will eventually be able to use this as a tool for self-assessment. The Charter School contract requires this measure.
  - o How to best pilot the continuum is in the process of being determined. There will be no school wide changes to goal setting and goal sharing at this time.
- o John shared that to assist with closing achievement gaps he will implement two programs. The two programs are the assessment and instruction software, i-Ready and teachers using the learning cycle and formative assessment to drive student-centered instruction.
  - o Juna and Rae commented on their experience with and the benefits of Learning Cycles and using ILOs (Institutional Learning Outcomes).

#### Implementing SEL (Social Emotional Learning) and PBIS (Positive Behavioral Interventions & Support)

- o PBIS implementation began last year and is ready to be implemented fully this year.
- o A counselor was hired, partially to assist with the implementation PBIS.
- o A cadre, led by Assistant Head of School Jodie Cheff, will continue reviewing SEL programs and intend to select a program this school year.
- o Waialae is currently looking at free SEL curriculum options with local connections. These programs are: Choose Love, the DOE version of Aloha SEL (which aligns with the HĀ framework), and Pillars of Peace.

# o Transitioning from ELL (English Language Learners) to MLL (Multi-Language Learners); SPED and MLL inclusion

- o MLL is the new term adopted by the DOE
- o A second MLLteacher has been hired to improve MLL services to students.
- o There will be two teachers working with ELL/MLL students by January of 2020.
- o DOE District had determined that one SPED position was to be removed, however Wai'alae has decided to include that position in the budget and keep the SPED service level consistent with last year.
- o Inclusion teams requested more time to collaborate, which will be provided via faculty meetings and the 24 hours of contractually required PD (professional development). Individuals from the University of Hawaii will be coming in to assist with training on MLL.
- o SPED inclusion is currently in two of the four grade level classes and MLL inclusion is in the other two (per grade level).
- o The school has also allocated more space for SPED and MLL needs in SY 2019-20

#### o Construction projects

- o Bids are currently being accepted for the preschool deck, 9/15/19 is the decision deadline.
- o John has been consulting with an electrical engineer to install air conditioning. The DOE now allows for window units.

#### - Review of School Finances

- Lianna reported (for Leila who was absent) that Operations Committee reviewed the school's financial status at their Operations Committee meeting on 8/20/19, and numbers look good. The committee also has plans to revisit the board's monthly financial review process and will work with John on how to report school finances during full board meetings, and how board members can better review finances as well.

- o The 5-15 worksheet will be used by committee chairs to share updates during board meetings. The format is that it should take 5 minutes to read the worksheet and 15 minutes for committee chairs to share the worksheet with the board.

- o Adjustments will be made to the worksheets over the coming months in response to questions and comments.
- o Liana shared the GSB Annual Calendar. There will be joint events with Community Circle (Governing School Board, Friends of Wai'alae School and Wai'alae School Foundations) in October, January, and April. Joint events will allow Community Circle's monthly meetings to be held simultaneously in a shared space with time allowed for collaboration.

o Tom shared that there will be trainings held on Oahu on September 14<sup>th</sup> and 19<sup>th</sup>, on Kauai on the 18<sup>th</sup>, Kona on the 17<sup>th</sup>, and Hilo on the 16<sup>th</sup>. A partnership between the Hawaii State Charter School Commission and the National Charter Schools Institute sponsored these events.
